(8) STAFF COMMUNICATIONS

City Council Chair Brechnitz welcomed new members, showed his appreciation and commended members for their volunteering efforts.

a. Landscape Maintenance Update - Al Benarroch, Affordable Landscaping

Mr. Benarroch reported white fly issue on Gumbo Limbo trees on island (better process to innoculate is to inject trees). Irrigation working, finished spraying Bougainvilleas for bugs, some Cabbage Palms turning brown, (are not dead, need to flush out). Director Pinter stated plantings did not survive on every median. Goodland Bridge sign plantings are completed, watering truck daily. Palms trimmed, and need to clean up medians. Cleaned cul-de-sacs.

Member Colombo left the meeting at 3:16 .m., returned at 3:18 p.m.

Member Tobin - Replanted medians look great, near Publix on Barfield and San Marco Road (median #4), needs tending. Director Pinter - Not much budget left for more landscaping, only replacing dying and dead materials.

Cindy Shuman, resident at Duchess, 220 South Collier Blvd, medians in front of building not in good shape, some plantings were done, half of bushes and grass is dead. Director Pinter will direct staff inspector and Mr. Benarroch will review location.

b. Staff Report - Tim Pinter

Director Pinter reported:

County had Fertilizer Ordinance Workshop presentation, (viewed on County TV Channel), both sides spoke openly with different ideas with no final decisions. It will be up to Marco Island, Naples and Everglades City to come up with a more restrictive ordinance or County ordinance. Marco Island's ordinance is most restrictive in County and probably in SW Florida. Discussion on black out season to be in fall, or in dry season or to fertilize in wet season.

Joint bike path project (with Federal Grant) later this summer, two shared use paths from Collier Boulevard, Rose Court from Jolley Bridge (6'-8' sidewalks on both sides) to Caxambas Court Circle.

Design will relocate 96 palm trees, (Affordable Landscaping will hold), and relocate trees in more uniformed design. If trees diseased, will replace.

Second shared use path plan on San Marco Road from Barfield to High School. (first phase) Landscaping on north side of San Marco is wide, not planting much. Following year will start on High School to Goodland Road.

Member Tobin requested \$1,200 budget approval for expenses: Advertising, signs, photo copies and video ad.

Member Tobin proposed home owners participate in award at entrance of Jolley Bridge (as first impression) to appreciate homeowners efforts, and motivate owners by rewarding them. Can also qualify under for "Residential" category.

Changes from last month had Motion that failed to change criteria on nomination form. Need to see landscaping from front yard only, not back yard or unable to get in to site due to security.

Director Pinter commented it was too late to add another category just for Jolley Bridge residents. Three large residents homes are gated, have shrubs, and unable to view front yard. Will postpone discussion to next year.
