## SECTION E CERTIFICATION

Community officials who are authorized by local law or ordinance to provide floodplain management information, may also sign the certification. In the case of Zones A1 and A (without a FEMA or community issued BFE), a building official, a property owner, or an owner's representative may also sign the certification.



Elevations for all V Zones should be measured at the bottom of the lowest horizontal structural member.
