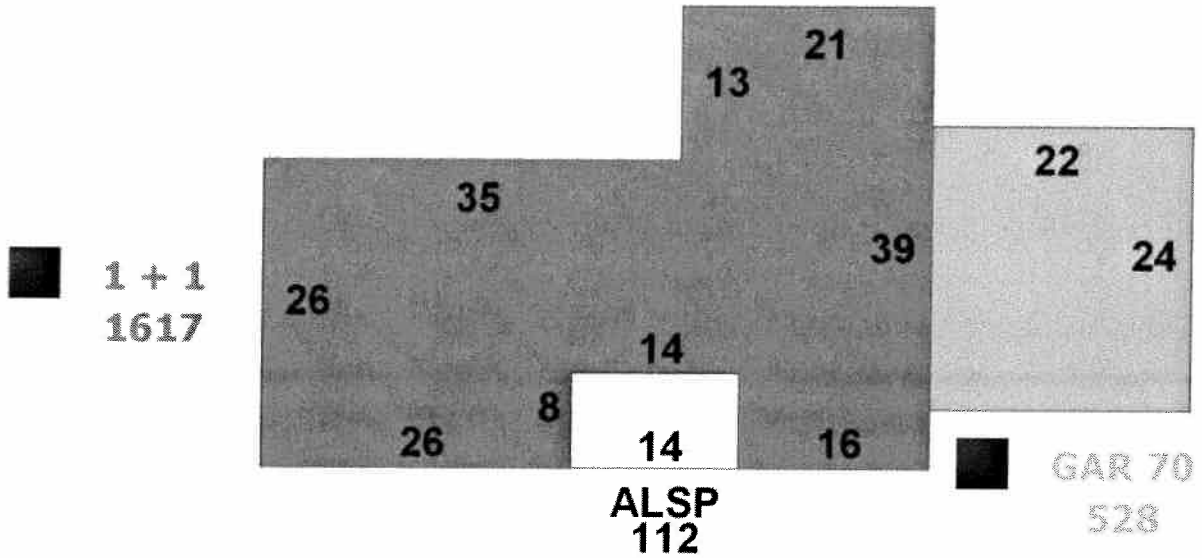
Front View
