SECTION E CERTIFICATION

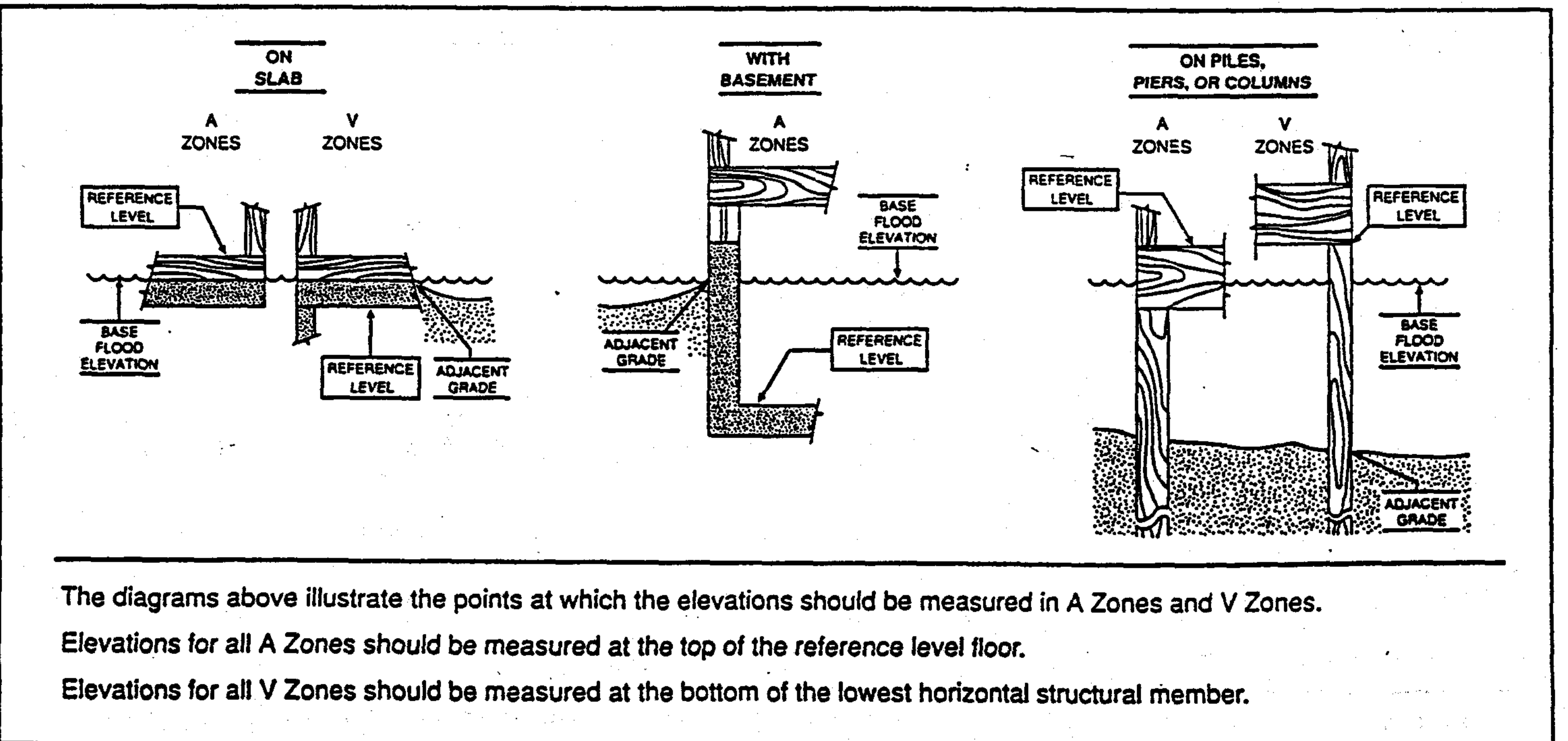
