## SECTION E CERTIFICATION

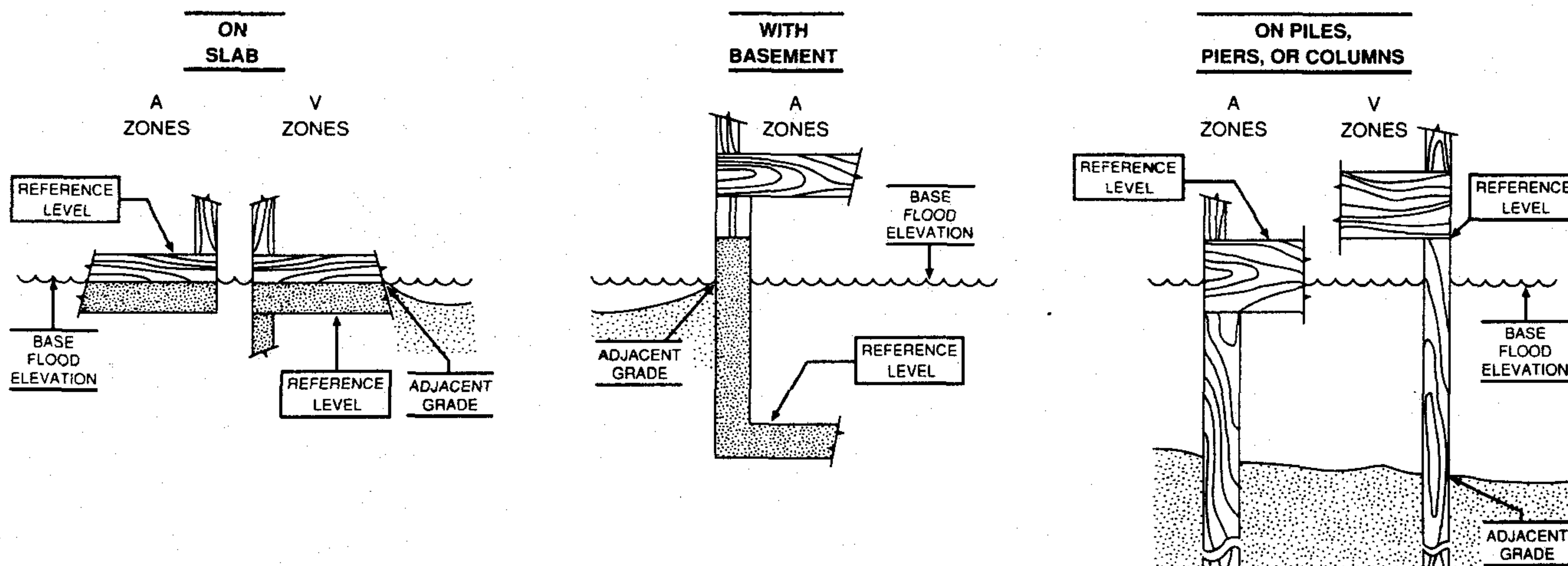
