C2e is the pad for the smaller A/C unit (E. side). There is a larger A/C unit on the same side at elevation 4.5', NAVD88. The restroom thresholds are at elevation 4.2' and the laundry room threshold is 4.4'. Local jurisdictions may have elevation requirements more restrictive than the base flood elevation shown hereon, consult with the applicable building department regarding any design decisions. According to the Collier County Property Appraiser structure was built in 1967.
