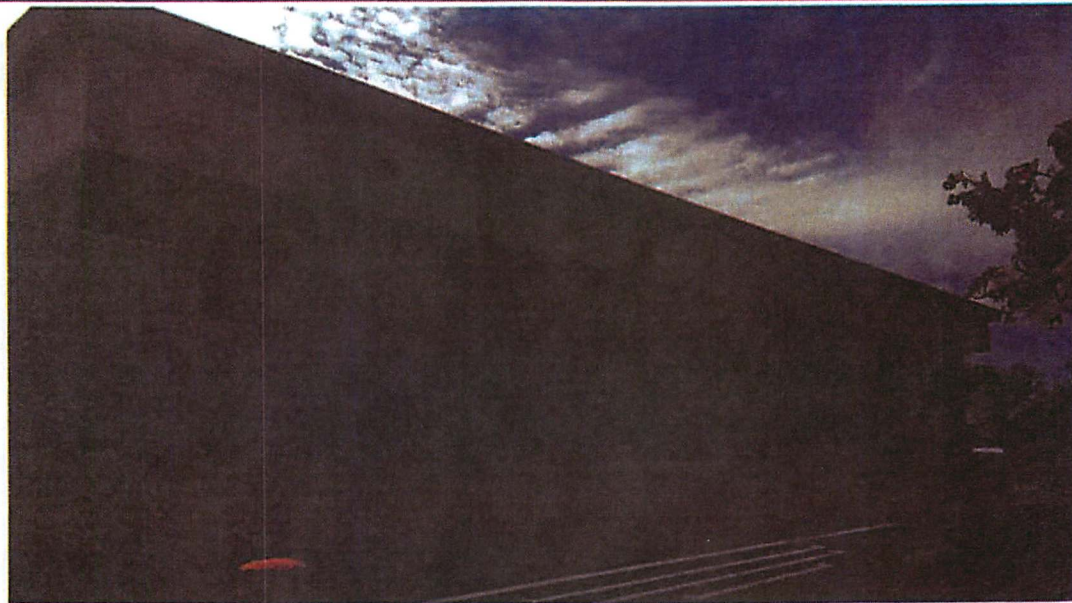

**FLOODPROOFING CERTIFICATE
