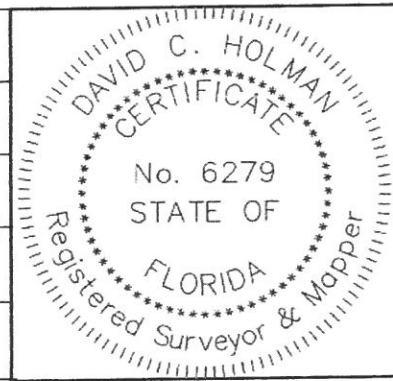

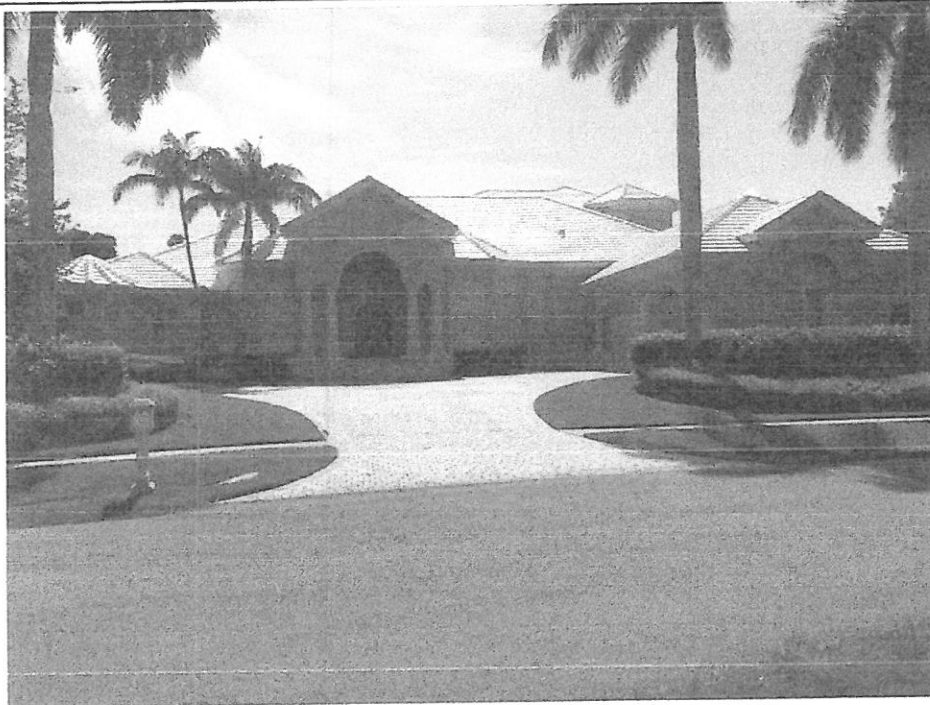

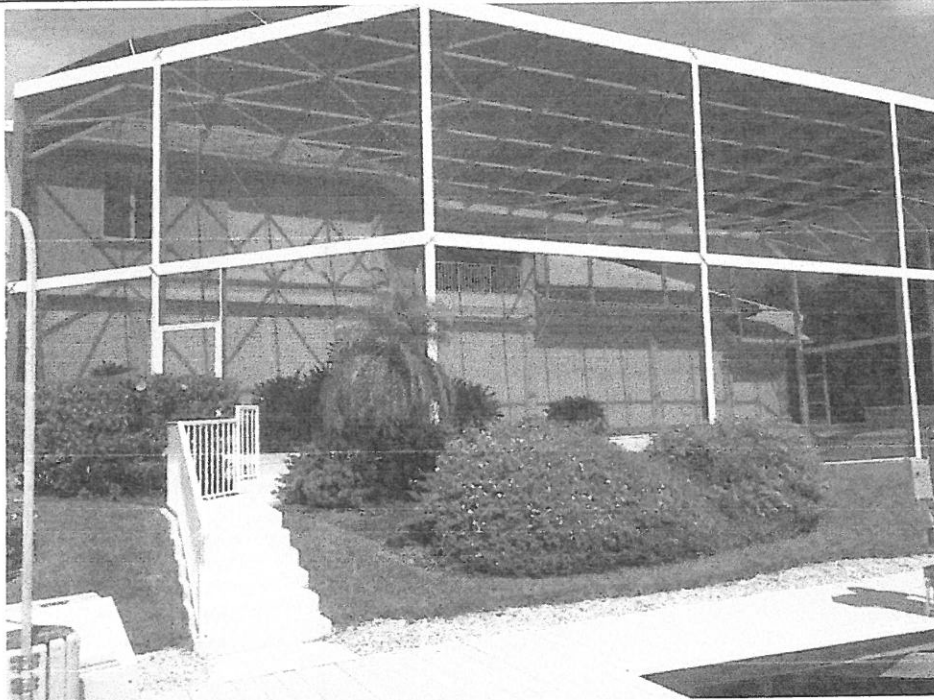

Photo Three Caption REAR VIEW 10/17/2019

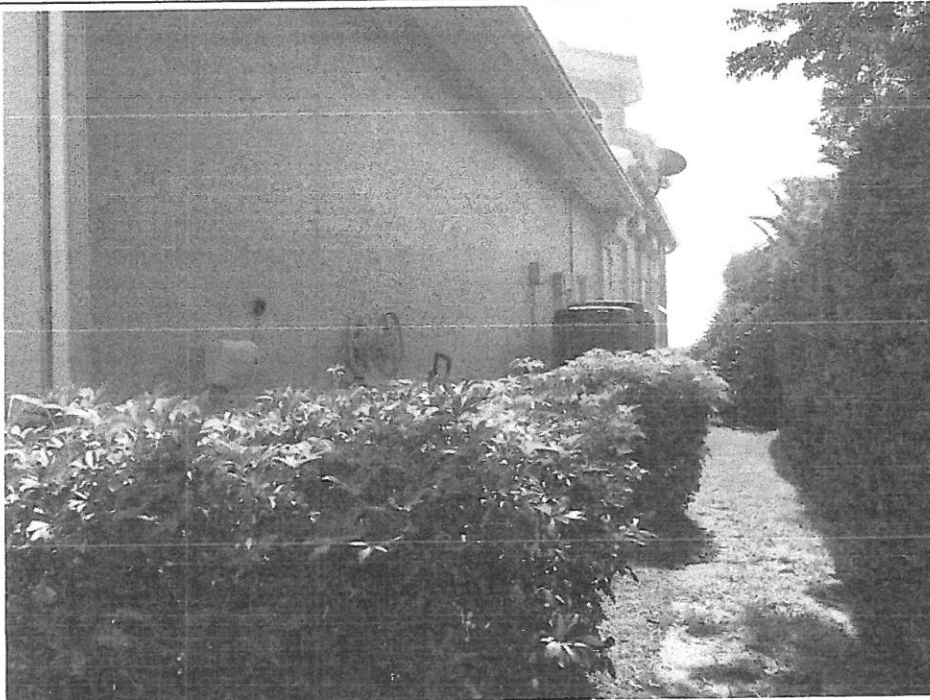

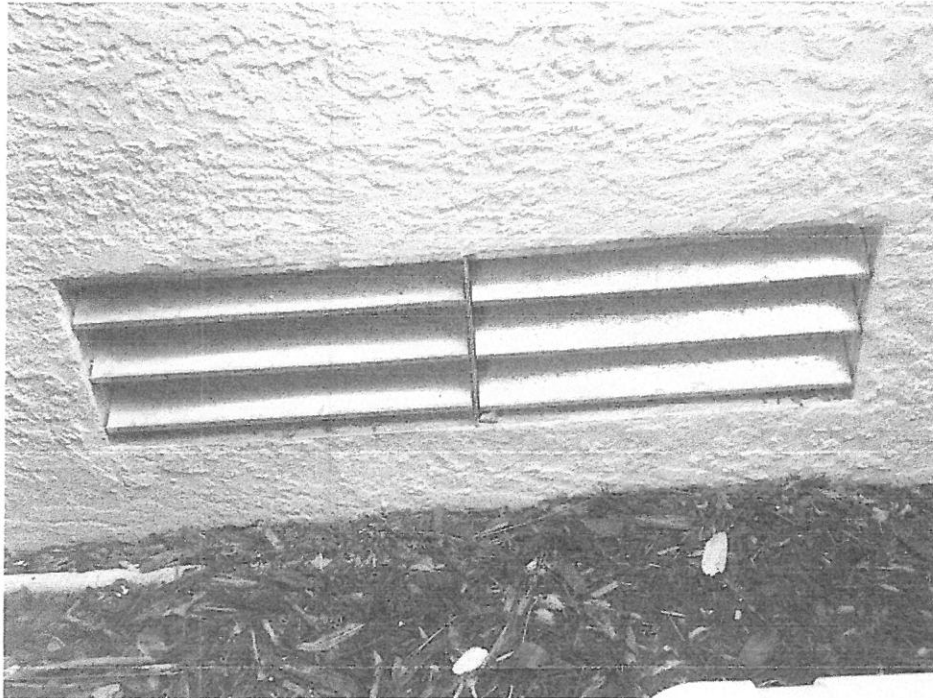
