

A8a Square footage derived from the construction plans. There are 4 vents in the 557ft² left garage, 4 in the 664ft² right garage and 8 in the 1,525ft² storage area, SmartVent Model #1540-520 certified to cover 200 ft² each for a total net flood coverage of 3,200 ft² for the enclosure. C2a is the garage portion of the enclosure, C2b is the storage portion. The foyer/entry level is at 11.1'. The first living floor is at elevation 15.2' and the 2nd living floor is 28.8'. C2e is the elevation for both A/C pad's. An elevator on the ground floor was inaccessible but appeared to be at the same elevation as the storage area. Local jurisdictions may have elevation requirements more restrictive than the base flood elevation shown hereon, consult applicable building department regarding any design decisions.
