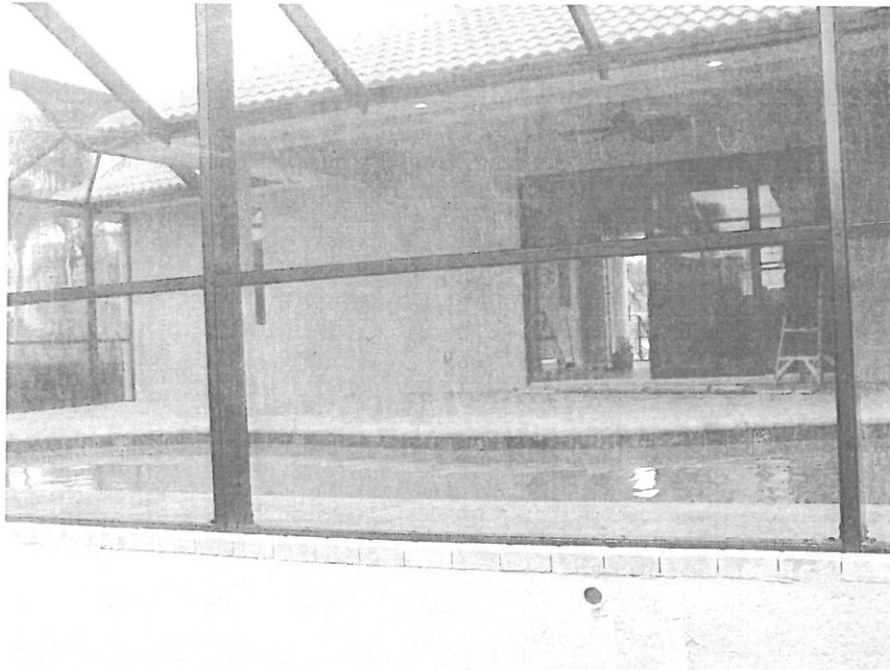

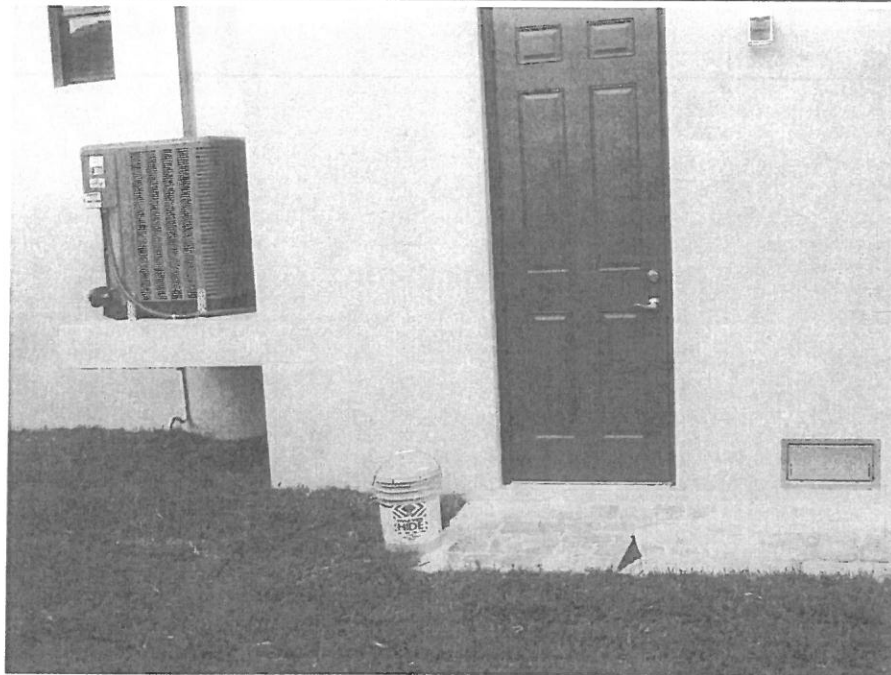

Photo Three Caption : A/C & Vent View, 10/21/2016

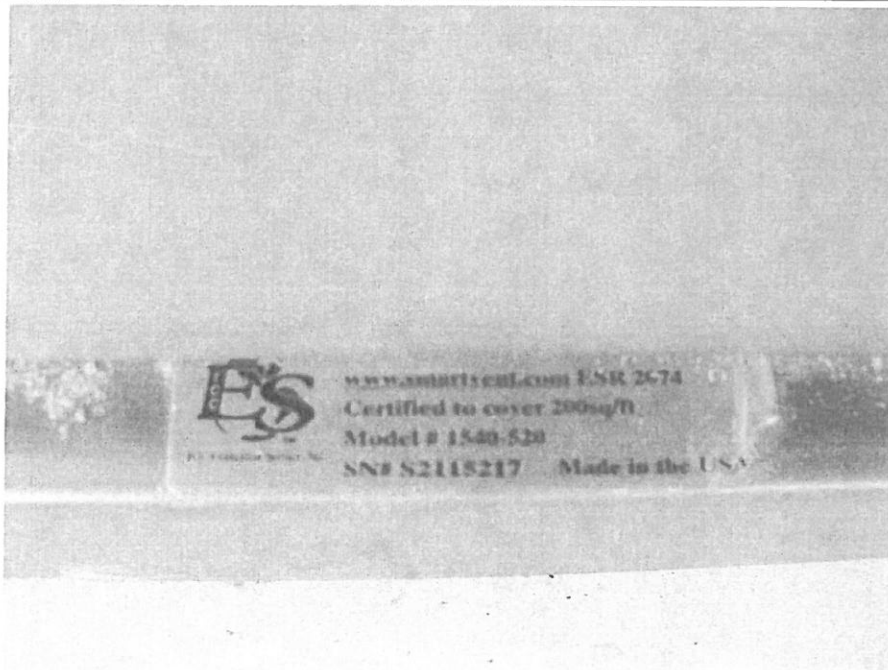
