



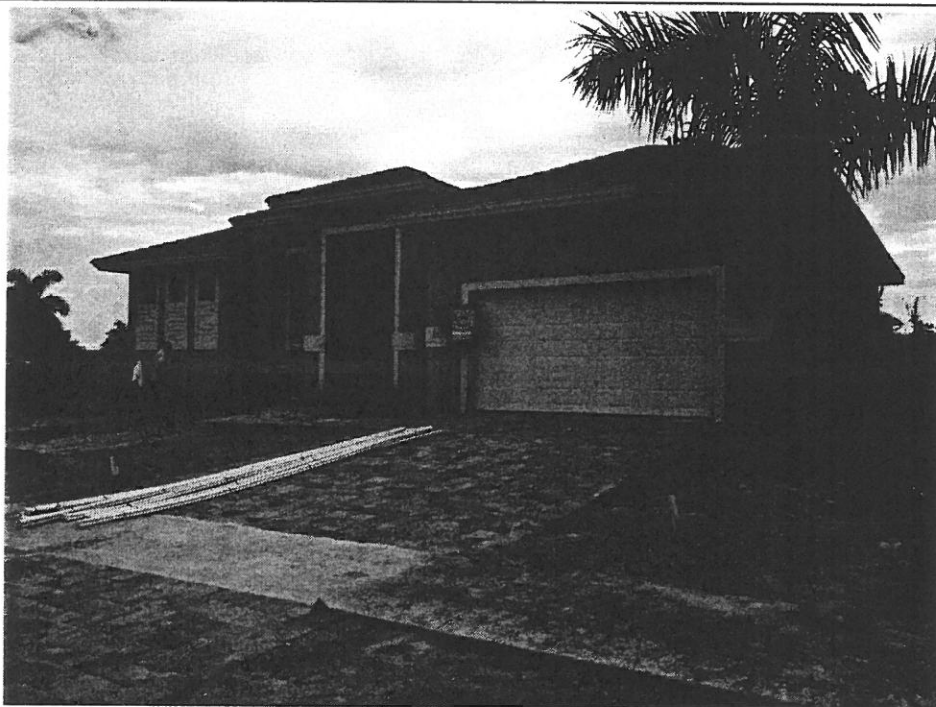

Photo One Caption FRONT VIEW 7/19/2017

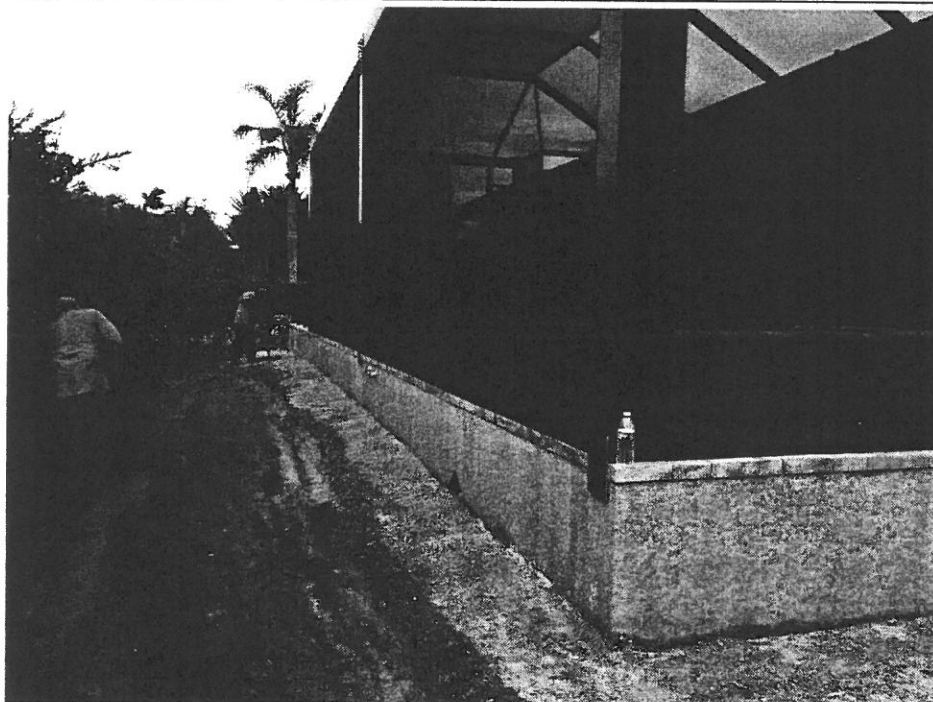

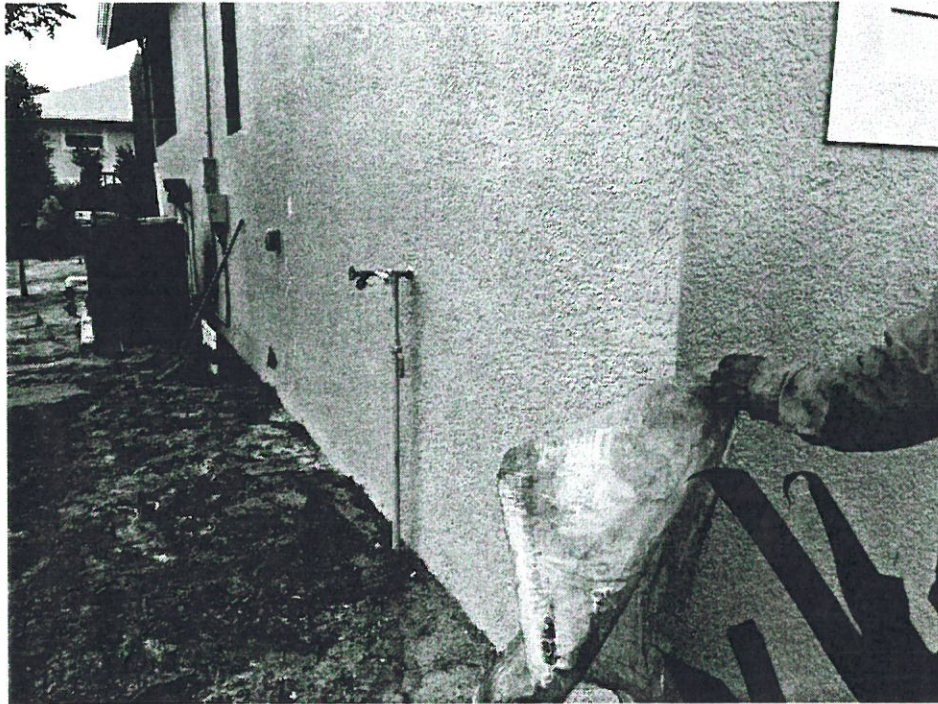

Photo Three Caption LEFT SIDE VIEW 7/19/2017

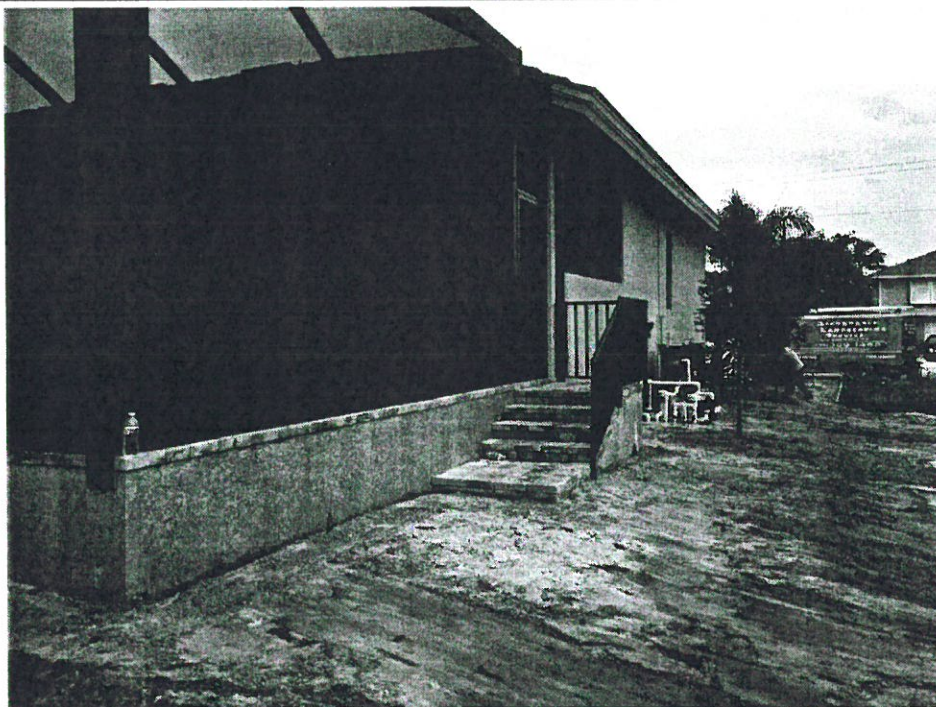

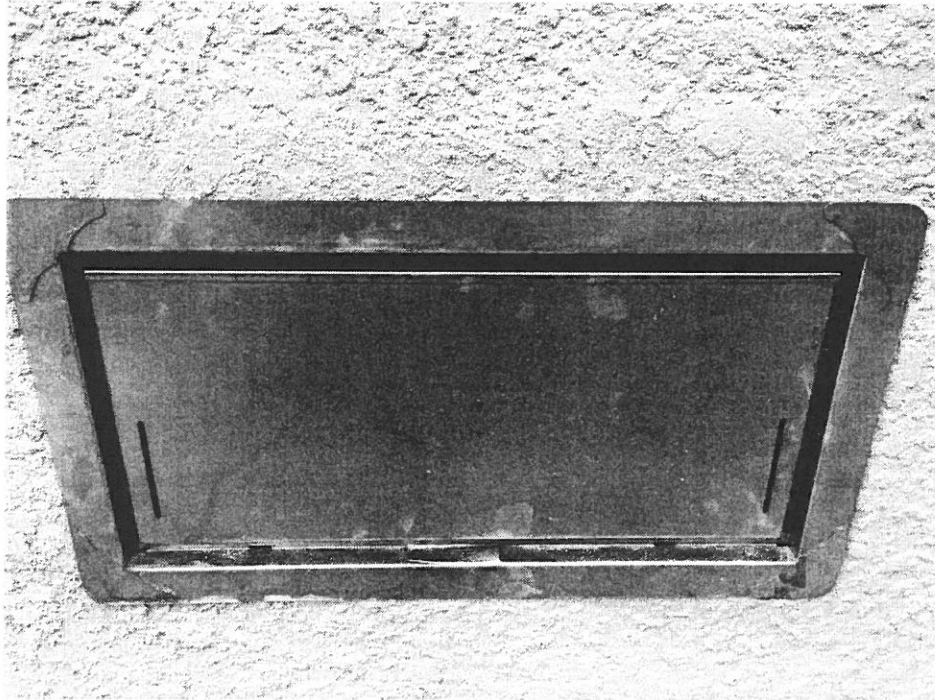
