



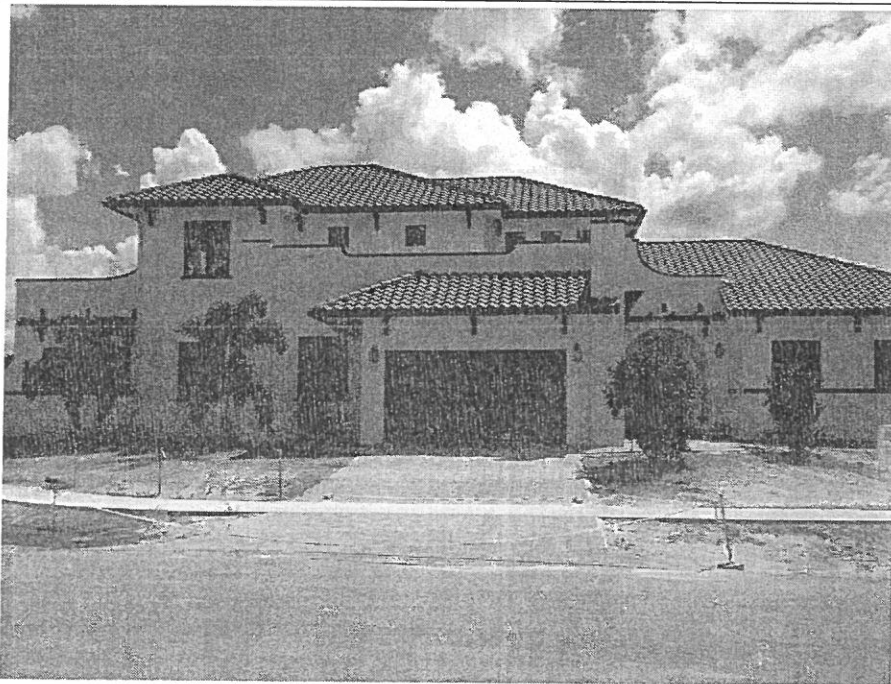

Photo One Caption FRONT VIEW 10/3/16

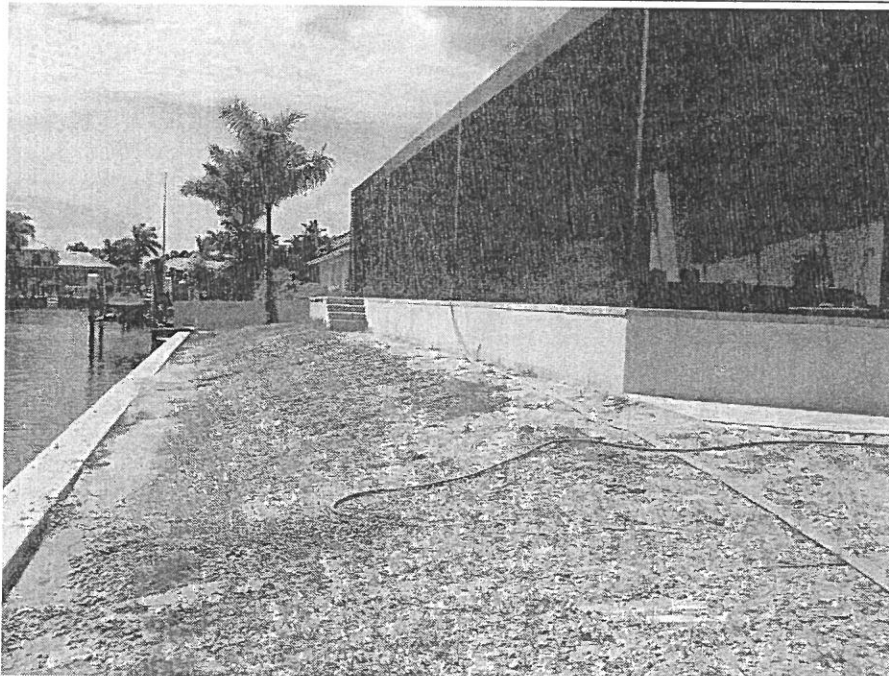

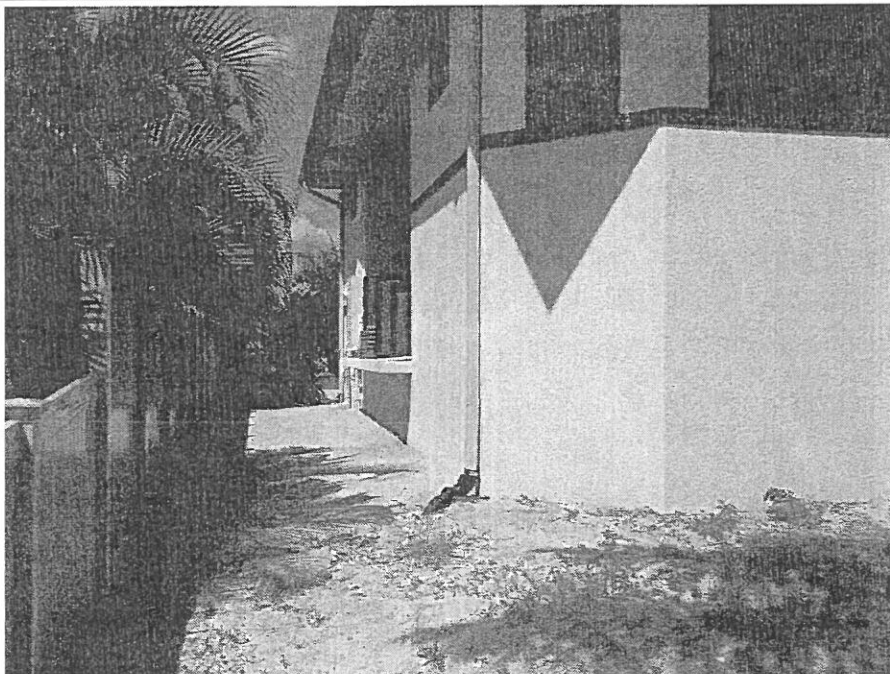
