  3. INSTALL WHEELS AND TOUNGE WITH HITCH STORED UNDER TRAILER
  4. RAISE / JACK TRAILER AND REMOVE BLOCKING
  5. USE MINIMUM 1 TON TRUCK FOR HAULING TO SAFE LOCATION
- \*trailer to be relocated at the pre-storm preparedness stage of impending hurricane to predetermined location.
