

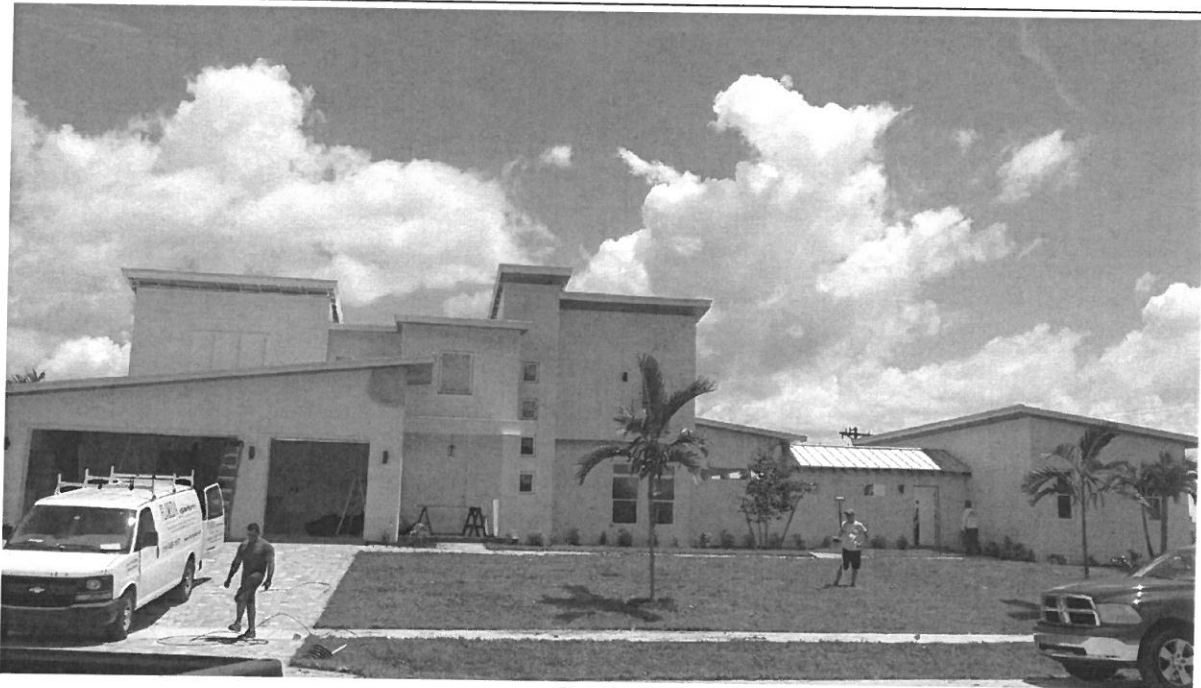

Photo One Caption front view 8/26/16

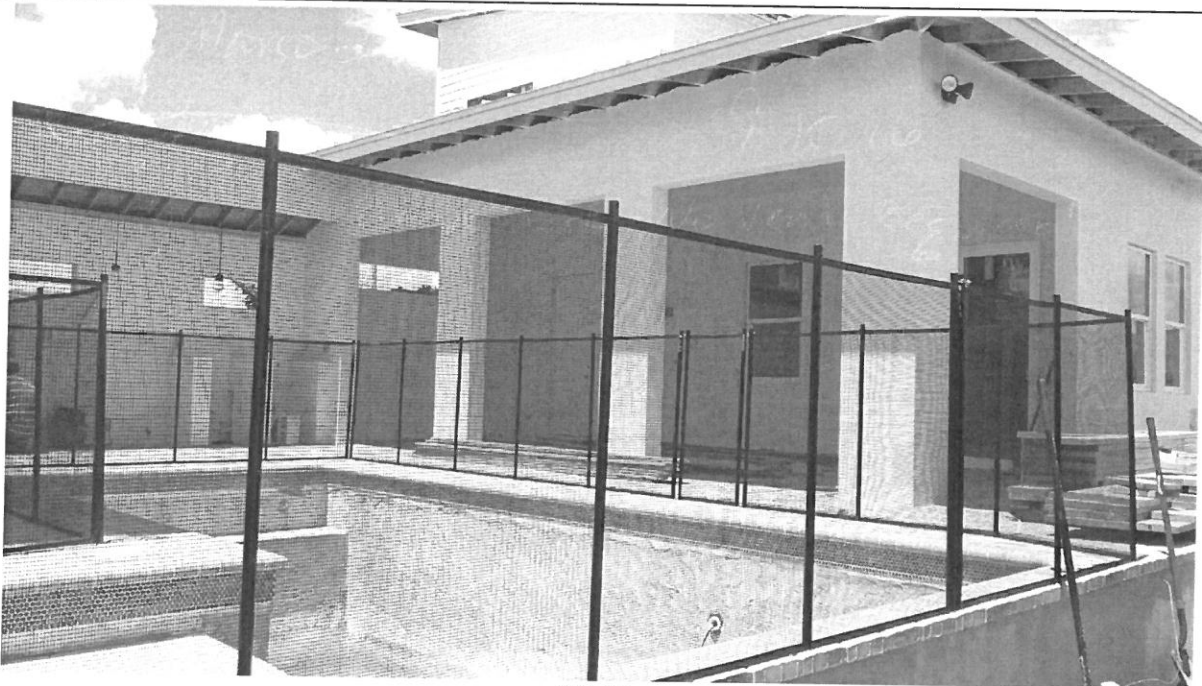

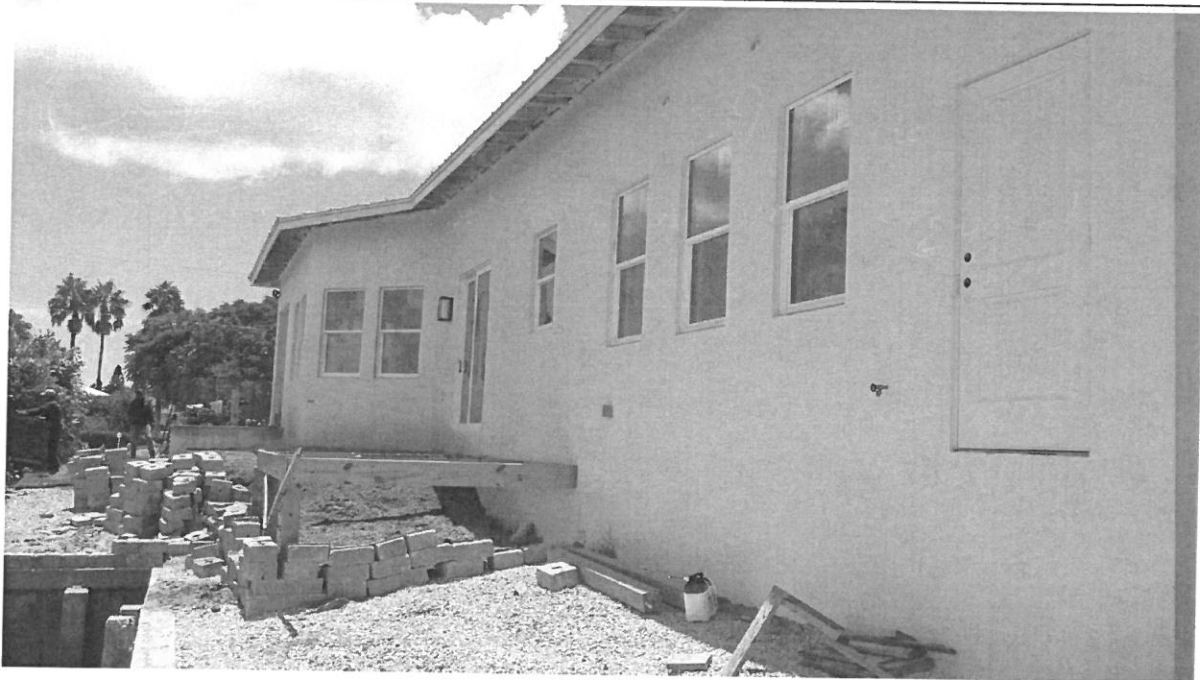

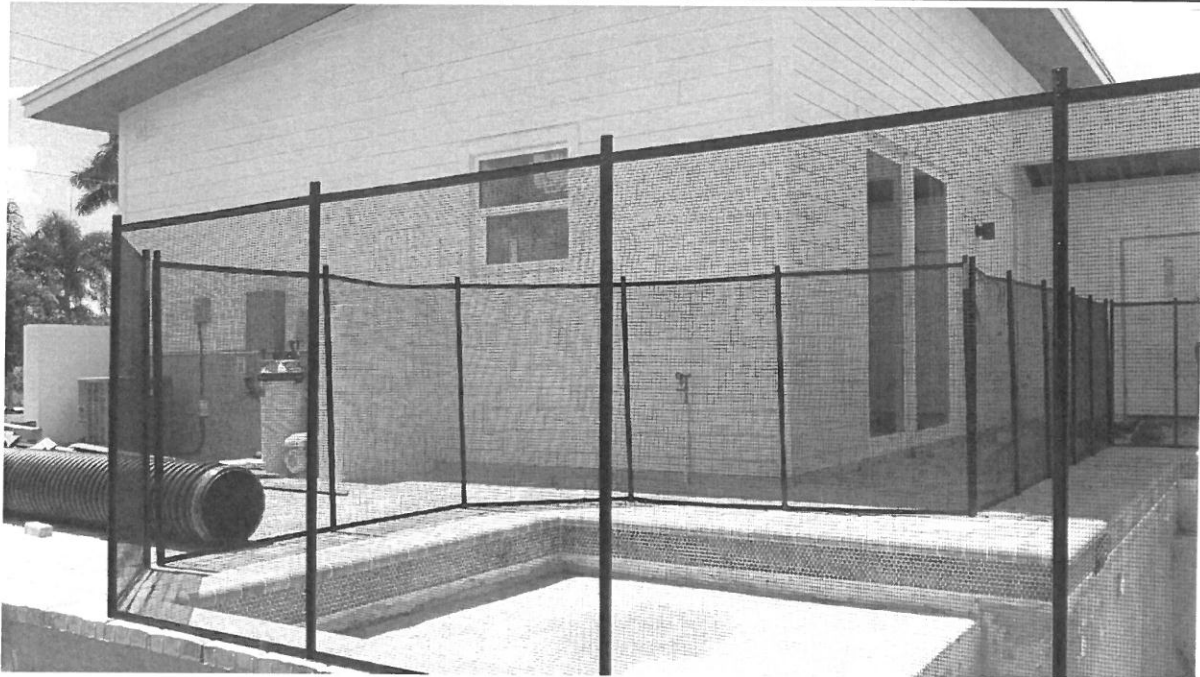
