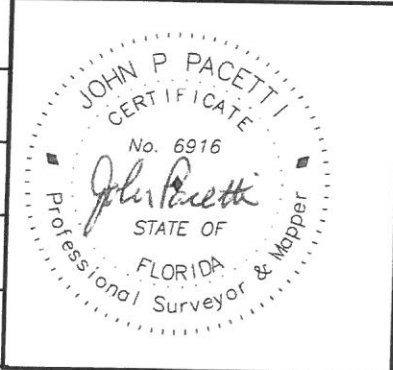

(2) vents in the enclosure are greater than 1' above adjacent grade. C2a is the front door threshold as there was no access to the structure. C2e is the A/C pad (N. side). Local jurisdictions may have elevation requirements more restrictive than the base flood elevation shown hereon, consult applicable building department regarding any design decisions. 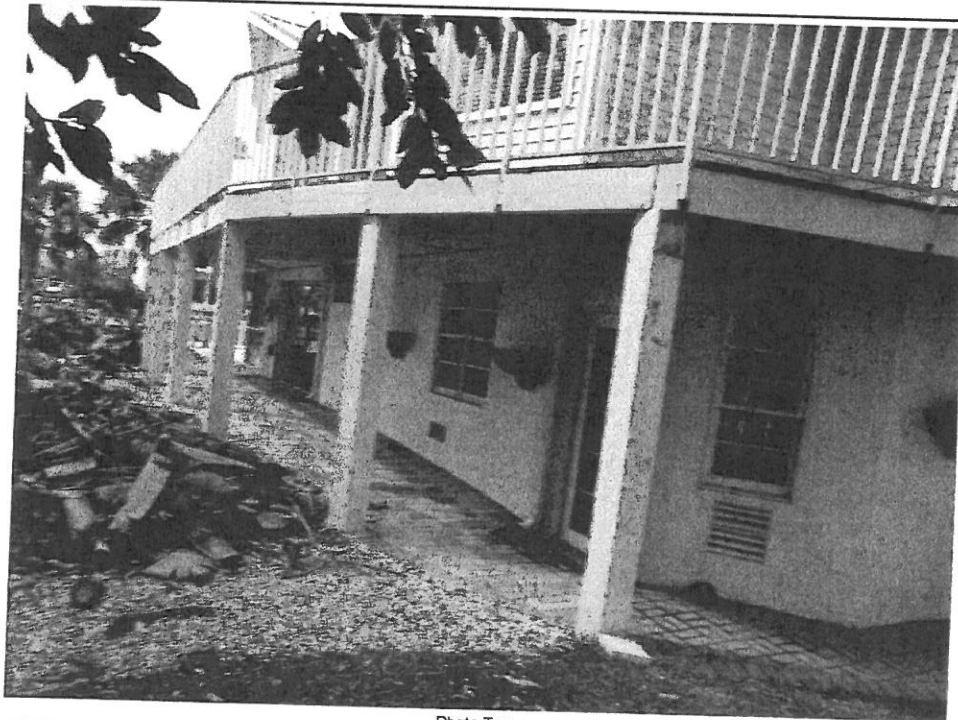

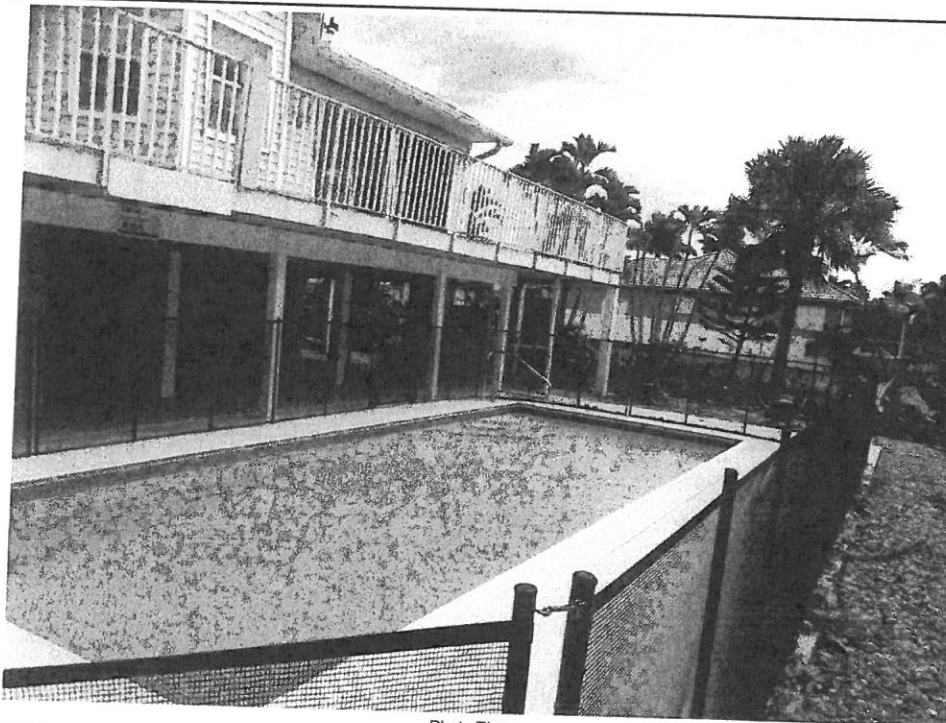

Photo Three Caption : Rear Side View (W) on 02/20/2019

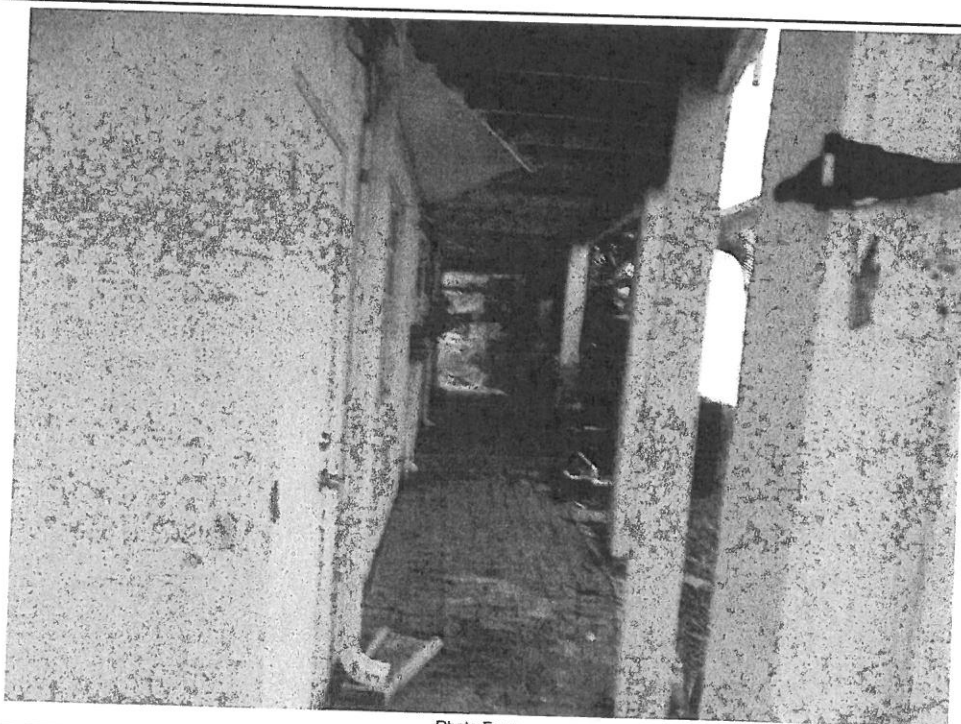
