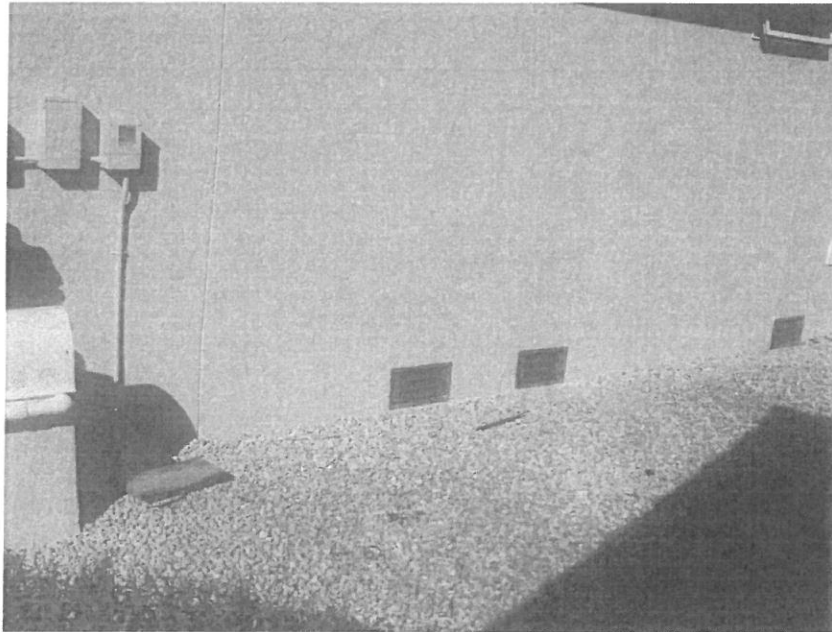

Photo Three Caption Vents-Left Side View 11/23/2016

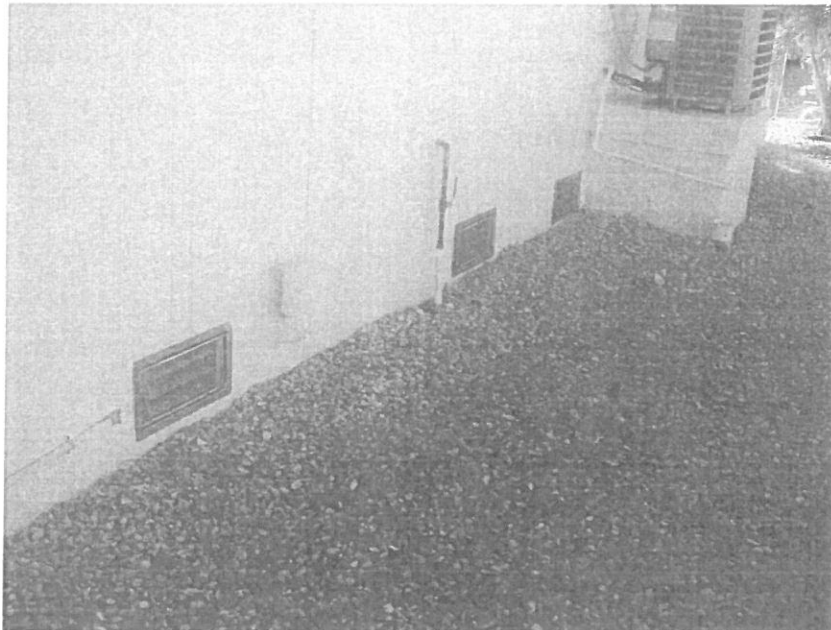

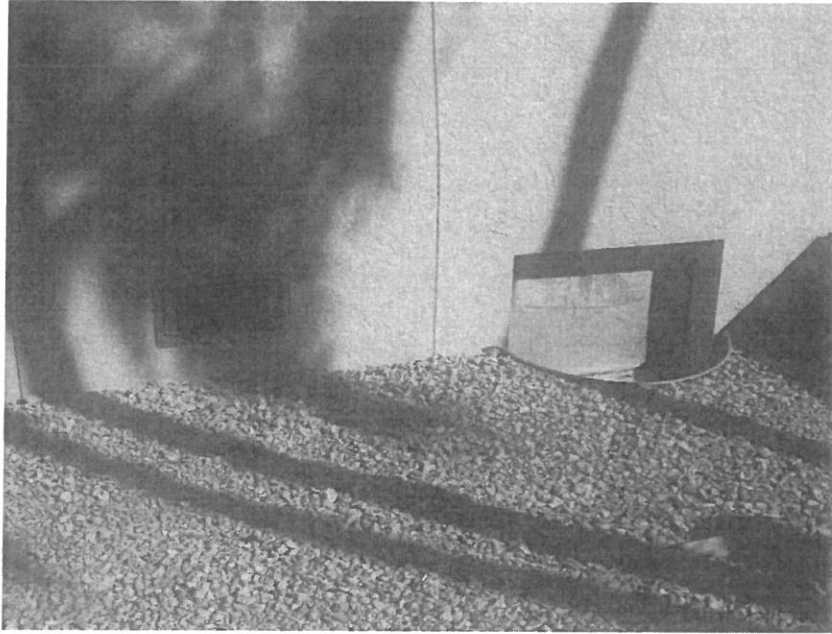

Photo Five Caption Vents-Rear View 11/23/2016

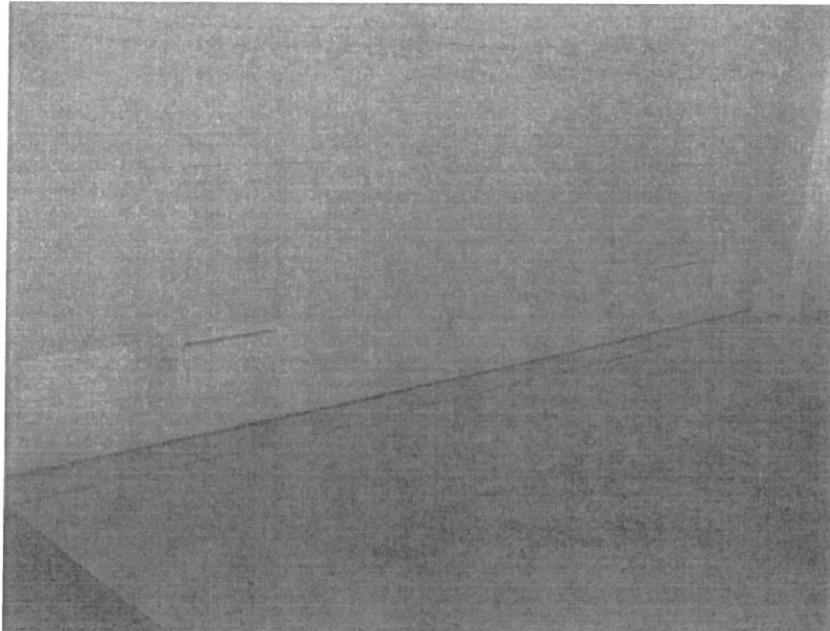
