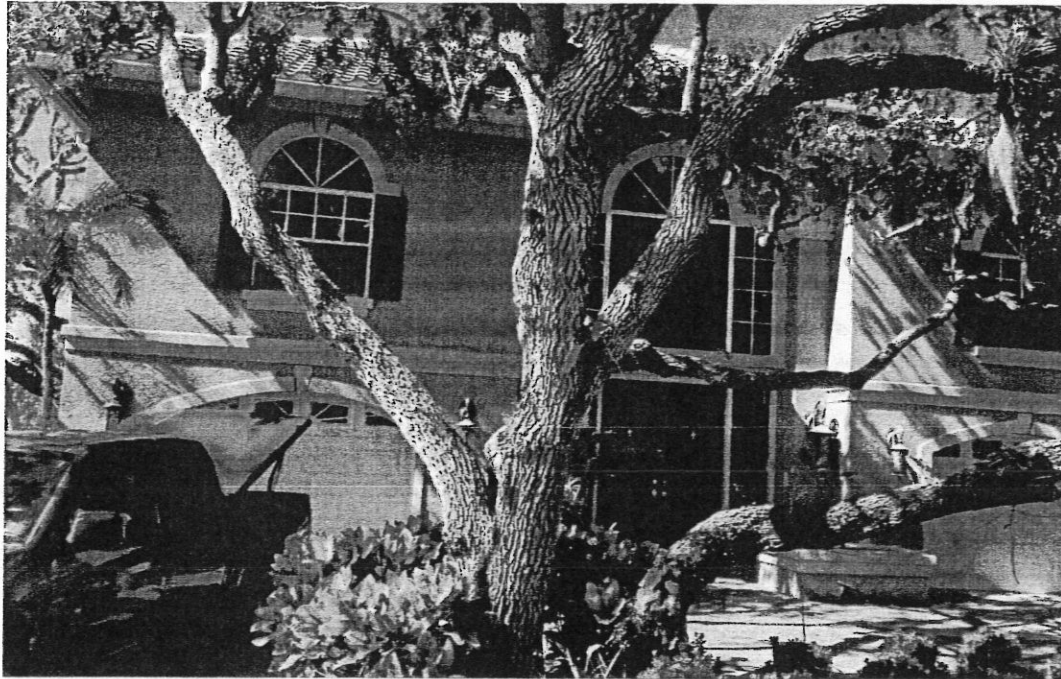

Photo One Caption FRONT VIEW: 02/15/2018

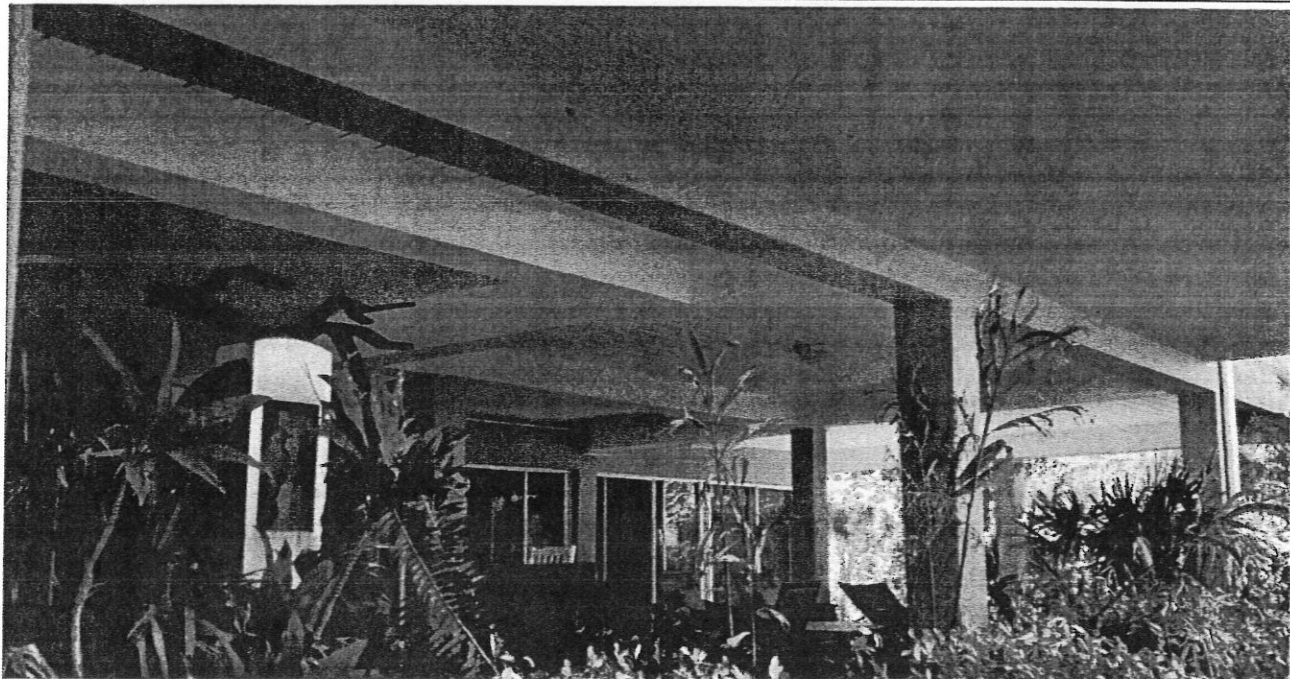
