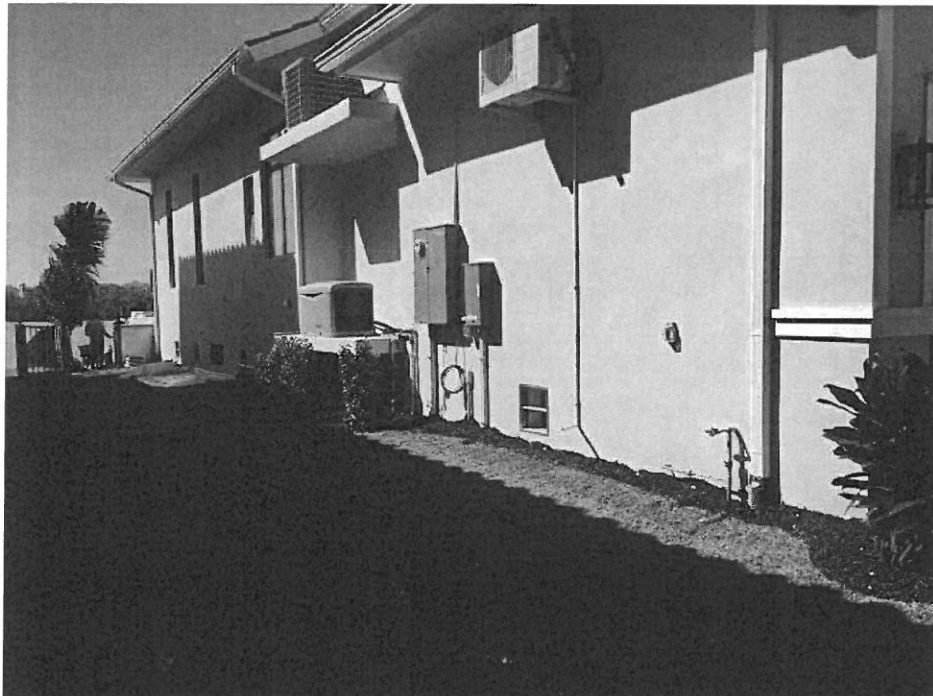

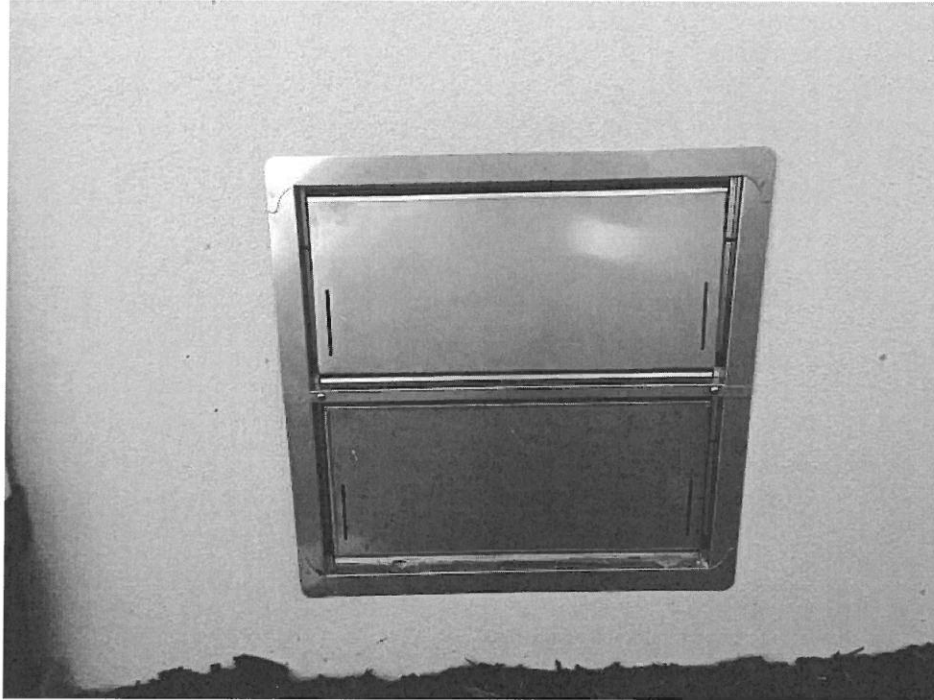

Photo Five Caption TYPICAL VENT 02/12/2020

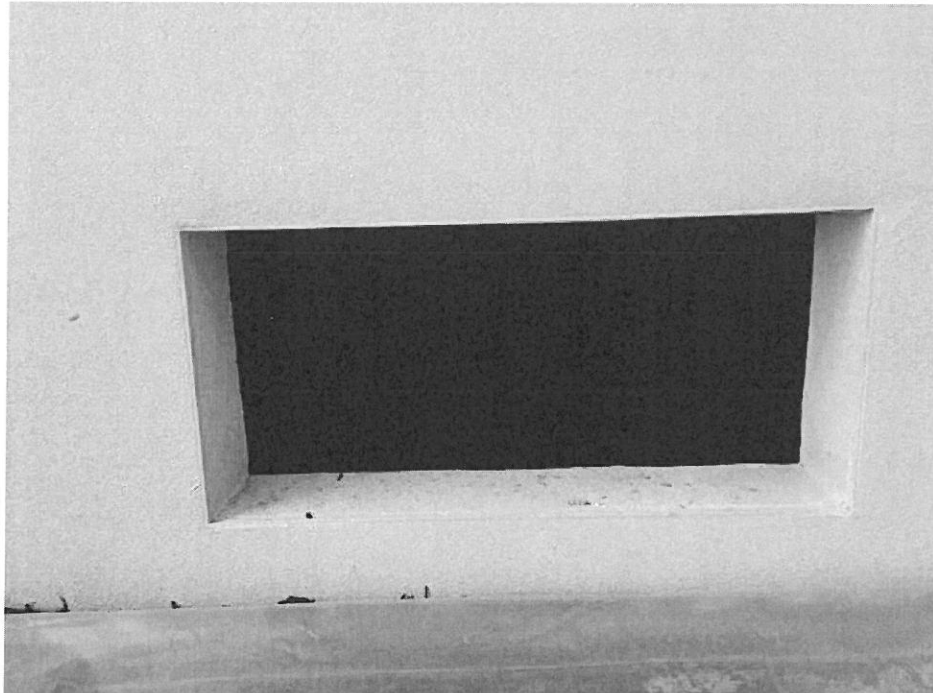
