A9a Square footage was derived from the Collier County Property Appraiser's website. A9c is based on figure #12, page #13 of the Non-Engineered Opening Guide, Volume 2, dated November 2015. There are (3) additional flood openings that would provide 45 sq/in each, painted over, that no net area credit was given. C2a is the front door threshold as there was no access to the structure. C2e is the A/C pad (W. side). The A/C pad (E. side) is at 7.1'. Local jurisdictions may have elevation requirements more restrictive than the base flood elevation shown hereon, consult applicable building department regarding any design decisions. According to the Collier County Property Appraiser, this structure was built in 1977.
