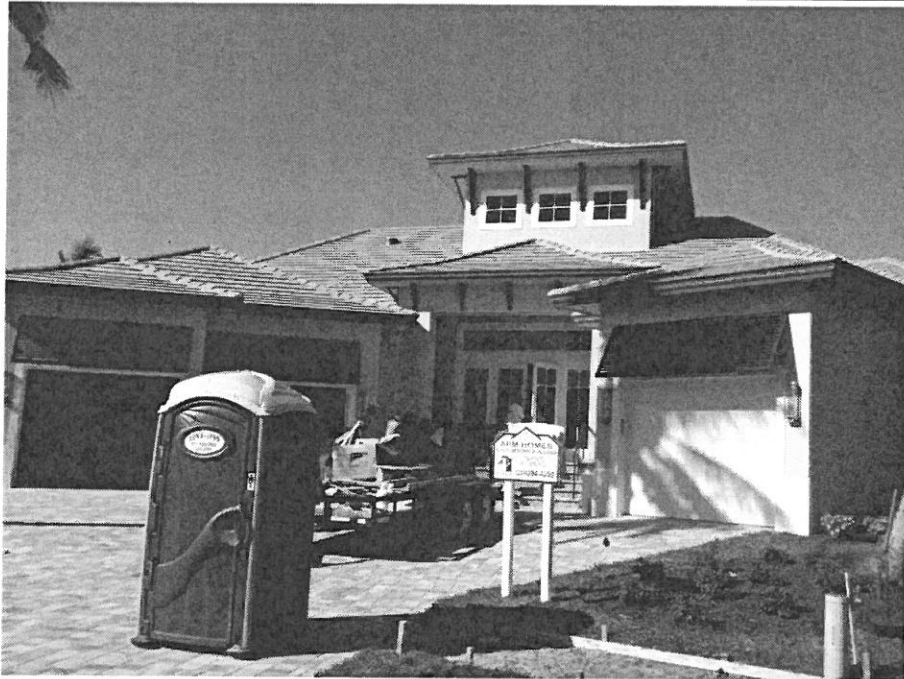

Photo One Caption FRONT VIEW 1/24/2017

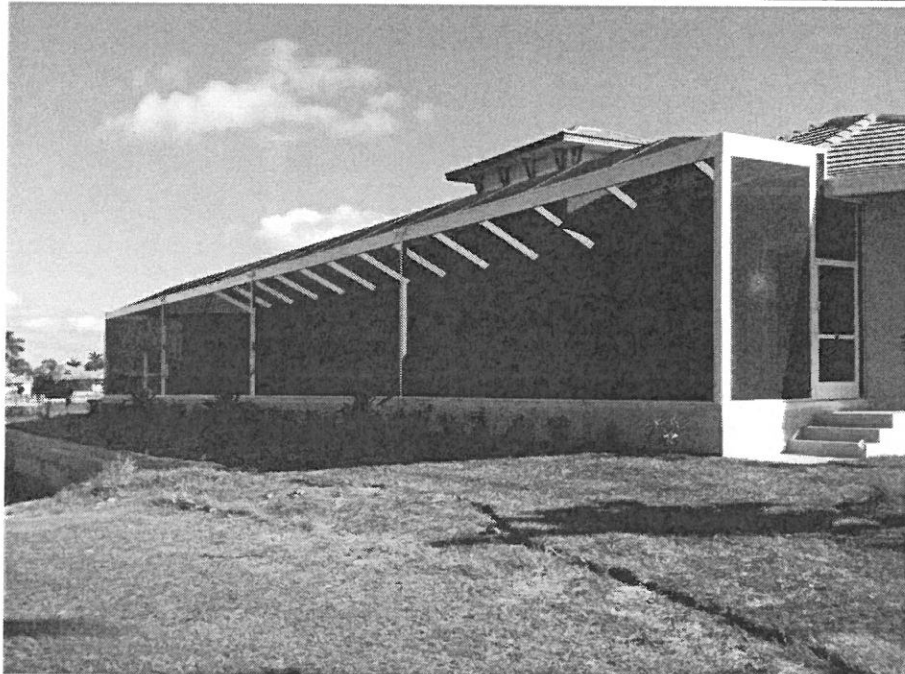

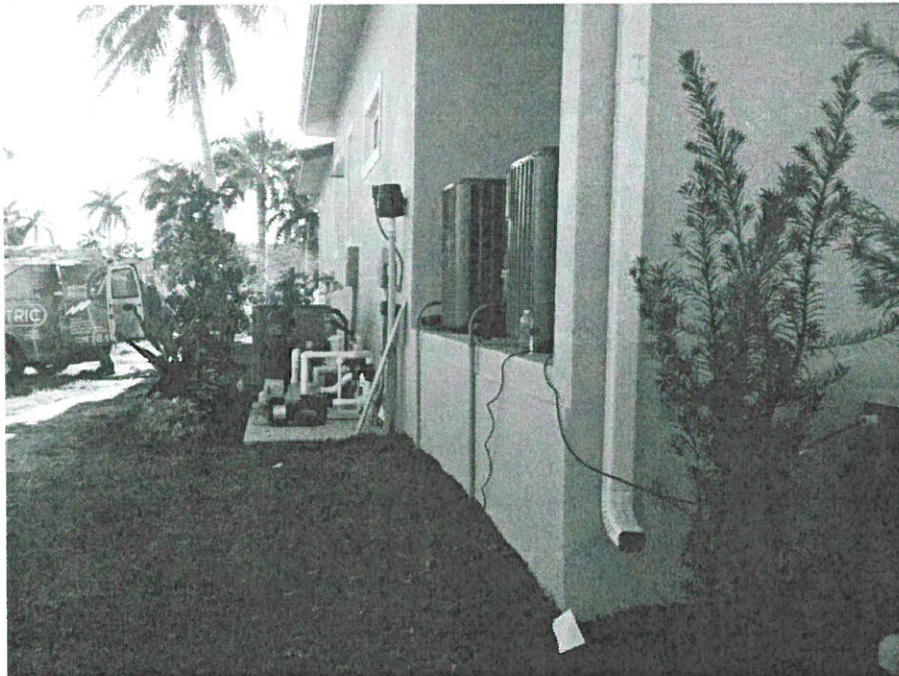

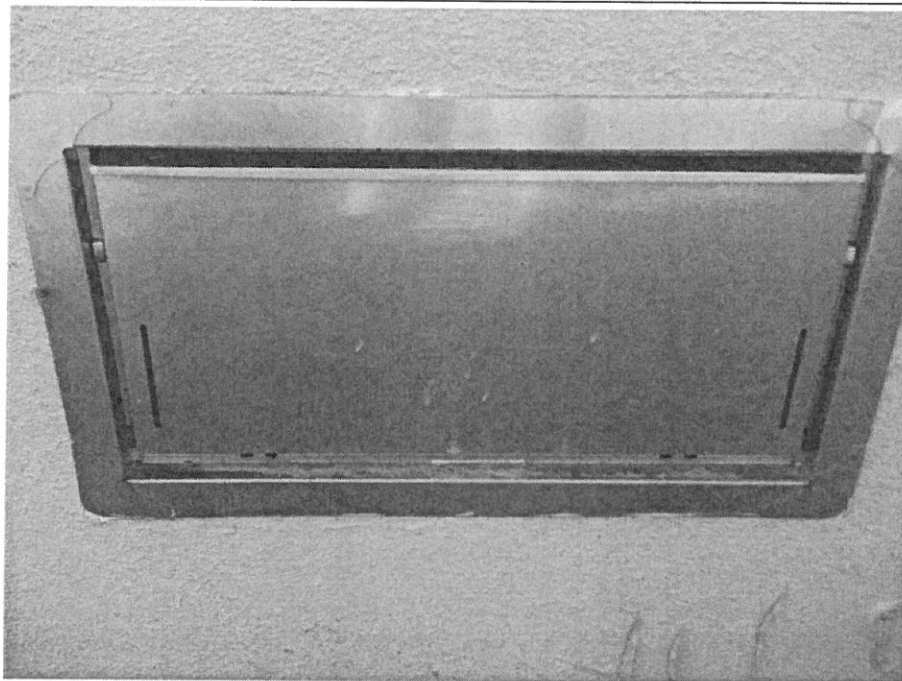
