LF CERTIFICATION

This limited certification, often referred to as a "fertilizer license" or "LF license", is issued by the Florida Department of Agriculture and Consumer Services (FDACS). This certification is required by Florida law to apply fertilizer commercially ("for-hire") on residential or commercial properties, or to parks or nonagricultural fields. Each individual fertilizer applicator must have this certification.

> Before applying for the FDACS LF Certification, you must take the <u>GI-BMP Training</u>.

BEGINNING MARCH 1, 2023, ALL LANDSCAPING AND FERTILIZER BUSINESSES OPERATING ON MARCO ISLAND ARE REQUIRED TO BE REGISTERED WITH THE CITY OF MARCO ISLAND. STARTING APRIL 1, 2023, MARCO ISLAND POLICE DEPARTMENT CODE ENFORCEMENT WILL BEGIN STRICTLY ENFORCING THE PROFESSIONAL LANDSCAPE/FERTILIZER REGISTRATION AND COMPLIANCE PROCESS. THE CITY OF MARCO ISLAND ENCOURAGES RESIDENTS TO VERIFY THEIR LANDSCAPING COMPANIES ARE LICENSED AND REGISTERED.



PROFESSIONAL FERTILIZER LAWN & LANDSCAPE REGISTRATON PROCESS

TO MAINTAIN THE QUALITY OF OUR WATERWAYS, THE CITY OF MARCO ISLAND WILL RESTRUCTURE THE PROFESSIONAL LANDSCAPE AND FERTILIZER REGISTRATION PROCESS IN COMPLIANCE WITH THE FOLLOWING: FSS 482.1562 AND CODE OF ORDINANCE 16-02 SECTIONS 8-70 THROUGH 8-80 SECTIONS 18-62 THROUGH 18-65

BUSINESS REQUIREMENTS

Step 1. Business owner must obtain the Green Industries Best Management Practices (GI-BMP) Certificate from the University of Florida.

Step 1a. Fertilizer applicators must also obtain the Limited Certification or Fertilizer License (LF License) issued by the Florida Department of Agriculture and Consumer Services (FDACS), renewable every four years. Visit aesecomm.fdacs.gov, email AESCares@FDACS.gov, or call 850-617-7977.

Step 2. If the primary location of the business is from an office or home office on Marco Island, a Home Occupational Certificate of Zoning Compliance is required. If your business is located off of Marco Island a Occupational Certificate of Zoning is not required.

Step 3. Business owner shall obtain a Business Tax Receipt (BTR) from the County in which their business is located.

Step 4. Complete the City of Marco Island Professional Lawn and Landscaper Registration Form. These forms are available online cityofmarcoisland.com/growth management. **Step 5.** Submit applications via email gmhelp@cityofmarcoisland.com or in person at City of Marco Island Growth Management, 50 Bald Eagle Drive, Marco Island, FL 34145.

Application must include:

a) GIBMP (to include all landscape professional/employees)

b) "LF License" (Fertilizer Applicators only)

c) Zoning Certificate (when applicable)

d) Business Tax Receipt

e) Registration Form and Fees

Step 6. Once the application is approved, window decals will be provided to the applicant showing proof of registration. The decals shall be adhered to the inside left lower section for all company vehicles. *Decals will have a unique ID number.

Step 7. A minimum of one business day prior to fertilizing, the applicator shall submit an email request to gmhelp@cityofmarcoisland.com that includes the location, type of fertilizer, and acknowledgement that a spreader deflector will be utilized.

LANDSCAPE PROFESSIONAL (EMPLOYEES) REQUIREMENTS

Step 1. Obtain the Green Industries Best Management Practices (GI-BMP) Certificate from the University of Florida.

Step 2. Obtain the Limited Certification or Fertilizer License (LF License) issued by the Florida Department of Agriculture and Consumer Services (FDACS), renewable every four years. Visit aesecomm.fdacs.gov, email AESCares@FDACS.gov, or call 850-617-7977. (For fertilizer applicators only)

OVERVIEW

- Applicant cannot apply fertilizer more than four times per year per location.
- Applicant shall keep a copy of the email permit request with them while fertilizing and produce same at the request of a Code Enforcement Officer.
- Every registered lawn and landscape professional shall carry his or her registration and photo identification at all times while engaged in lawn and landscaping work in the City of Marco Island.
- Fertilizer applicators shall have and carry in their possession at all times when applying fertilizer evidence of their "LF License".
- Landscape professional and fertilizer applicators are encouraged to keep on their persons a copy of their GI-BMP certificate.
