

RESOLUTION NO. 00- 40

A RESOLUTION REQUESTING FLORIDA DEPARTMENT OF TRANSPORTATION AUTHORIZATION FOR LANDSCAPE IMPROVEMENTS ON S.R. 951 AT THE MARCO RIVER BRIDGE (JUDGE JOLLEY BRIDGE); AUTHORIZING THE CHAIRMAN OF THE MARCO ISLAND CITY COUNCIL TO EXECUTE A LANDSCAPING INSTALLATION AND MAINTENANCE AGREEMENT WITH THE FLORIDA DEPARTMENT OF TRANSPORTATION; AND AUTHORIZING THE CITY MANAGER TO EXECUTE THE ATTENDANT LANDSCAPE PERMITS.

WHEREAS, the Florida Department of Transportation (FDOT) is the operating/maintenance/permitting authority for S.R. 951, including that portion of roadway on the north side of the Marco River Bridge (Judge Jolley Bridge), State roadway section 03030, between milepost 2.908 and milepost 3.001; and

WHEREAS, the FDOT and the City of Marco Island are desirous of beautifying the aforementioned segment of S.R. 951 through the proper application and maintenance of landscape materials.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MARCO ISLAND, FLORIDA, that FDOT accept the following conditions in performance of landscape improvements as proposed herein by the City of Marco Island:


1. The City of Marco Island assumes the responsibility and cost for landscape installation and maintenance work within FDOT roadside right-of-way at the Judge Jolley Bridge.
2. The City of Marco Island accepts the landscape plans as prepared by McGee & Associates, Inc. and as reviewed and approved by FDOT staff (Reference McGee & Associates, Inc. S.R. 951 Landscape Plans; Sheet Nos. L-1, L-PS-1, L-PS-2, and I-IS).
3. The City of Marco Island is responsible to notify all applicable utilities in writing concerning proposed landscape improvements herein, and to coordinate utility relocation as necessary.
4. To implement the landscape improvements, the City Council hereby authorizes the Chairman of the City Council to execute the State of Florida Department of Transportation Highway Landscaping Installation and Maintenance Agreement. The City Council of the City of Marco Island


hereby further authorizes the City Manager or his staff to execute the attendant landscape (right-of-way) permit(s).

5. To administratively ensure proper coordination of the landscape improvements, a certified copy of this Resolution shall be provided to the FDOT District One Secretary, the FDOT District One Landscape Manager, and other persons which may be deemed to have an interest in these matters.


