

MARCO ISLAND PLANNING BOARD RESOLUTION NO. 01- 20

RELATING TO PETITION NUMBER TU-E-01-01 FOR AN EXTENSION OF A TEMPORARY USE PERMIT FOR A MODEL HOME ON PROPERTY HEREINAFTER DESCRIBED IN CITY OF MARCO ISLAND, FLORIDA.

WHEREAS, the Legislature of the State of Florida established the Charter of the City of Marco Island in Chapter 97-367, Laws of Florida ("City Charter"); and

WHEREAS, the City Charter provides that there shall be a planning commission advisory to the City Council; and

WHEREAS, the City Council adopted Ordinance 98-1, establishing and creating the Marco Island Planning Board; and

WHEREAS, pursuant to Ordinance No. 98-1, the Marco Island Planning Board is responsible for reviewing and finally approving temporary use permit extensions; and

WHEREAS, Petition TU-E-01-01 is a request for a temporary use permit extension as defined in Ordinance 98-1; and

WHEREAS, the City Charter provides that the Collier County Land Development Code in effect on August 28, 1997 ("Regulations") shall remain in effect as the City of Marco Island's transitional land development regulations; and

WHEREAS, the Marco Island Planning Board, being the duly constituted Planning Board for the area hereby affected, has held a public hearing after proper notice as provided in said Regulations was made, and has considered the advisability of a 3 year extension of a temporary use permit for a model home in a RSF-4 zone for the property hereinafter described, and has found as a matter of fact that satisfactory provision and arrangement have been made concerning all applicable matters required by said regulations and in accordance with Section 2.6.21 of the Collier County Land Development Code; and

WHEREAS, all interested parties have been given the opportunity to be heard by this Commission in public meeting assembled, and the Commission having considered all matters presented;

NOW THEREFORE, BE IT RESOLVED BY THE CITY OF MARCO ISLAND PLANNING BOARD of  
the City of Marco Island, Florida that:

The petition filed by Bob Peloquin of Madra Homes with respect to the property  
hereinafter described as:

Marco Beach Unit 6, Block 249, Lot 13, Collier County, and within the City of  
Marco Island, Florida

Be and the same is hereby approved for a 3 year extension of a temporary use permit for a  
model home in a RSF-4 zoning district where in said property is located.

BE IT FURTHER RESOLVED that this Resolution relating to Petition Number TU-E-01-01- be  
recorded in the minutes of this Board and filed with the City Clerk's Office.

This resolution adopted after motion, second and majority vote.


