

## RESOLUTION 18-73

**RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MARCO ISLAND, FLORIDA, APPROVING THE PURCHASE OF A 2019 FORD F350 2-DOOR 4x4 BRUSH TRUCK FOR THE FIRE RESCUE DEPARTMENT, IN AN AMOUNT NOT TO EXCEED \$57,329.89, FROM HALL-MARK RTC; WAIVING COMPETITIVE PROCUREMENT REQUIREMENTS OF THIS PURCHASE AS IN THE CITY'S BEST INTEREST; AUTHORIZING THE INTERIM CITY MANAGER TO EXECUTE A PURCHASE ORDER WITH HALL-MARK, RTC, AND EXPEND BUDGETED FUNDS ON BEHALF OF THE CITY FOR THIS PURPOSE; AND PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, the City of Marco Island Fire Rescue Department desires to purchase a 2019 Ford F350 2-door 4X4 Brush Truck for a total of \$57,329.89; and

**WHEREAS**, the truck will be purchased using the Florida Sheriffs Association Contract FSA17-VEH15.0 for the amount of \$35,677.38, through Hall-Mark, RTC ("RTC"); and

**WHEREAS**, up fitting of the truck with specialized equipment ("Equipment") is essential for the City to perform its governmental functions; and

**WHEREAS**, the Equipment will be purchased from, and up fitting will be performed by, RTC for the amount of \$21,652.21; and

**WHEREAS**, the City has purchased equipment and services from RTC in the past; and

**WHEREAS**, RTC has satisfactorily and successfully performed similar services for the City; and

**WHEREAS**, due to RTC's expertise and experience with City vehicles and equipment, it is in the best interests of the City to waive the competitive procurement requirements for this purchase; and

**WHEREAS**, City Council does hereby find that the approval of this Resolution is in the best interest of the City of Marco Island.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MARCO ISLAND, FLORIDA, AS FOLLOWS:**

**Section 1.** The above recitals are true and correct and incorporated herein.

**Section 2.** The City Council approves and authorizes the purchase of one (1) 2019 Ford F350 2-door 4x4 Brush Truck, in a total amount not to exceed \$57,329.89, from Hall-Mark, RTC.

**Section 3.** The City Council waives the competitive procurements requirements for this purchase as in the best interests of the City.


**Section 4.** The City Council of the City of Marco Island hereby appropriates \$57,329.89 for this purchase by using Fire Rescue Department Capital Funds.

**Section 5.** The Interim City Manager is hereby authorized to expend budgeted funds on behalf of the City and execute a purchase order with RTC.

**Section 6.** This Resolution shall take effect immediately upon its adoption.
