

RESOLUTION 18-81

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MARCO ISLAND, FLORIDA, APPROVING AND AUTHORIZING THE PURCHASE OF A CHEVROLET SILVERADO 4500 MEDIUM DUTY SERVICE TRUCK (MODEL CK56403), WITH A 5,000 LB. CRANE, FOR THE WATER AND SEWER DEPARTMENT, IN AN AMOUNT NOT TO EXCEED \$80,880.33 UTILIZING THE SOURCEWELL BID CONTRACT 2019-120716-NAF FROM ALAN JAY FLEET SALES IN SEBRING, FL; AUTHORIZING THE INTERIM CITY MANAGER TO APPROVE A PURCHASE ORDER AND EXPEND BUDGETED FUNDS ON BEHALF OF THE CITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Marco Island's ("City") Water and Sewer Department is replacing one of its sanitary sewer pump station service trucks; and

WHEREAS, the City Code provides authority for the City to select and contract through the use of contracts of another government entity as an exception to the otherwise required formal competitive process; and

WHEREAS, the pricing of the vehicle is based on the Sourcewell Bid Contract No. 2019-120716-NAF to ensure that the City receives the maximum cost savings through competitive bidding in compliance with the City's purchasing requirements; and

WHEREAS, the total cost of the vehicle, including the 5,000 lb. crane and tool bed, will not exceed \$80,880.33; and

WHEREAS, the requisite funds are available in the Water and Sewer Department Capital Improvement Program; and

WHEREAS, City Council does hereby find that the approval of this Resolution is in the best interest of the City of Marco Island.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Marco Island, Florida that:

Section 1. The above recitals are true and correct and incorporated herein.

Section 2. City Council of the City of Marco Island approves and authorizes the purchase of a Chevrolet Silverado Medium Duty Service Truck (Model CK56403) with a 5,000 LB. Crane, from Alan Jay Fleet Sales in Sebring, FL, in a total amount not to exceed \$80,880.33.

Section 3. The Interim City Manager is hereby authorized to approve the purchase order and expend budgeted funds on behalf of the City.

Section 4. This Resolution shall take effect immediately upon its adoption.

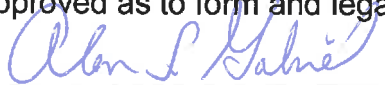
