AN ORDINANCE AMENDING ORDINIANCE NUMBER 91-102, THE COLLIER COUNTY LAND DEVELOPMENT CODE WHICH ESTABLISHED THE COMPREHENSIVE ZONING REGULATIONS FOR THE UNINCORPORATED AREA OF COLLIER COUNTY, FLORIDA, BY AMENDING THE OFFICIAL ZONING ATLAS MAP NUMBER MB4B BY CHANGING THE ZONING CLASSIFICATION OF THE HEREIN DESCRIBED PROPERTY LOCATED AT THE CORNER OF BALD EAGLE DRIVE AND ELKCAM CIRCLE, FURTHER DESCRIBED AS A 1.0+/- ACRE PART OF TRACT D, MARCO BEACH UNIT 6, IN SECTION 8, TOWNSHIP 52 SOUTH, RANGE 26 EAST, COLLIER COUNTY, FLORIDA, FROM RSF-4 TO C-4; PROVIDING FOR STAFF AND PLANNING COMMISSION STIPULATIONS; AND BY PROVIDING AN EFFECTIVE DATE.

NOW, THEREFORE BE IT ORDAINED BY THE MARCO ISLAND CITY COUNCIL, OF COLLIER COUNTY, FLORIDA: SECTION ONE:

The zoning classification of the real property as more particularly described by Exhibit "A", attached hereto and incorporated by reference herein, and located in Section 8, Township 52 South, Range 26 East, collier County, Florida, is changed from RSF-4 to C-4 and the Official Zoning Atlas Map Number MB4B, as described in Ordinance 91-102, the Collier County Land Development Code is hereby amended accordingly. The

herein described real property is the same for which the rezone Is hereby approved.

SECTION TWO:

This Ordinance shall become effective upon adoption.




