

RESOLUTION 18-85

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MARCO ISLAND, FLORIDA, APPROVING AND AUTHORIZING THE PURCHASE OF A 2018 WESTERN STAR TRUCK WITH A DUMP BODY FOR THE PUBLIC WORKS DEPARTMENT, IN AN AMOUNT NOT TO EXCEED \$123,061.00, UTILIZING THE FLORIDA SHERIFFS ASSOCIATION CONTRACT FSA18-VEH16.0; AUTHORIZING THE INTERIM CITY MANAGER TO APPROVE PURCHASE ORDERS AND EXPEND BUDGETED FUNDS ON BEHALF OF THE CITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Marco Island Public Works Department is requesting to purchase a Western Star Truck with a Dump Body and Equipment; and

WHEREAS, the City of Marco Island ("City") Procurement Code provides authority for the City to select and contract through the use of contracts of another government entity as an exception to the otherwise required formal competitive process; and

WHEREAS, the pricing of the vehicle is based on Florida Sheriffs Association contract FSA18-VEH16.0 to ensure the City receives the maximum cost savings through competitive bidding in compliance with the City's purchasing requirements; and

WHEREAS, the total cost for the Loader and Equipment shall not exceed \$123,061.00; and

WHEREAS, the necessary funds are available in Public Works FY19 Capital Improvement Program; and

WHEREAS, City Council does hereby find that the approval of this Resolution is in the best interest of the City of Marco Island.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MARCO ISLAND, FLORIDA THAT:

Section 1. The above recitals are true and correct and incorporated herein.


Section 2. The City Council approves and authorizes the purchase of a Western Star Truck with a Dump Body and Equipment in a total amount not to exceed \$123,061.00, utilizing the Florida Sheriffs Association Contract FSA18-VEH16.0.

Section 3. The Interim City Manager is hereby authorized to approve purchase orders and expend budgeted funds on behalf of the City.

Section 4. This Resolution shall take effect immediately upon its adoption.
