RESOLUTION 19-07

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MARCO ISLAND, FLORIDA, AUTHORIZING A PURCHASE ORDER TO THE VENDOR C.A.P. GOVERNMENT, INC., IN THE AMOUNT OF \$112,500.00 FOR BUILDING INSPECTION SERVICES IN ACCORDANCE WITH THE CITY OF FORT LAUDERDALE, FLORIDA CONTRACT #575-11849 PURSUANT TO SECTION 2-255(G)(5) OF THE CITY CODE; AUTHORIZING THE CITY MANAGER TO APPROVE AND EXECUTE PURCHASE ORDERS FOR BUILDING INSPECTION SERVICES; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, pursuant to City of Marco Island ("City") Code Section 2-255(g)(5), contracts or purchasing agreements that were obtained through competitive purchasing methods by federal, state, county, or municipal purchasing organizations can be used by the city in place of issuing its own RFBs or RFPs; and

WHEREAS, the fees for building inspection services with C.A.P. Government, Inc., is based on the competitively solicited City of Fort Lauderdale, Florida Contract #575-11849 with C.A.P. Government, Inc., as required by Section 2-255(g)(5) and City Purchasing Policies; and

WHEREAS, the aforementioned contract has a fee of \$75/hour for the building inspection services and the City estimates that 1,500 hours of inspections will be necessary; and

WHEREAS, the City Council finds that it is in the best interest of the City to waive competitive purchasing requirements pursuant to Section 2-255(g)(5) of the City Code and to authorize a purchase order to C.A.P. Government, Inc. in the amount of \$112,500.00 for building inspection services in accordance with the City of Fort Lauderdale Contract #575-11849, and to authorize the City Manager to approve and execute purchase orders for these services.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Marco Island, Florida that:

- **Section 1.** The above recitals are true and correct and incorporated herein.
- **Section 2.** The competitive purchasing requirements are hereby waived pursuant to Section 2-255(g)(5) of the City Code.
- **Section 3.** The purchase from the vendor C.A.P. Government, Inc. of building inspection services for the hourly pricing and terms consistent with City of Fort Lauderdale, Florida Contract #575-11849 in the amount of \$112,500.00, is hereby approved.

Section 4. The City Manager is authorized to approve and execute purchase orders on behalf of the City for these services.

Section 5. This Resolution shall take effect immediately upon its adoption.
