

RESOLUTION 22-42

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MARCO ISLAND, FLORIDA, ESTABLISHING THE TRANSIENT RENTAL REGISTRATION ADMINISTRATION FEE TO BE IMPOSED IN CONJUNCTION WITH THE CITY OF MARCO ISLAND'S TRANSIENT RENTAL REGISTRATION PROGRAM; PROVIDING FOR CONFLICTS, SEVERABILITY, AND AN EFFECTIVE DATE.

WHEREAS, on December 5, 2022, the City of Marco Island City Council adopted Ordinance 22-08, establishing the City of Marco Island Transient Rental Registration Program for certain properties located within the City of Marco Island (the "Ordinance"); and

WHEREAS, Section 30-90.4, "Fee and Costs for Registration," of the Ordinance, provides for the establishment of a Transient Rental Registration Administration Fee; and

WHEREAS, in accordance with Section 30-90.4, the City Council shall adopt the Transient Rental Registration Administration Fee by Resolution; and

WHEREAS, the Transient Rental Registration Administration Fee is intended to cover the City's costs to administer the Transient Rental Registration Program; and

WHEREAS, the City Council received information from City Administration regarding the costs to administer the Transient Rental Registration Program and finds that the Administration Fee adopted pursuant to this Resolution is consistent with the intent and purpose of the Ordinance, and serves both a municipal and public purpose.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MARCO ISLAND, FLORIDA:

SECTION 1: The above recitals are true and correct and incorporated herein.

SECTION 2: The City Council hereby adopts a Transient Rental Registration Administration Fee in an amount equal to Eight Hundred and 00/100 Dollars (\$800.00), as authorized by Section 30-90.4 of the City of Marco Island Code of Ordinances.

SECTION 3: That all prior resolutions or parts of resolutions, insofar as they are inconsistent or in conflict with the provisions of this Resolution, are hereby repealed.

SECTION 4: If any clause, section, or other part of this Resolution shall be held by any court of competent jurisdiction to be unconstitutional or invalid, such unconstitutional or invalid part shall be considered eliminated and will in no way affect the validity of the other provisions of this Resolution.

SECTION 5: This Resolution shall take effect immediately upon its adoption.


