

**RESOLUTION 23-02**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MARCO ISLAND, FLORIDA, APPOINTING MEMBERS TO THE MARCO ISLAND PLANNING BOARD, WATERWAYS ADVISORY COMMITTEE, PARKS AND RECREATION ADVISORY COMMITTEE, BEAUTIFICATION ADVISORY COMMITTEE AND BEACH AND COASTAL RESOURCES ADVISORY COMMITTEE; AND PROVIDING AN EFFECTIVE DATE.**
