Hello and Welcome Camp Mackle Parents!

The City of Marco Island Parks and Recreation Department would like to welcome you and your family to Camp Mackle!

Camp Mackle is a summer camp program for children entering first grade through fifth grade. Our hours of operation are 7:30 a.m. – 6:00 p.m., Monday through Friday. Camp Mackle will begin Friday, May 31, 2024, and end on Monday, August 12, 2024.

We'll have special guest speakers and presentations, field trips, specialty craft projects, games, athletics, and other significant experiences. Camp Mackle encourages children to engage in hands-on activities lead by our trained, motivated counseling staff which will expand their knowledge, activate their creativity, and excite their curiosity of the environment around them.

The attached information must be completed in full and returned to Mackle Park **prior** to your camper's first day of camp. Please keep in mind that we do have a daily ratio. Pre-registration is required. Acceptance will be based on priority: Full Summer and Specific Weeks & Day registrations. Walk-ins will be accepted ONLY if a registration form has already been received at least 24 hours prior and we have availability. If you are paying for a full summer session, registration payment is due by Friday, May 24, 2024. Please review the Question-and-Answer page for details on what your child needs each day of camp.

Full Summer Camp Cost is \$770.00, Weekly cost is \$90.00 and Daily cost is \$25.00.

### **Camp Mackle Policy and Procedures**

- Drop-off and Pick-up procedures: Please walk your child into camp each day, a parent or guardian MUST sign the child into camp EVERY morning. This is for the safety of your child. You must come into the facility EACH afternoon to sign out your child. For your child's safety they will not be allowed to leave camp alone. Please have an ID available so that Parks and Recreation staff can check the pick-up list. No child will be released to anyone that is not on the authorized pick-up list. All parents who can legally pick-up a child must also be listed.
- Camp Mackle does not allow any personal items to be brought into camp, they must be left at home. This includes iPod, toys, Legos, Pokémon cards, etc. Children are NOT allowed to use cell phones during camp, in the event of an emergency or if a child would like to call their parents, they can use the phone located at the front desk.
- Camp Mackle has a lost and found table, this table is located by the front desk.
   Please check this table daily. All items may either be thrown away or donated each Friday at the end of camp.
- **Discipline Policy:** Please review this policy with your child, as attending Camp Mackle is a privilege and any camper who is consistently disregarding our rules will be subject to disciplinary action. If a child misbehaves during a field trip that child may lose privilege to participate in the next field trip (you must find alternate plans for child care for that day, they will not be allowed to stay back with park staff).
  - o Discipline actions will generally occur in the following progression:
    - 1st Verbal Warning.
    - 2<sup>nd</sup> Redirection/alternative activity if possible.
    - 3<sup>rd</sup> Time out and/or loss of privileges (ex: not allowed to go in spray park, sitting during playground time, etc.) Parent Contacted and a Discipline Report (parents must sign report).
    - 4<sup>th</sup> Joint meeting with Program Supervisor and Parent.
    - 5<sup>th</sup> Parent will be called and must pick-up camper immediately.
  - Serious infraction may result in immediate suspension or termination from camp. Examples included, but not limited to, intentionally threatening or hurting others, leaving the group without permission, stealing, or causing significant damage to property.

**Field Trips:** All campers must arrive at camp at least 10 minutes prior to bus departure. If a child misses the bus, then parents will need to make other arrangements for child care for that day. ALL campers MUST wear their Camp Mackle T-Shirt. If they do not have a T-shirt, one can be purchased at the front desk for \$12.00. The following rules must be adhered to during the trip as well as at Camp Mackle:

- During the trip to our destination:
  - No standing or jumping during the bus ride.
  - No opening the windows unless instructed by camp counselors.
  - No shouting or screaming.
  - All Collier County School District rules are in effect throughout the duration of the trip.
- At the destination:
  - Campers MUST ALWAYS remain with their assigned counselor.
  - Campers will be respectful of other patrons and all staff members.
  - Persistent rule breaking WILL result in suspension from future field trips.
  - Parent and Guardians are NOT permitted on field trips with the children.
  - If applicable masks may be required while at destination.

### **QUESTIONS AND ANSWERS**

#### Q: WHAT SHOULD MY CHILD WEAR TO CAMP?

A: Your child should wear comfortable clothing, sunscreen (please apply prior to camp), and hat/sunglasses (optional). All campers are required to wear close-toed shoes (no sandals) for safety purposes. Children who do not wear close-toed shoes will not be able to participate in certain activities and their parents will be notified. Campers are required to wear their camp shirt on all field trip days.

### Q: DOES CAMP MACKLE PROVIDE MEALS/SNACKS FOR MY CHILD?

A: No, Camp Mackle does not provide food for campers. Please pack your child a morning snack, lunch, and afternoon snack daily. Campers will not have the opportunity to microwave/heat their lunches or store them in the Park's refrigerator, so please plan accordingly. Throughout the summer Camp Mackle will host special food days. These special days will be noted on the weekly camp schedule. There is a sign-up and additional cost associated with these activities. Campers can choose not to participate and bring their food from home as usual.

### Q: CAN MY CHILD BRING HIS/HER I-POD, CELL PHONE, OR GAMING DEVICE TO CAMP?

A: No, I-PODS, cell phones, gaming devices, or any other electronic equipment is not permitted at camp at any time. If a camper needs to call his/her parent or guardian s/he will need to notify his/her counselor. S/he will then be permitted to use the Mackle Park phone.

### Q: WILL MY CHILD BE ABLE TO PURCHASE FOOD AND DRINK ITEMS FROM THE PARK VENDING MACHINES?

A: Yes, but only during snack and lunch time, after receiving permission from one of the counselors on duty. No sodas or candy will be allowed for purchase during camp hours.

### Q: WHAT ARE THE QUALIFICATIONS OF CAMP MACKLE COUNSELORS?

A: All counselors hired for Camp Mackle are at least 18 years of age, CPR certified, first aid certified, and have participated in a five-day staff training conducted by the City of Marco Island Parks and Recreation Department.

#### Q: WHAT ARE PARENT DROP-OFF AND PICK-UP POLICIES?

A: Each day your child attends camp, an authorized parent/guardian must sign the camper in and out. **A photo ID is required for identification**. We ask that all parents/guardians respect Camp hours and pick-up and drop-off their children accordingly. All individuals who can legally pickup must be listed on page 4 "Child Pick-up Page"

#### Q: WHEN ARE WEEKLY PAYMENTS DUE?

A: Weekly payments are due the Friday prior to the next week. (If spots are still available)

### Q: WHAT IS THE COST FOR A CAMP MACKLE T-SHIRT?

A: Camp Mackle t-shirts are \$12.00 each and your child must purchase one in order to go on camp field trips. NO T-SHIRT, NO TRIP! Parents will have to find alternative child care for this day, as we are not able to watch kids who do not attend our field trips.

### Q: WHAT SHOULD MY CHILD BRING TO CAMP?

A: We encourage all campers to bring plenty of drinking water, morning and afternoon snacks, a packed lunch, sunscreen, close-toed shoes, sunglasses, and a hat. All personal belongings need to be kept in a bag or backpack clearly labeled with your child's name. Camp staff is not responsible for any personal belongings brought to camp, therefore please have campers keep all unnecessary items at home.

### Q: IS MY CHILD ASSIGNED TO A GROUP?

A: Yes, this year's new campers will be assigned to groups according to the grade they just completed. Groups include:  $1st - 2^{nd}$  and  $3^{rd} - 5^{th}$  grades. Campers are required to stay with that group during that time. Groups will join together when guest speakers arrive, or special trips are involved.

### Q: WHAT IS WATER DAY?

A: Campers will have the choice of playing in the Mackle Park Spray Park (weather permitting) for one of their activities. Children who would like to participate should wear their bathing suit to camp, sunscreen, and bring a towel with a change of clothes.

### Q: CAN YOU ACCEPT CHILDREN WITH SPECIAL NEEDS AT CAMP?

A: Although Marco Island Parks and Recreation does not have the capability to provide personal care services, participants are able to bring their own personal assistant for their benefit or to assist with the participants special needs. Personal assistants may be subject to screening questions and background check.

Q: DOES CAMP MACKLE OFFER REFUNDS?

A: All payments are final, No Refunds.
