As global concern about the coronavirus (COVID-19) outbreak grew, the Marco Island Police Department took many measures to keep those within the department safe while still giving superlative police service to the community. We closely monitored the situation and did our best to discourage false information from circulating. We created videos, a multitude of social media posts, and even hand delivered cover letters to restaurants, businesses, and rental properties explaining the evolving situation with Governor's Orders and County and City decisions. We were part of the county and city planning cells, taking proactive measures throughout to be sure that issues in reference to COVID-19 were being addressed but at the same time making sure the public safety concerns were at the forefront. Throughout the month, the department utilized virtual training to teach our staff about COVID-19 and personal protective measures. We also utilized this same platform to strengthen the skills and knowledge of the employees. Technology allowed us to continue our search for potential employees. Throughout the month, we conducted dozens of Zoom interviews in our quest to bring the department to full staffing with the right people.

## Detective Bureau Monthly Report April 2020

#### **INVESTIGATIVE SUMMARY:**

#### Self-Initiated Reports:

**Found Property** – Detective found keys at MI Post Office and was able to locate the owner to return them.

**Sex Crimes** - Allegations of additional unlawful sex acts between juveniles uncovered during an unrelated investigation. Investigation ongoing.

**Stolen Firearm** – Victim reported that a firearm was stolen from his place of business. The firearm's serial number was entered into the national database for stolen property and bulletins were sent out to the law enforcement Fusion Center.

#### Cases Closed by Detective Bureau

**Sex Crime** – Through further extensive investigation, the unknown suspect was identified and located in a case that occurred on the beach around Thanksgiving 2019. Juvenile suspect and victim. This case has been sent to the State Attorney's Office for warrant review.

**Grand Theft** – Allegation of Contractor theft of a \$40,000 deposit for a roof. This case has been sent to the State Attorney's Office.

Sex Crime – Allegation of molestation between family members. This case has been sent to the State Attorney's Office.

**Fraud / Assist Postal Inspectors** – Sweepstakes fraud. Victim was fooled into believing they needed to send a processing fee because they won cash and a car. With the assistance of the US Post office, some of the lost funds were recovered. Unknown suspects. Case Inactive.

**Petit Theft** – Mailbox theft report was unfounded. Waste Management trucks ripped the mailbox off when picking up trash can. Waste Management taking responsibility for repair/replacement. Case Unfounded.

**Vehicle Burglary** – Metal detector was stolen from a pickup truck. All investigative leads were exhausted. Case Inactive.

**Battery Domestic** – Detective collected 911 calls for a domestic case that was referred to the State Attorney's Office (SAO) with a Capias Warrant request. SAO refused to file charges.

**Worthless Check** – 17 N Collier Blvd – Information report of a worthless check presented to a service provider. Referred to the State Attorney's Office worthless check program.

**Stolen Vessel** – 385 Angler Drive – A vessel stolen out of Marco Island was recovered in Miami-Dade County. Victim did not wish to prosecute.

**Lewd and Lascivious Acts** – A case of inappropriate touching was comprehensively investigated and sent to the State Attorney's Office for an Agency Review of the findings.

**Criminal Mischief** – A suspect threw a rock at a window and fled the scene. All investigative leads were exhausted. Case Inactive.

**Criminal Mischief/Grand Theft** – A suspect cut a water meter lock to their residence without permission from the City. After the suspect was identified and provided an admission, the City designee elected to civilly fine the suspect and not have them arrested. Case exceptionally cleared.

**Fishing Equipment Thefts** – Over the last 4 months MIPD took 6 cases for fishing equipment thefts. All investigative leads were exhausted. Cases inactive.

**Retail Petit Theft** – 951 Bald Eagle Drive – A suspect stole shrimp from Rose Marina while they were closed. Detectives discovered the suspect's identity and located him for an interview. The suspect provided a full confession and was issued a notice to appear in court.

**Battery** – 175 S Barfield Dr – A report was made that a shopper was hit in the face by an unknown suspect. A follow-up investigation ensued, and a suspect was identified. A warrant request was sent to the State Attorney's Office for the arrest of the suspect.
