INTRODUCTION

April marked the last month of the year before the beginning of Sea Turtle Nesting Season on Marco Island beaches. The Marco Island Police Department, Code Enforcement Unit, Educational Specialist Tristan Ashby, and Tonia Selmeski, the City's Environmental Planner, worked together to educate the community on protective measures to keep our beaches safe for Sea Turtle Nesting Season. The Police Department held an open house to educate beachfront property managers on Sea Turtle Protection. Officers attended Mackle Park's Spring Jubilee event getting to know the community. Chief Frazzano engaged with the community this month, spending time on the beach interacting with families and speaking with the Marco Island Kiwanis Club. Sgt. Reserve / Auxiliary Program Activity Hours

Reserve and Auxiliary Police Officers are unpaid volunteers who are certified by the State of Florida to perform in the law enforcement role. These officers must meet the Department's and State of Florida's annual retraining / certification requirements. Reserve and Auxiliary personnel are required to volunteer a minimum of 16 hours per month. They perform a variety of functions for our Department and community which are outlined in the chart below. Particularly they assist full-time personnel at community events or special duty functions (requests for an officer to be assigned and compensated by the outside vendor) and during significant weather events such as hurricanes or flooding. Reserve and Auxiliary Officers provide an additional uniformed police presence in neighborhoods, commercial areas, schools, parks, and beaches. Once a month Reserve and Auxiliary Officers have a staff meeting to review policy changes, attend training and address planning and logistical requirements. The below chart signifies the logged hours that have been devoted to the particular assignments by the Reserve and Auxiliary Officers.

Detective Bureau Monthly Report April 2021

INVESTIGATIVE SUMMARY:

Cases Closed by Detective Bureau

Notary Fraud – A case of a contractor committing false notaries was sent to the State Attorney's Office for review.

Battery 2nd Offense – A report was made at a grocery store that a customer pulled down on an employee's facemask. The customer was identified and records show he had a prior conviction of battery. A warrant request was sent for the suspect's arrest.

Retail Theft – A juvenile stealing from a liquor store was identified. The juvenile qualified for the juvenile citation program and was sentenced to 30 hours of community service under the supervision of the Collier County Sheriff's Office.

Assault – An assault case that occurred in 2020 was closed due to the victim being no longer available for prosecution.

Death Investigation – A death investigation from November 2020 was ruled a suicide by the Medical Examiner.

Death Investigation – A death investigation from January 2021 was ruled an accidental overdose.

Suspicious Incident – Suspicious phone calls related to an earlier battery investigation were evaluated along with phone records, and the unknown suspect(s) could not be identified.

Registered Sex Offender – Detective responded to a local timeshare to ensure that a registered sex offender left the location as instructed to prevent a violation of the local sex offender ordinance.

Hit and Run – a parked vehicle was struck at a local hotel. Surveillance cameras were checked and did not cover the area of the crash.

Follow-Up Reports from Patrol:

Fraud – Report of a vessel being stolen and then fraudulently registered through the DMV. Case is currently active.

Stolen Checks – Report of checks being stolen from a residence and then deposited into the suspect's account. Case is currently active.

Sexual Battery – Report of a sexual battery taking place on the beach. Evidence was obtained and sent to FDLE for forensic review. Case is currently active.

Suspicious Incident Sexual in Nature – A woman was reported missing from a bar and then located a few blocks away in a state of undress. Evidence was obtained and sent to FDLE for forensic review. Case is currently active.

Aggravated Battery – Domestic Violence – Male subject battered his parents causing permanent disfigurement. Upgraded toa felony due to the victim being over the age of 65.

Grand Theft – Fishing equipment and golf clubs were stolen from Condo storage unit. No further suspect information was developed after a check of area surveillance cameras.

Luring/Enticing of Child – Three siblings were riding their bicycles from Mackle Park to their home. A white pickup truck, occupied by two male teenagers, stopped to speak to them at three different crosswalks. The victims were scared by the behavior. The juveniles in the truck were identified and their parents were notified. Investigation is ongoing and will be sent to the State Attorney's Office for review when completed.

Self-Initiated Reports:

Assist other Agency – A Detective was enroute to an assignment in Fort Myers when he noticed a road rage incident where one driver was holding the other driver at gunpoint. After intervening, the driver put his gun down and both parties were separated until the Fort Myers Police Department arrived to conduct an investigation.

Operation Medicine Cabinet – Detective Sergeant cleared out the prescription medications turned in by the public three times during the month of April and placed them into evidence for disposal.




