Events

- August 2nd, the Police Department held "**Coffee with a Cop**" at Starbuck's. Attendees met with local officers while enjoying refreshments.
- Also, on the 2nd, the City Manager, Fire Chief Murphy, Captain Baer and Emergency Management Coordinator, Chris Byrne met with the Collier County Emergency Director to discuss All-Hazard preparations, procedures and training.
- The Department held it's first "Coloring with a Cop" on Saturday August 10th. Children and their parents had fun exploring the patrol cars, playing games, and, of course, coloring! Charleen Kraemer won the coloring contest. Families also had the opportunity to have their children's fingerprints taken by an Officer.

- Captain Baer and Emergency Management Coordinator Chris Byrne participated in a Public Information and Strategy Hurricane Exercise session at Collier County Emergency Management on August 12th.
- School began August 13th. As always, our children's safety is a priority. Officers and crossing guards ensure drivers respect school zones. MIPD asks that everyone observe traffic & parking laws, watching and reporting any suspicious activity.
- August 13th and 14th, 17 members of the MIPD attended a seminar on Intelligence-Led Policing, instructed by the St. Petersburg College Center for Public Safety.
- The 2019 national "Drive Sober or Get Pulled Over" campaign went into effect across the country from August 14th to September 2nd. One of the deadliest and most often committed, yet preventable of crimes, impaired driving, has become a serious safety epidemic in our country.
- On August 16th, Captain Baer, Community Affairs Director Smith and Environmentalist Tonia Selmeski had a meeting to discuss upcoming Beach Vendor Permit inspections. Vehicles on the beach were a significant element of the discussion.
- The Department continued its search for both sworn and community service officers at a Law Enforcement Career fair on August 23rd, in Miami.
- The Marco Island Police Foundation hosted their annual summer picnic for members, officers, and their families. Taking place on August 24th, the event was hosted by St. Mark's Episcopal Church and the Police Foundation, with a sell-out crowd of 150 people. New

Chief, Tracy Frazzano, and new City Manager, Mike McNees, were both warmly welcomed by the community.

- Chief Tracy Frazzano assumed Departmental Leadership from Acting Chief Baer on August 26th. Chief Frazzano is the Department's sixth Chief of Police.
- We ended the month with the approach of Hurricane Dorian. Fortunately, the storm veered to the North and East. During Hurricane Dorian, Departmental and City operations / contingency plans were reviewed in advance and enacted (personnel, asset protection / preparation) based on requirements. The Department assisted Information Technology staff in setting up the City's Emergency Operations Center. Numerous telephonic and in-person briefings were held or attended by Departmental staff relative to forecasting, planning, operations and logistics. The City's telephone hotline was activated for several operational periods and staffed by members of the Police and Finance Department. City-wide fuel surveys were conducted by MIPD. For the first time, the City stood up its Public Information Team, consisting of Captain Dave Baer MIPD, Firefighter Chris Bowden MIFRD, and Community Education Specialist Tristan Ashby MIPD. The team linked the City's web site and multiple social media accounts, and between 8/24/19 and 9/3/19 informed the public through multiple platforms:




