Re: December 2015 Monthly City Council Report

On 12/8/15, CCSO arrested Currie for a burglary that occurred off the Island. MIPD determined that Currie had pawned items from a Dogwood Drive burglary. On 1/15/16, MIPD Detectives charged Jerry Currie of Naples with Grand Theft \$300 - \$5K. Currie's charge stems from an exhaustive investigation into a series of burglaries that recently occurred on the Island. Since Currie's arrest, burglaries on Marco Island have ceased. MIPD continues to investigate the burglaries and anticipates additional charges and arrests.

Capital Expenditures

The Police Department is continuing to implement its plan to replace several high-maintenance aging vehicles with four (4) 2016 Ford Interceptor Utility Patrol vehicles. The vehicles being replaced are between five and 12 years old, with an average life-time maintenance cost of over \$15K per vehicle. Planned purchases also include one (1) 2016 Ford Escape 4X4 for use by the Detective Bureau and one (1) 2016 Ford Explorer 4X4 for use by the Chief of Police. Total cost for vehicles and equipment (safety, emergency, video and communications) will be approximately \$300,000.00. Vehicles are purchased through the Florida Sheriff's Association Statewide Cooperative Purchasing Contract.

In addition, the Department plans to replace outdated Panasonic laptop computers, which do not meet Collier County Sheriff Office's hardware specifications relative to the deployment of the new Computer Aided Dispatch System, with eight (8) new high-tech Fujitsu laptop computers. Total cost will be \$17,200.00. The Department uses competitive quotes for these type of purchases.

Funds for the above expenditures were allocated in our FY16 Capital Improvement (Pay As You Go) Program.
