EVENTS

- The Annual Tree Lighting was held at 6pm December 2nd at Veteran's Park
- The month started out right when, on December 1, 2017, when Collier County awarded Sgt. James Inlow and Officer Lorenzo Smith with the Phoenix Award (Life Saving Award)
- Marco's Annual Boat Parade, scheduled December 16, was cancelled due to unsafe conditions still remaining in the channels from Hurricane Irma.
- December 15th, Coffee & a Bagel with a Cop was held at Empire Bagel. Citizens came in to get to know and to chat with our MIPD Officers.
- Santa arrived at 9:30 December 16th and all hands were on deck for the Christmas Parade that evening.
- On December 22nd Officers Willem Hernandez, and Jeff Stafford, took part in rescuing a young man trying to jump from the S.S. Jolly Bridge shortly after 3:00 am. Officer Hernandez was able to exit his vehicle quickly enough to grab the male by his hand as he jumped over the bridge railing. The male resisted the efforts of Officer Hernandez, who was able to maintain a grasp onto Officer Jeff Stafford arrived on scene and assisted pulling the individual over the bridge railing. The uninjured male was taken into protective custody.
