SIGNIFICANT CASE INFORMATION/INCIDENTS:

Criminal Mischief Greater than \$1,000.00 855 Bald Eagle Drive – A suspect vandalized a pickup truck overnight causing over \$3,000.00 in damage. A follow-up investigation from the Detective Bureau developed a suspect. A warrant request was sent to the State Attorney's Office and is pending approval. *Warrant Pending SAO Approval*

Narcotics/Possession of Firearm by Convicted Felon 300 S Collier Blvd – Officers conducted a traffic stop for a moving violation. Through investigation it was determined the driver was a convicted felon in possession of narcotics and a firearm. The suspect was arrested and was transported to the Naples Jail Center. *Cleared by Arrest*

Stolen Jewelry 880 Huron Ct – Approximately \$8,400 in jewelry was stolen from an apartment. A person of interest was developed, and the case is still pending. *Open*

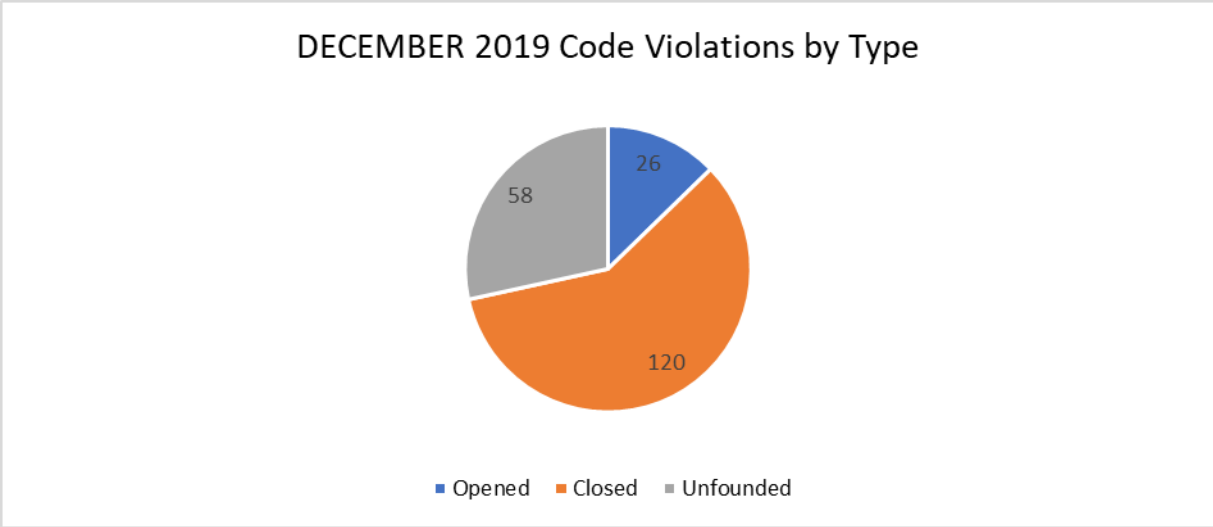
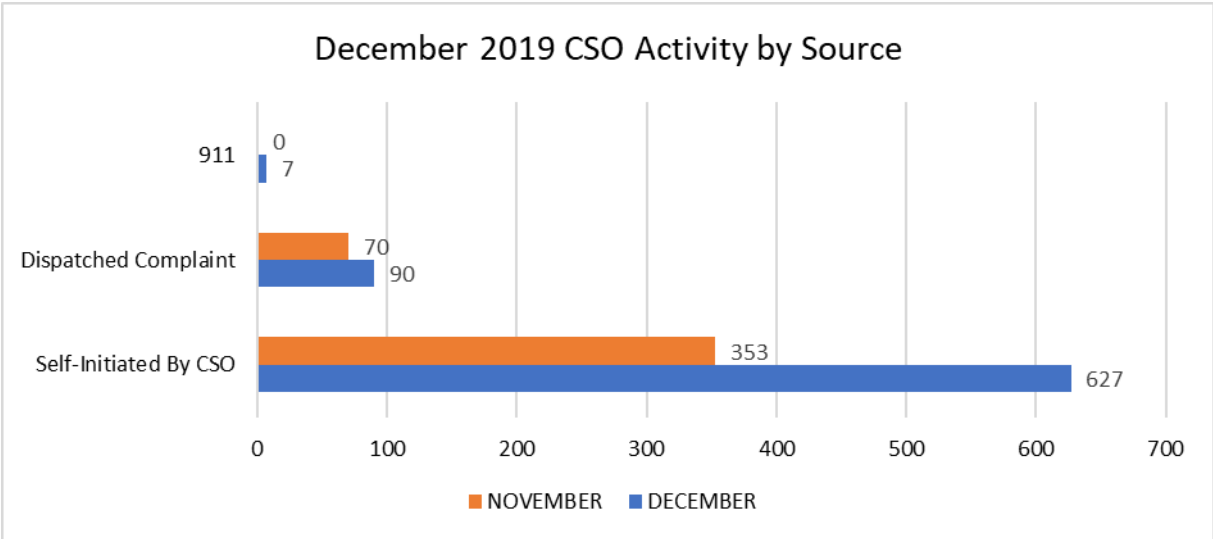
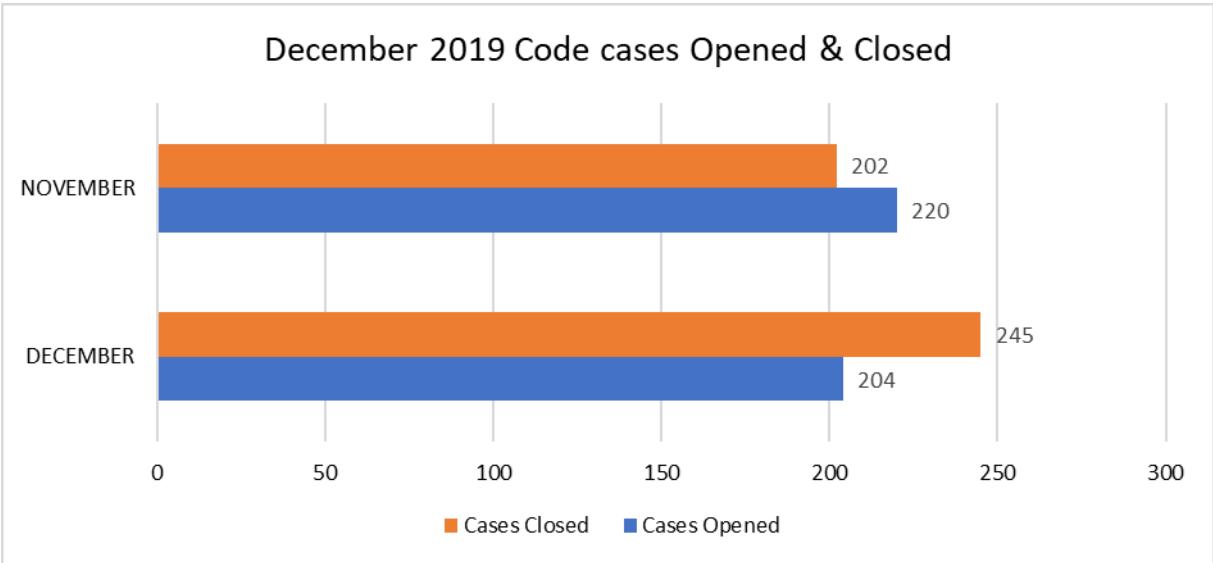
- Identified beach maintenance being performed at the Hideaway Beach and the Madeira Condo -Checked and this was a permitted activity.
