December was a month to celebrate 2021. Our Marco Island Police and Community Service Officers were excited to join the resumed holiday festivities, which included the tree lighting, Christmas First Responder Style, and the Christmas Parade.

The Audubon Western Everglades awarded Marco Island Police Department Community Service Officers a plaque recognizing achievement with wildlife conservation efforts on Marco Island. The Audubon Society and Marco Island Community Service Officers have a strong collaboration, who together protect a variety of species. We look forward to our continued partnership.

As we look back across 2021, we wanted to share achievements delivered by the members of our department. We attribute these accomplishments through the greater use of technology and continued dedication from our Police, Community Service Officers and Administrative staff.

- Police and Code Officers responded to **78%** more calls in 2021 versus 2020. As our Island grows with new residents and visitors, our officers continue to meet needs;
- **200%** more patrols occurred on the Island in 2021 in comparison to 2020. A greater presence helped maintain Marco Island as one of the saftest communities in Florida;
- Code Enforcement beach patrol units responded to **8,662** events, a **56%** increase over 2020. Beach patrol enforces ordinances, performs community outreach, and responds to visitor and wildlife needs;
- Officers arrested **64** more people this year in comparison to last year. Many of the arrests occurred through the ALPR (license plate reader) system: removing unlicensed and uninsured motorists from the roadways;
- Patrols stopped **34%** more vehicles in 2021 and wrote almost **600** more traffic citations in comparison to 2020. Many of the traffic infractions were for speeding events or running red lights: key contributors to accidents;
- Our department collected and properly disposed of over **600** lbs. of medications through Operation Medicine Cabinet: a program that protects our community and reduces environmental damage risk.



December Police Activity

Crime report:

79 incident reports were written in December. The number of crimes this month decreased in comparison to December 2020 due to less reported property crimes. In December 2020, Marco Island experienced multiple vehicle burglaries and vehicle thefts. To prevent a potential reoccurrence, Marco Island Police Department increased December patrols by 80% versus 2020,


An increase with vacation rental scams were reported this month from visitors to the Island. While this is not a new crime, the use of cyberspace makes this fraud easier to commit by criminals through owner impersonation and untraceable IP addresses. In light of recent events, Marco Island Police Department conducted a large-scale rental fraud education campaign through social media and partnering with the news media. We also remind our Island visitors to reconsider moving forward with a vacation rental if it sounds "too good to be true".

More individuals were trespassed this month versus the same time period last year, impacting the increase in Miscellaneous Crimes. The Marco Island Police Department works closely with various businesses, condo associations and property owners to prevent unlawful activity occurring on private property through the use of trespass agreements. A trespass agreement grants law enforcement officers the authority to act on the behalf of the property owner with an alleged trespasser.

Note: Non-Criminal incidents are reports that do not have a criminal offense or are information reports. Examples include fraud cases (outside of Marco Island jurisdiction), other agency assists, lost, and found items and medical assists.

2021 vs 2020 Incident Trends

45 non-criminal incidents were reported in December. Lost and found items represented the largest number of non-criminal events, accounting for 25% of reported incidents. The most reported lost items are credit cards, wallets and handbags. While individuals may be fortunate to retrieve financial items after being lost, the Marco Island Police Department encourages people to protect themselves and freeze lost credit and debit card accounts with their bank when they realize their items are missing.





Traffic patrol



Over 200 traffic warnings and citations were issued in December. Speed related infractions represented the greatest number of written citations: 58% of total issued traffic citations. The share of speed related citations in December increased versus November (58% in December versus 35% for November). Failure to obey the speed limit not only carries financial penalties for the offender but can also impact the driver's insurance plan with points.

The ALPR system (license plate reader) remains instrumental at ensuring people living and visiting the Island have valid registration and licenses. 8 driver's licenses and 2 license plates were confiscated from motorists operating a vehicle with a suspended or canceled licenses. 5 drivers were arrested for knowingly operating a vehicle with a suspended license; they were transported to the Naples Jail Center.

The Marco Island Police Department is using a newly enhanced software tool, Signal4Analytics to help analyze traffic crashes.

Signal4Analytics synthesizes crash data from Marco Island accident reports into various analysis. Data outputs from Siginal4Analytics identify when and why crashes occur from historical crash locations, times of crashes, and factors influencing accidents. Marco Island Police Department's patrol unit will use this information to dedicate more resources to these areas with a goal of reducing future crashes.

December Detective Bureau Monthly Report

Investigative Summary:

Investigative cases for our detective bureau decreased this month vs last year; driven in-part by less reported vehicle thefts and burglaries.

This month's highlight for the detective bureau concerned a case involving an individual who made a false report. The reporting party advised their rental home had been burglarized. After investigating through a series of interviews and neighborhood canvassing, detectives concluded that the burglary was staged. The involved parties later confessed to the false crime.

Cases Closed by Detective Bureau:


Threatening Text Messages – The reporter advised he received multiple threatening text messages, from unknown person(s). The person responsible for sending the messages was identified. The victim declined to pursue criminal charges.

Residential Burglary – Two suspects attempted to gain entry to a locked residence. Moments after the 911 call was made, both suspects were located and identified. The victim declined to pursue criminal charges.

Uttering a Fake Check – An arrest warrant request was approved from the State Attorney's Office for a suspect issuing a fake check. The subject was arrested and processed at Naples Jail Center.

Retail Theft – Two juveniles were identified as suspects stealing from Winn Dixie. The two juveniles were issued juvenile citations and are in a community service program.

Stolen/Recovered Vehicle – A vehicle was reported stolen from the Marriott parking lot. The Detective Bureau canvassed the city and found the vehicle abandoned at a business parking lot. The victim refused to pursue charges after the vehicle was recovered.

Follow-Up Reports from Patrol:

Fraud – Multiple reports of rental and real estate fraud have been made. The investigations are ongoing.

Battery – A report was made of a battery at a restaurant. A photograph of the suspect was disseminated to the public and the case is pending.

Retail Theft – A suspect stole a piece of jewelry from a local store. The Detective Bureau is following leads to identify the suspect.

Domestic Violence – The detective bureau collected 911 recordings and dashcam videos for future court proceedings with a battery arrest.

Suspicious Incident – A student perceived other students used threatening language. Detectives conducted an extensive investigation and found no credible threat. All parents and school administrators were made aware of the incident.

Death Investigation – A person transported to the hospital died hours later. Information was collected and provided to the District-20 Medical Examiner and the initial case file was updated. The death was ruled to be accidental.

Self-Initiated Reports:

Sex Offender – An out of state sex offender visiting Marco Island was served with the local ordinance. The subject complied and left the Island per ordinance requirements.

Fraud – The detective bureau initiated a fraud report regarding an unknown suspect(s) listing a property for sale that did not belong to them. This was discovered through the efforts of the detective bureau to educate the local real estate community.

December Marine Report

During December, Marco Island waterways continue a steady increase of boater traffic and anchored transient vessels. Marine officers conducted vessel safety and sanitation inspections of anchored vessels in Smokehouse and Factory Bays. All inspected vessels were in compliance with Coast Guard regulations.

The Marine unit also conducted vessel safety and compliance inspections for charter, tour and jet ski rental operations operating out of Caxambas boat park. The Marine Unit prioritized commercial/livery operator safety and compliance inspections to accommodate the increased number of commercial tour operators and ensure safety for visitors using the offerings.

Several residents have inquired about a 40' vessel anchored Northeast of the Jolley bridge in the Marco River. Marco Island Police officers have contacted the Florida Fish and Wildlife Conservation Commission (FWC) and the Collier County Sheriff's Office (CCSO) because the vessel is out of Marco Island Police Department's jurisdiction. FWC and CCSO advised they are aware of the vessel and have contacted the owner. Any inquiries regarding the vessel should be directed to CCSO Marine Unit.

Marine highlights in December:

- Officer Ferris responded to a vessel fuel spill on Marlin Court. Investigation revealed fuel from the vessel leaked into the bilge and subsequently expelled into the waterway. The spill was contained, DEP and Coast Guard personnel were notified.
- Officer Marvin responded to Starfish Ct. for a boat that had fallen off its lift and sunk. Officer Marvin assisted in pulling the vessel from the water and secured it to the dock.
- Sgt. Casabona and Officer Marvin secured a vessel that drifted off anchor at Smokehouse Bay. Officers contacted the owner who later removed the vessel for safe storage.
- Marine officers deployed pumps to remove water and prevent a vessel from sinking on Factory Bay. The vessel owner/operator could not be located. FWC was contacted and an investigation initiated.

Continuation of Marine highlights in December:

 Officers responded to 2 marine emergencies (MERTS) the day after Christmas. The first event consisted of two individuals on rafts who floated into strong currents offshore from Marco beach. Officers rescued both individuals and conveyed them back to shore. The second event was a distress signal coming from a vessel positioned seven miles offshore. Officers responded to the coordinates and upon investigation determined the captain was unaware of the activated distress call. All parties were safe.

December Reserve / Auxiliary Program Activity Hours

Reserve and Auxiliary Police Officers are unpaid volunteers who are certified by the State of Florida to perform in the law enforcement role. These officers must meet the Department's and State of Florida's annual retraining / certification requirements. Reserve and Auxiliary personnel are required to volunteer a minimum of 16 hours per month. They perform a variety of functions for our department and community which are outlined in the chart below. Particularly they assist full-time personnel at community events or special duty functions (requests for an officer to be assigned and compensated by the outside vendor) and during significant weather events such as hurricanes or flooding. Reserve and Auxiliary Officers provide an additional uniformed police presence in neighborhoods, commercial areas, schools, parks, and beaches. Once a month Reserve and Auxiliary Officers have a staff meeting to review policy changes, attend training and address planning and logistical requirements.

December Code Enforcement:

Marco Island Community Service Officers responded to several environmental and protected species incidents over December. Calls for service with two environmental violations developed into case involvement from the Florida Fish and Wildlife Conservation Commission (FWC). The first event involved a property owner removing mangroves from the surrounding environment. The State of Florida protects mangroves due to their ecological importance in the ecosystem. Officers intervened and stopped the property owner from further destruction; FWC is leading the follow-up investigation. The second event involved a landscaping company that cleared property with active gopher tortoise burrows. Both the tortoise and its burrow are protected under state law. Gopher tortoises must be relocated before any land is cleared or property developed; permits are required prior to tortoise engagement. Community Service Officers Dodd, Citarella and the Audubon Western Everglades responded to the call in an effort to locate burrows and save entrapped gopher tortoises. FWC was present and is continuing the investigation. Marco Island Code Enforcement reminds our residents to help protect our environment by taking steps at securing correct permits prior to engaging with the surroundings and to call our Officers or FWC Officers with any sick, injured or endangered wildlife.

In December 2021, 68% of Code Enforcement investigations were initiated by Officers while on routine patrol. Threequarters of code enforcement investigations resulted in a notice of violation.



Code Enforcement Cases

The number of cases opened in December 2021 was similar to those opened in December 2020. There were 46% more cases closed in December 2021 as compared to December 2020. This is due to an increase in violations with 24-hour compliance deadlines (examples include trash receptacle violations)

The top three violations written for December included: City Code Ordinance 18-38(8) "Placement of Waste on Curb", 50-37 "Prohibited Parking", and issuance of permits for recreational vehicle parking. Thirty calls for service were made for noise complaints; 5 calls were deemed valid noise violations.

The number of violations for "Placement of Waste on Curb" decreased by half in comparison to last month. This decrease is attributed to greater awareness of the city ordinance and community compliance.

The magistrate hearing was not held during the month of December due to the holidays. The next magistrate hearing is scheduled for January 25, 2022. For more information about Magistrate cases/rulings, please visit us at:

Code Enforcement Protected Species Update

Burrowing Owl season will start soon: February 15th to July 10th. Our Community Service Officers work closely with Owl Watch and the Audubon Western Everglades organizations to protect owls

during breeding and hatching season. In preparation for the upcoming season, our Community Service Officers remind residents and visitors that the protection area around the burrows will increase to a thirty-three-foot perimeter from 10 feet. Please keep this in mind when watching these delightful, but protected creatures. In the coming month, our Community Service Officers will have a series of meetings with the Audubon and Owl Watch volunteers to discuss best practices for collaborating with Burrowing Owl protection.

Sea Turtle protection preparations are on-going with Community Service Officers attending the Third Annual Light Pollution Management Workshop hosted by the Florida Fish and Wildlife Conservation Commission. Officers are also providing input with Growth Management and the Beach & Coastal Resources Advisory Committee regarding the revised Sea Turtle Protection ordinance.

Beach Report

Community Service Officers (CSO) logged more beach patrol hours in December versus November, with 258 hours. Increased patrols and more community outreach were among the primary reasons for the increased beach presence this month. While litter and debris removal continue to be the top incident requiring beach patrol enforcement, Community Service officers responded to an increase of reported dogs on beach this month Our officers continue to remind residents and Island guests that dogs are not permitted on beaches unless they are service dogs.



Calls for service with injured and sick wildlife increased this month versus the previous month, with 23 events. Officers and FWC worked in partnership to locate a baby dolphin, orphaned when its mother was found deceased in a canal. Officers continue to work with local naturalists for the baby dolphin's safety. Community Service Officers Dodd and O'Keefe responded to a call that successfully freed a Cormorant without injury from a line wrapped around its beak. CSO Dodd also captured an injured Royal Tern for treatment at the Conservancy of Southwest Florida. CSO O'Keefe, Curry, and Warder assisted freeing a pelican trapped between rocks near South Beach.


December Community Engagement Report


