Re: December 2022 Monthly City Council Report

Events that occurred in 2022 proved that we are resilient and are always better when we help each other.

Below are the accomplishments achieved by the hard work and dedication of our Officers, Code Enforcement Officers and Administration staff. Please note, many of these accomplishments are under-reported due to refocused efforts with Hurricane Ian safety management and recovery.

- Our officers responded to over 150,000 calls for service in 2022.
- Officers assisted the community by taking **1,060** incident reports in 2022.
- Officers conducted **95,000** extra patrols, keeping our city one of the safest communities in Florida to live.
- Our Marine unit responded to over **6,500 calls for service in 2022, a 130% increase** with marine patrol activity when compared to 2021.
- The Investigations unit cleared and closed over **840 cases**, a **24% increase** in the number of cases versus last year.
- Our Code Enforcement Officers investigated almost **7,000** instances, a **63% increase** over last year.
- Our social media footprint **increased 44%** versus last year, driven in part to the real time information provided during Hurricane Ian.
- Our department collected and properly disposed of **740 lbs**. of medications through Operation Medicine Cabinet: a program that protects our community and reduces environmental damage risk.

<u>December Police Activity</u> Crime report:

89 incident reports were written in December. There was a significant increase with thefts this month versus the same time last year. Most of the reported thefts were in reference to items stolen from unsecured vessels or vehicles. The Marco Island Police Department arrested 15 individuals in December 2022 for offenses including Aggravated Assault, Narcotics, Theft, Fraud and Criminal Traffic.


Note: Multiple criminal offenses may have occurred within some incidents in 2022. This reporting aligns with new crime data collection requirements from the Florida Department of Law Enforcement and the FBI. This announcement for crime reporting was covered in the February 2022 monthly report.

Non-criminal incidents are reports that do not have a criminal offense or are information reports. Examples include fraud cases (outside of Marco Island jurisdiction), other agency assists, lost and found items and medical assists.

December Incident Trends

52 non-criminal incident reports were taken during December 2022, representing 64% of total incident reports. Most of the reports (40%) were for suspicious incidents (suspicious people or phone calls). The Marco Island Police Department encourages our community members and visitors to report suspicious incidents. This month residents reported a suspicious vehicle on the Island that led investigators to arrest 2 individuals for mail theft, narcotics and weapons law violations.

Lost or found property was the second highest number of reports (25%) taken during December.




December Traffic Patrol

199 traffic citations and warnings were issued by the Marco Island Police Department during December. Most infractions (45%) were for the failure to obey signs and traffic control devices. The remaining citations were written for expired licenses and registrations (14%), failure to display a valid registration (9%), and failure to display a valid license (8%).

Our Department is using a combination of speed sentry signs and officer enforcement to slow traffic speeders, making our streets safer for cyclists and pedestrians.

5 individuals were arrested for criminal traffic violations including driving with a suspended license or expired registration.

15 driver's licenses and 2 license plates were seized from individuals for operating a motor vehicle with a suspension or revocation (with or without knowledge).




Quarterly Crash Report (Q4 2022)

The Marco Island Police Department tracks vehicle crash data on a quarterly basis to understand traffic accident patterns. This data helps inform where we allocate resources for crash prevention.

The heat map to the right, shows geographic locations with the highest concentration of reported crashes (does not include driver exchanges). Areas where crashes are more densely concentrated or had injuries appear with red or orange coloring.

59 crashes were reported on Marco Island from October through December. Of those crashes:

- Most (80%) had no injuries.
- 37% occurred in parking lots, related to backing/ parking maneuvers.
- Intersections at Bald Eagle Dr and N. Collier Blvd., N. Barfield Dr. and San Marco Rd., and various locations along San Marco Rd. represented the greatest number of reported crash incidents.
- Data indicates crashes occurred most often on Mondays and Tuesdays and on weekends between 12pm and 4pm.

December Reserve / Auxiliary Program Activity Hours

Reserve and Auxiliary Police Officers are unpaid volunteers who are certified by the State of Florida to perform in the law enforcement role. These officers must meet the Department's and State of Florida's annual retraining / certification requirements. Reserve and Auxiliary personnel are required to volunteer a minimum of 16 hours per month. They perform a variety of functions for our department and community which are outlined in the chart below. Particularly they assist full-time personnel at community events or special duty functions (requests for an officer to be assigned and compensated by the outside vendor) and during significant weather events such as hurricanes or flooding. Reserve and Auxiliary Officers provide an additional uniformed police presence in neighborhoods, commercial areas, schools, parks, and beaches. Once a month Reserve and Auxiliary Officers have a staff meeting to review policy changes, attend training and address planning and logistical requirements.

Cases Closed by Detective Bureau:

Narcotics – A suspicious package containing white powder was turned into the Marco Island Police Department. The white powder was fentanyl and cocaine. Investigators identified the recipient and arrested him for the possession of a controlled substance.

Death Investigation – The Medical Examiner concluded a death in 2021 was due to natural causes.

Fraud / Asist of Agency – Investigation determined that a rental scam occurred outside the city limits. The case was referred to the appropriate agency with crime jurisdiction.

Follow-Up Reports from Patrol:

Mail Theft / Assist Other Agency – Detectives assisted US Postal Inspectors with subjects arrested for mail theft.

Vessel Burglaries – Detectives are actively investigating two vessels that were burglarized.

Vessel Burglaries – Detectives conducted a follow-up investigation for ten vessel burglaries at a local marina and two condominiums. CCSO Forensics assisted with evidence collection. The case is on-going.

Impersonation / Fraud – Fraudulent documents were filed with a government agency. Investigation is on-going.

Vehicle Burglary – A vehicle burglary case was suspended until more information becomes available.

Criminal Mischief – Detectives reviewed an allegation of criminal mischief to a vehicle; investigation is on-going.

Vehicle Burglary – A vehicle burglary report where money was taken from an unlocked vehicle was suspended until more information becomes available.

Baker Act / Risk Protection Order – Detectives filed a civil Risk Protection Order in Collier County Circuit Court for a suicidal subject.

Aggravated Assault / Ex-Felon with Firearm – Detectives processed information and met with Federal Law Enforcement partners regarding this case.

Residential Burglary – Investigation is ongoing for jewelry that was stolen from a residential condominium.

Grand Theft – Investigation is on-going for the removal and theft of an outboard boat motor.

Criminal Mischief – A criminal mischief case for a vehicle's smashed windshield was suspended until more information becomes available.

Hit and Run Crash – The investigation is on-going for a hit and run crash with property damage.

Lost Property – Investigators conducted online searches for lost property.

Self-Initiated Reports:

Sex Offender Ordinance – A sex offender who checked in with the Marco Island Police Department, was informed of the Marco Island City Ordinance and monitored for Ordinance compliance.

Suspicious Incident – A Department of Children and Family (DCF) allegation regarding an elderly person was determined to be unfounded and closed.

Accreditation Status

The Marco Island Police Department underwent the final step of our accreditation application to the Commission for Florida Law Enforcement Accreditation (CFA) on December 6th – 8th. Accreditation is a professional recognition for Police Departments; it acknowledges that departments are current and compliant with the latest law enforcement policies, procedures and practices.

Two assessors were assigned to conduct the Marco Island Police Department assessment and spent 3 days at the agency reviewing 235 standards that addressed various topics including, but not limited to: training, investigations, arrest procedures, use of technology, safety practices, property and evidence. Assessors evaluated the department's policies and proofs of compliance. They also interviewed officers and department members, and inspected our vehicles.

The results of the assessment will be brought forward to the CFA commissioners on February 23rd, 2023, to make the final determination.

December Marine Report

Boater traffic on Marco Island waterways was substantially lighter in the month of December due to several cold fronts and inclement weather. Marine officers participated in the annual Christmas boat parade escorting participants and ensuring boater safely. One of the Marco Island Police Department vessels was decorated and participated in the annual Christmas Parade.

Marine officers continued efforts to secure, remove, and relocate debris from Marco Island waterways throughout their patrols. Officers are also monitoring waterways using sonar to locate submerged obstacles marking them with temporary buoys for later removal.



December Code Enforcement:

The Code Enforcement Unit self-initiated activity showed an increase of 494% percent from the same time last year. There was a large increase in Notices of Violations issued as well, this activity is due to the increase in personnel and the addition of full-time members of the Code Enforcement team.

The violations reported to the Code unit increased this month as from the prior year, in which 83% of all code enforcement investigations resulted in the issuance of a Notice of Violation.

On November 15, 2022, a temporary exemption was granted in residential districts that allows for overnight parking on the swale until January 15, 2023.








Code Enforcement Officers (CSOs) and Command Staff organize toys collected for the Marine Corps Toys for Tots campaign

December 2022 Code Enforcement Cases

Cases opened in December 2022 were 123% greater than this time last year. Cases closed were less than this time last year due to the additional time granted to correct violations after the Hurricane.

The three most significant violations for the month of December 2022 include "Placement of Waste on Curb", "Sidewalk Encroachments", and "Parking Citations".

There was 1 valid noise violation for the month of December.



December Code Enforcement Protected Species

Burrowing owls

Community Enforcement Officers responded to 10 calls for service involving Burrowing Owls. One call was for an owl reported to be hit by a car. Upon arrival the owl was found alive: stunned by the impact and not seriously injured.

Eight calls for service were for construction vehicles parked too close to burrows on vacant lots. Upon investigation, verbal warnings were issued for the calls and offenders complied. One event involved Code Officers assisting the Environmental Planner with determining the best course of action for tall grass on a lot with multiple Burrowing Owl and Gopher Tortoise burrows. A joint recommendation was to use a weedwhacker for the lot to ensure animal safety.

Gopher Tortoises

Officers responded to 2 calls for service for Gopher Tortoises stuck in culverts. One tortoise was removed by The Audubon of Western Everglades personnel (AWE) and the other managed to dislodge himself upon arrival of the officer.

<u>December Code Enforcement Protected Species (cont'd)</u>

Shore Birds/Wading Birds

Community Enforcement Officers responded to a call for an Ibis with a hook in its wing at Mackle Park. CSOs worked with a volunteer to transport the bird to the Conservancy for treatment. Two weeks later, the recovered bird was safely released in Mackle Park.

Community Enforcement Officers, the Marco Island Fire and Rescue Department and AWE responded to an injured Osprey stuck on a roofline of a second story home. The Osprey was taken to the Conservancy for treatment. Upon its rehabilitation, the Osprey was released at the same location where he was initially retrieved.



AWE requested assistance from CSOs to investigate an injured White Pelican in the lake at Mackle Park. White Pelicans migrate from northern states during the winter, usually to salt-water venues. The Pelican was monitored and determined to be healthy.

Enforcement: Water quality

In December, Code Enforcement issued 13 violations for the MS4 ordinance (MS4 is the Municipal Separate Storm Sewer System Ordinance).

All 13 were issued for Silt Fence Violations at construction sites, that were either missing or damaged. Silt fences are required at construction sites to capture debris or silt that may wash into the canals.

Of the 13 cases, 10 were closed due to their corrective action by the compliance date. The remaining 3 did not comply and will be scheduled for January 31st Magistrate.

During the month of December, CSOs continued to pro-actively build on the code enforcement framework, addressing MS4 ordinance violations (MS4 is the Municipal Separate Storm Sewer System Ordinance). CSOs in partnership with the City's Environmental Planner, reviewed and improved management of the fertilizer ordinance, instilling greater regulation and enforcement.

The CSOs and City's Environmental Planner strengthened their approach with the fertilizer ordinance by requiring landscapers using fertilizer to register with the City. The registered individuals will be required to take training developed by the University of Florida (Green Industries Best Management). Upon successful completion of the course, individuals will be certified and awarded a registration sticker validating their compliance. The landscapers working on the Island will be tracked and inspected for working according to the fertilizer ordinance and displaying the awarded registration sticker. Starting March 1, 2023, entities conducting landscaping or fertilizing on a commercial basis that does not have the required registration will receive a Stop Work Order and a Citation. Violations can lead to revocation of the registration.

To ensure landscapers and homeowners are aware of the modified fertilizer requirements, our department created a social media campaign informing the process, released announcements to the local media, and distributed pamphlets to the landscapers.

Children engaged with officers and checked out the various public safety vehicles and vessels. A gift card was given to each child at the event.

The Grinch and Elf helpers added Christmas fun to the event. The MIPD Marine Unit kept the waterways clear and safe for the Boat Parade on December 17th.






