Events

- We notified the Marco Island Community of the passing of Lieutenant Clayton Smith after an off-duty traffic crash. Department members, family, friends, and the community extended their heartfelt condolences, thoughts and prayers to Mrs. Smith, their children, and the rest of their family. Lieutenant Smith's memorial service was held February 10, 2020.
- > A blood drive was held at MIPD in in honor of Lieutenant Smith
- > Officers were extensively involved in "The Wall That Heals" event at Veteran's Park. Specifically:
 - o Planning meetings for escort and security.

- Coordination of an escort operation that spanned six miles and required over fifty law enforcement personnel from seven agencies.
- Providing law enforcement personnel around the clock for the duration of the event to include the assignment of members during daylight hours.
- ➤ MIPD, in cooperation with the Sea Turtle Conservancy hosted Sea Turtle Lighting Workshop, open to the public at the Marco Island Police Department. Topics included: lighting laws, enforcement, and best practices of managing artificial lighting during the season.
- Coffee with a Cop was held at Hoot's Restaurant.
- In partnership with community houses of worship, Officer Gallup led an active shooter awareness class for local church members.
- > Interviews are ongoing for law enforcement ond community service officer positions.
- Narcan was used for the first time for a medical emergency on the island. The individual was successfully resuscitated. Kits were donated by the Families of Grace Foundation.
- > Officers participated in the Souper Bowl event at Mackle Park.
- > Chief Frazzano spoke at the noon Rotary meeting. The Chief met with the leadership of the YMCA.
- Officer Moreno attended the Collier Drug Free Coalition Meeting.
- As part of a joint effort, MIPD helped kick-off the Marco Island Cruise Club's dock house number project.
- Officer Miller was a judge at the pie eating contest at the United Church.
- > Chief Frazzano and Chief Murphy attended the grand opening of two local businesses.
- > Chief Frazzano attended a board meeting at the Naples Shelter for Abused Women and Children.
- > Several Department members attended the 37th Annual Marco Island Prayer Breakfast.
