Reserve / Auxiliary Program Activity Hours

Reserve and Auxiliary Police Officers are unpaid volunteers who are certified by the State of Florida to perform in the law enforcement role. These officers must meet the Department's and State of Florida's annual retraining / certification requirements. Reserve and Auxiliary personnel are required to volunteer a minimum of 16 hours per month. They perform a variety of functions for our Department and community which are outlined in the chart below. Particularly they assist full-time personnel at community events or special duty functions (requests for an officer to be assigned and compensated by the outside vendor) and during significant weather events such as hurricanes or flooding. Reserve and Auxiliary Officers provide an additional uniformed police presence in neighborhoods, commercial areas, schools, parks, and beaches. Once a month Reserve and Auxiliary Officers have a staff meeting to review policy changes, attend training and address planning and logistical requirements. The below chart signifies the logged hours that have been devoted to the particular assignment by the Reserve and Auxiliary Officers.

Detective Bureau Monthly Report February 2021

INVESTIGATIVE SUMMARY:

Self-Initiated Reports:

ASSIST OTHER AGENCY— Detective initiated a report regarding false land documents filed at the clerk of courts resulting in a transfer of the investigation to the Collier County Sheriff's Office. Report completed and delivered to CCSO. Case has been assigned to a Detective.

ASSIST OTHER AGENCY— Detective was provided with a DCF report of a child molestation with the victim located in Marco Island. Further investigation revealed that the incident occurred in the county. Report was drafted and sent to Collier County Sheriff's Office for investigation.

MISSING PERSON – During a call out for a missing teenage juvenile, a detective determined that an additional female juvenile was missing. The detective completed the report and both juveniles were subsequently located unharmed.

Cases Closed by Detective Bureau

CRIMINAL MISCHIEF – Suspect broke car window. A check of surveillance cameras resulted in no new information or witnesses so case is inactive.

VEHICLE BURGLARY – Victim's purse stolen from car. After a check of surveillance, no video was pointing toward the car. There are no witnesses and no further leads.

SHOOTING / ACCIDENTAL DISCHARGE – Male subject was retrieving a firearm when it was dropped, and an accidental discharge occurred with the bullet striking him in a leg. Non-life-threatening injury.

LEWD/LASCIVIOUS ALLEGATION – After a full investigation, the SAO rendered an opinion that there was no evidence of occurrence and case closed exceptional.

Follow-Up Reports from Patrol:

ARRESTS – Eight arrests by patrol resulted in a detective conducting follow-up investigation to include downloading of dashcam videos.

RETAIL THEFT – A suspect stole a bottle of alcohol from the Publix liquor store. A photograph of the suspects was disseminated but no identifications have been made.

DEATH INVESTIGATION – Detectives responded to the scene of a death. The Medical Examiner took jurisdiction of the decedent.
