Re: February 2024 Monthly City Council Report

In February 2024, the Marco Island Police Department set sights on increasing crime prevention within the community. While Marco Island remains to be one of the safest cities in Florida, it is important to share information on current scams and frequent types of crimes so community members can feel protected and prepared. For example, in 2023, 39.7% of total crimes were property crimes consisting of offenses including burglary, larceny and fraud. Of those property crimes 15%, were comprised of reports of Motor Vehicle Thefts. This data has driven the Department to identify crime prevention information that can help to reduce instances of property crimes.

One example of these techniques includes a social media campaign regarding the importance of ensuring vehicles are locked, electronics and personal possessions are removed from the interior, and that key fobs are taken inside when exiting a vehicle. Vehicles that are equipped with "Push to Start" ignition become targets for car thieves and leaving key fobs in the car assists in their attempts to take personal property. The MIPD's social media campaign is just one of the ways the MIPD can reach the community about important crime prevention messages.

On February 14th, 2024, Lieutenant Angel Casabona attended the Marco Island "We Are All Just Friends" club lunch to present on Situational Awareness and personal safety tips. This lunch gave the opportunity for Marco Island Newcomers and not- so- newcomers to meet others in the community and learn about Lieutenant Casabona's crime prevention tips, such as understanding your environment, knowing how to determine if something is not right, and making personal safety a priority. On the same day, Chief Frazzano also attended the "Newcomers Club" to share crime prevention and personal safety tips. The MIPD will continue to focus and promote crime prevention and community outreach to help ensure safety and security within the community.

<u>February Police Activity</u> Crime report:

In February 2024, 60 incidents were reported to the Marco Island Police Department. Total crimes against persons showed a decrease of 60%. Property crimes decreased in February 2024 by 69% due to a significant reduction in thefts and criminal mischief incidents. Miscellaneous crimes showed a decrease by 17% due to less criminal traffic incidents. In February 2024, crimes against society, such as driving under the influence incidents showed a decrease by 80%. The Marco Island Police Department had 2 arrests in February of 2024 for incidents including DUI and criminal traffic for driving with no license.



This reporting aligns with new crime data collection requirements from the Florida Department of Law Enforcement and the FBI. This announcement for crime reporting was covered in the February 2022 monthly report.

Non-criminal incidents are reports that do not have a criminal offense or are information reports. Examples include fraud cases (outside of Marco Island jurisdiction), other agency assists, lost and found items and medical assists.


2023 vs 2024 Incident Crime Trends

In February 2024, there were 48 non-criminal incidents reported. 12% of non-criminal incident reports were comprised of suspicious activities. 5% of non-criminal incident reports were due to domestic disturbances, with no crimes occurring. 7% of reports were referencing assistance to other agencies including Collier EMS, Marco Island Fire Department, and other law enforcement agencies. 37% of non-criminal incident reports are for lost and found property. The Marco Island Police Department will accept found property into our property and evidence department for safekeeping until an owner can be located.



February Traffic Patrol

In February 2024, there were 130 traffic citations and warnings issued by the Marco Island Police Department. Of the citations issued, 38% were for failure to obey traffic signs or traffic lights. 29% were due to an excess in posted speed. 24% of citations were for operating a motor vehicle with an expired registration or driver's license. Other citations issued were for violations including safety belt infractions, improper passing, and illegal U-turns. In February 2024, the Marco Island Police Department arrested 2 people for traffic violations. The 2 arrests comprised of a DUI and a criminal traffic violation for driving with no license issued. 3 licenses were seized during traffic stops due to suspensions or revocations.



Quarterly Crash Report


The Marco Island Police Department collects crash information data quarterly to help determine which conditions, participants and circumstances are more likely to result in an accident. The heat map shows the geographic location of the areas with the highest concentration of reported crashes. Areas where crashes are more densely concentrated will appear on the heat map as a "hotter" location, indicated by red or orange color. Crashes that are more severe will also appear "hotter" to reflect a more severe accident occurrence.

On March 1, 2023, the Governor approved Senate Bill 1614, which expanded public records exemptions to Crash Reports and Uniform Traffic Citations. Due to this change, crash report data became exempt from public disclosure for 60 days after the date of the crash occurrence. Q4 crash data was available for review beginning on March 01, 2024.

In Q4 (October - December 2023), 41 crashes were reported within the municipal city limits of Marco Island. This quarter saw a slight increase in crashes as compared to Q3 (July - September 2023). Of the 41 reported crashes, 83% were non- injury related and 86% were in clear weather conditions. Most accidents were between 8am and 4pm, with concentrations on Thursdays and Fridays. Data showed that most of the accidents involved drivers in their 40s (40 – 49 years old) and that male drivers were responsible for 68% of accidents. November had the most crashes in Q4. There were 3 alcohol/ impaired driver related crashes in Q4, comprising 7% of total crash events. In Q4, there were 3 instances of bicycle-related crashes.







February Reserve / Auxiliary Program Activity Hours

Reserve and Auxiliary Police Officers are unpaid volunteers who are certified by the State of Florida to perform in the law enforcement role. These officers must meet the Department's and State of Florida's annual retraining / certification requirements. Reserve and Auxiliary personnel are required to volunteer a minimum of 16 hours per month. They perform a variety of functions for our department and community which are outlined in the chart below. Once a month Reserve and Auxiliary Officers have a staff meeting to review policy changes, attend training and address planning and logistical requirements.

Suspicious Incident - Computer — Detectives took an initial report regarding an unusual email. Contact with the person who sent it revealed that the author did not intend it to be taken seriously and was not a threat.

Suspicious Incident- Patrol Officers took an incident report where a women's vehicle car door was left open. Subsequent investigation could not determine if a burglary had occurred since no items were missing.

Death Investigation- A suspicious death investigation from 2022 came to fruition when M.E. finally ruled cause of death as medical.

Death Investigation- A death investigation from 2023 was closed after M.E. ruled it as an overdose.

Fraud Impersonation Use ID W/O Consent VIC 60 YOA or Older- Patrol Officers took an initial report regarding the victim's identity being used to open lines of credit. The victim was reimbursed. Detectives contacted other agencies regarding fraudulent credit card transactions in their jurisdictions and were advised they were unable to identify a suspect or did not meet criteria threshold.

Conveyance Burglary – After a follow-up investigation with subpoenaed records, unknown suspects remain unidentified.

Battery – The State Attorney declined to prosecute on an investigation submitted for review.

Grand Theft – Two bicycles were stolen and recovered; however, no surveillance video was available as it was too dark to identify the suspect(s).

February Marine Report

Marine officers observed an increase of boater traffic this month as the weather started to improve. Officers conducted several patrols near and around Marco Island which resulted in 30 vessel stops and 24 boater assists/contacts.

Officers also conducted vessel safety and sanitation inspections of anchored vessels in Smokehouse and Factory bays. All vessels were following Coast Guard regulations.

Marine Sergeant Montgomery and Officer Bob Marvin participated in a County wide MERT training and will take part in a practical MERT operation in the following months. Due to additional training requirements in the month of February, marine patrols were limited.

Beach Report

February Events decreased 5% compared to events in February 2023.

Code Enforcement Officers' community engagement increased 55% compared to last month, whereas shorebird flushing decreased 50%. February also saw an increase for 911 calls, increasing 93%, likely due to visitors that are unaware of the non- emergency phone number.

Code Enforcement:

In February, statistics continued to reflect higher numbers in enforcing parking ordinances. This covers infractions such as parking across the sidewalk and overnight parking in the swale. City residents often contact Code Enforcement regarding blocked sidewalks which impede the pedestrian right of way. Silt fence violations remain in higher numbers this month as well as trash ordinance violations. Cases regarding right of way obstructions were also prominent in number, and generally centered around obstructing the ROW with materials or items in the swale.

February Special Magistrate Hearing

29 cases were scheduled for February 27th, 2024, Magistrate Hearing. 16% of the scheduled cases were related to illicit discharge violations. 13% of the scheduled cases were for working without a permit violation, and another 13% represented individuals contesting parking citations.



Code Enforcement Protected Species


This month there were 17 cases involving burrowing owls. All violations were due to violations of protection zones. One case led to a notice of violation, one case had eight written warnings issued, and seven cases resulted in verbal warnings. All cases resulted in voluntary compliance. 8 of the 17 cases were unfounded. There was also one case involving vegetation near a gopher tortoise burrow being removed without a permit. Code Enforcement Officer Gary Miller rescued an injured Egret from the Island Country Club. The bird was transported from the Audubon of the Western Everglades to the Naples Conservancy for treatment. There were two cases involving manatees in the month of February 2024. The first was a vessel violation for a boater going too fast in a manatee protection zone. The other involved a call for what appeared to be two injured manatees. Upon investigation, a mother and her calf were nursing in a canal and were not injured.

Code Enforcement: Water Quality

The Code Enforcement Department issued 37 Notices of MS4 violations during the month of February 2024.



This figure reflects the total number of violations and not the number of cases. This is to account for cases with multiple violations.



33 of these violations were for missing or damaged silt fences. Of the 33, 26 were closed as Compliant, and 7 remain open and are scheduled for March/April Magistrate Hearing.

The remaining 4 violations were issued for Illicit Discharge. 2 were closed as complaint, while 2 remain open and are scheduled for March/April Magistrate Hearing.
