Significant Events

April 1 Chief Schettino and Sgt. Hood speak to the Marco Island Yacht Club. MIPD's Marine unit and boating safety were discussed.

April 5 MIPD Patrol and Marine unit provided security and support at the Easter Sunday Sunrise Service. Record attendance of 10,000.

April 17 MIPD, CCSO Aviation & FWC responded to a boat collision with a channel marker near Keewaydin Island.

April 18 MIPD provided security and volunteer support for the American Cancer Society Relay for Life event at Mackle Park.

April 21 Chief Schettino speaks at a San Marco Knights of Columbus meeting.

April 22 Three MIPD Officers participated in the Muscular Dystrophy Association Lock-Up fund-raising event at the Esplanade.

April 25 Officer Bill Miller heads up Operation Medicine Cabinet at MIPD headquarters.

April 26 Swimmer at Residents' Beach sustains minor injuries from a shark bite.

Investigations

- **Investigations/Follow-Up Investigations:**
 - Detectives conducted eighty-nine (89) follow-up investigations for the month.
- **Significant Incidents/Investigations:**
 - MIPD Officers assisted CCSO with the arrest of an individual suspected of selling narcotics. Subject was transported to Naples Jail Center.
 - MIPD responded to a call in reference to a disorderly person. Subject refused to pay his bar tab. Patron was arrested for petit theft and transported to Naples Jail Center.
 - MIPD Officers responded to Lilac Avenue on a report of an individual attempting to break into a residence. Subject was arrested and charged with burglary. Subject was transported to Naples Jail Center.

- MIPD Officers assisted the United States Capitol Police on a traffic stop in reference to a suspicious vehicle.
- MIPD Officers responded to a business located on South Collier Blvd. in reference to domestic violence. Suspect fled scene. Detectives applied to the State Attorney's Office for a warrant for the suspect's arrest.
- MIPD Officers responded to South Collier Blvd. in reference to a report of possible child endangerment. Investigation revealed a 6-year-old child was left alone for several hours. Father was located and was charged with child endangerment. Subject was transported to Naples Jail Center. Child's mother was contacted and took possession of the child.
- MIPD Officers assisted CCSO in reference to a boater under the influence at the south end of Lamplighter Court. Suspect was operating a boat while intoxicated and had difficulty navigating the canals. Subject was transported to Naples Jail Center.
- MIPD Officers responded to North Collier Blvd. in reference to a disturbance in progress. MIPD Officers conducted an investigation at the scene and arrested one subject for two counts of battery. Subject was transported to Naples Jail Center.
- MIPD Officers responded to Angler's Cove Condos in reference to a dispute. Further investigation by the Officers revealed that a subject was in possession of narcotic paraphernalia. Subject was issued a notice to appear.
- MIPD Officers responded to a South Collier Blvd. business to take a report in reference to counterfeit money that was received. The money was confiscated and turned over to the U.S. Secret Service, along with Police Reports and video surveillance footage. The Secret Service is conducting a follow-up investigation.
- MIPD Officers responded to a business on North Collier Blvd. in reference to a person who presented a fraudulent prescription to be filled. Subject did appear to pick up the prescription and MIPD was alerted. Subject was arrested in the parking lot and transported to Naples Jail Center.
- MIPD Officers conducted a traffic stop on North Collier Blvd. Operator was arrested and charged with DUI. Subject was transported to Naples Jail Center.
- MIPD Officers responded to Residents' Beach in reference to a swimmer who was bitten by a shark. Swimmer was transported to hospital.
- MIPD Officers conducted a traffic stop on South Collier Blvd. A vehicle struck the guardrail prior to traffic stop. Operator was charged with DUI and transported to Naples Jail Center.
- **Investigations Opened by Detectives**
 - MIPD Detectives initiated two investigations.
- **Aid/Assist Other Agencies:**
 - MIPD Detectives provided three aid/agency assists for the month.
- **Warrant Checks:**
 - MIPD Detectives conducted one hundred seventy three (173) warrant checks to determine if any of the active warrants were applicable to our jurisdiction.

- **Warrant Arrests:**
 - **One (1)**
 - MIPD Officers conducted a traffic stop in which the driver was found to have an active warrant from CCSO. Suspect was arrested and transported to Naples Jail Center. Citation was issued for driving while license suspended.
- **Department of Children and Families (DCF) Referrals/Follow-ups:**
 - MIPD Detectives conducted six (6) follow-ups for DCF this period.
- **Subpoena Requests:**
 - MIPD Detectives did not submit any subpoena requests to the State Attorney’s Office for review.
- **Warrant Requests:**
 - MIPD Detectives submitted three (3) warrant requests to the State Attorney’s Office for review. The warrants are still pending at this time.
- **Crime Bulletins:**
 - Detectives created and disseminated one (1) bulletin regarding criminal activity or suspect information.
- **Crime Stoppers Tips:**
 - There were no crime stopper tips for the month of April.

Property & Evidence

MIPD donated eight abandoned bicycles to the Marco Island Charter Middle School for educational use in April. The bicycles had been turned over to MIPD and held by the Property and Evidence Dept. section until cleared for disposal.

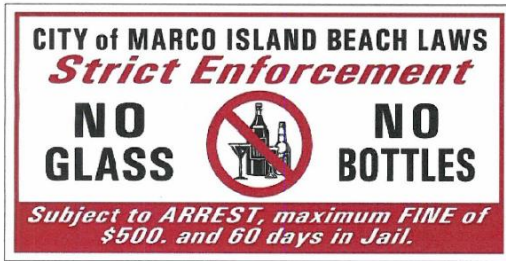
Operation Medicine Cabinet collected 114 pounds of prescription and over-the-counter medication thus far in 2015. These items will be incinerated at a later date.

The Property and Evidence Dept. took in 54 items in April, bringing the 2015 total intake of evidence and found property to 205. Additionally, 44 items were returned to claimants and 36 items were processed for disposal. This brings the Property and Evidence Dept. total inventory to 3,719 items.

Beach Patrol

Forty-seven unique events included 23 Police or Community Service Officer initiated patrols on the beach or water immediately adjacent to the beach, 14 foot patrols, 4 traffic/vessel stops, one medical issue and five 911 calls.

The following are new graphics that will be deployed at beach access points, on social media and on MIPD's website. This is an initiative to obtain increased voluntary compliance of City Ordinances related to beach conduct. The Department will place these signs periodically at beach access points to increase awareness and notify the public of enforcement.



Community Service Officers / Code Enforcement

The Department's seven CSO's conducted nearly 200 hours of intensive community patrols of beach, parks, schools, commercial and residential areas. They assisted Law Enforcement personnel with several vehicle crash investigations, fingerprinting on Tuesdays and Thursdays, issuance of RV parking permits, and handled several wildlife rescue calls.

In April, Community Service and Law Enforcement personnel attended to 95 CAD (Dispatched) events classified as "Code Complaints" at 83 unique addresses. CAD events at repeat addresses included follow-up investigations.

As noted in the table below, there were 276 events. The difference, 181 events, represents primarily self-initiated calls versus complaints generated from the public:

The Department received 30 noise-related complaints in April, with only two occurring during CSO working hours. The Code Enforcement Unit sent 13 Courtesy Notices to owners of locations with verified first-time noise violations.
