Re: January 2016 Monthly City Council Report

On November 20, 2014, I informed City Council that a restructuring of the Police Department was warranted. At that time, I eliminated one Assistant Chief and two Lieutenant positions.

After 18 months as Chief of Police, I believe that a realignment of the Department's resources is necessary. I'm reclassifying a Police Officer position to Captain to establish a clear chain of command and provide increased supervision of staff. This position will be responsible for overseeing all Police Patrol Operations. Funding for this position will be covered under our current budget.

The existing Administrative Captain will focus on overseeing the Code Enforcement Unit, Property & Evidence/Quartermaster, Buildings & Facilities, Vehicle Fleet Management/Maintenance, Department Budget and Public Information.

Capital Expenditures

The Police Department is purchasing a new patrol vessel to soon replace our two aging Honda waverunners. While our current waverunner patrols/operations require two Marine Officers, the new vessel will be manned by a single Marine Officer. This purchase has already been subsidized by transferring an underutilized F250 Ford pickup truck from the Police Dept. to Public Works, which yielded \$28,000.

Construction Site Code Enforcement

Now that season is upon us, Building Services is currently addressing a large number of complaints regarding adjacent construction sites.

With the significant amount of construction occurring on the Island, including two high-rise projects with aggressive completion schedules, Joe Berko and I have reached an agreement that the Building Services Department will augment the Police Department's Code Compliance Unit with a full-time staff member to perform construction site maintenance inspections.

This CSO will address and mediate all construction site compliance issue and ensure that all sites maintain an acceptable level of cleanliness and safety. This proposed agreement was developed through a joint partnership between the Building Services Department and the Police Department's Code Compliance Unit. We are confident that the City of Marco Island will greatly benefit from this proactive approach.

The Department's part-time CSO's conducted community patrols of the schools, commercial and residential areas, as well as occasional beach and parks patrols. In January, Community Service and Law Enforcement personnel attended to 202 CAD (Dispatched) events classified as "Code Complaints" at 162 unique addresses. It is important to note that these calls do not include parking or noise related events which are classified as separate categories. In the last six months of 2015, Code violation calls averaged approximately 220 events per month and represented numerically, the single largest category of dispatched versus solely self-initiated calls.

Community Service Officers who attend to quality of life or Code Enforcement calls are finding it increasingly difficult to proactively patrol the beach or conduct parking enforcement due to the ever increasing amount of Code Enforcement related calls, as well as their law enforcement support duties. We currently have the following hours covered by Community Service Officers:
