Re:	January 2017 Monthly City Council Report

The Department investigated 96 index crimes in 2016. Index crimes include violent crimes of murder and nonnegligent manslaughter, forcible rape, robbery and aggravated assault; and the property crimes of burglary, larceny-theft and motor vehicle theft. This represents the lowest number of index crimes reported since the Department's inception, which represents a 76% reduction in crime since 2000.

More specifically, when comparing 2015 to 2016, violent crimes declined 83.5%, property crimes 31.7%, simple assaults 24%, aggravated assaults 87.5%, and total domestic violence-related offenses 37.9%. In addition, arrests for all offenses combined increased 27.5% in 2016.

Also worth noting, all MIPD Officers recently took part in active shooter training scenarios. This type of ongoing specialized training is critical to ensuring the safety of the island's residents and visitors.
