The popular Marco Island Farmer's Market was in full operation this month. This year, the Farmer's Market relocated to Mackle Park, a temporary home while Veteran's Park remains under construction. To identify potential issues that may occur at the new location, Marco Island Police Department and the Parks and Recreation staff partnered to create a trial run of the Market at Mackle Park end of its 2021 season.

At the start of the new season, Marco Island Police Department pre-emptively doubled its Police presence at the event and key intersections to help with congestion and parking issues. Code Officers were assigned to support the community's access, pedestrian safety and parking compliance. Given the added complexities of roadway construction located nearby the market, the Marco Island Police are continuously seeking solutions to manage the traffic flow and parking experience with the community.

After 5 and a half years of service, Community Service Officer John Kovacs retired from the department on January 19th. John played a strong role at helping our community achieve a high quality of life through his work as a Community Service Officer. John was known for his friendliness and approachability, instilling a small-town feel that Marco Island is known for. John will continue with the Code Enforcement Department as a reserve member when he's not out enjoying his well-deserved retirement. We wish him all the best.




Note: Non-Criminal incidents are reports that do not have a criminal offense or are information reports. Examples include fraud cases (outside of Marco Island jurisdiction), other agency assists, lost, and found items and medical assists.

2022 vs 2021 Incident Trends

52 non-criminal incidents were reported in January. Lost and found items continued to represent the largest number of non-criminal events, accounting for 25% of reported incidents. Fraud that occurred outside Marco Island's jurisdiction and medical assists represented the second and third highest reported incidents at 14% and 10%, respectively. Many of the fraud cases categorized as "information reports" were because the crime location was in cyberspace and needs to be investigated by another Law Enforcement agency other than Marco Island Police. Our police department helps fraud victims by informing them of resources available to them and documenting the initial report needed for the respective investigative agency.



Traffic patrol



Over 330 traffic warnings and citations were issued in January. Speed related infractions continue to represent the greatest number of written infractions: 60% of total issued traffic citations.

11 driver's licenses and 4 license plates were confiscated from motorists operating a vehicle with a suspended or canceled license. 9 drivers were arrested for knowingly operating a vehicle with a suspended license; they were transported to the Naples Jail Center.

January Detective Bureau Monthly Report

Investigative Summary:

Investigative cases for our detective bureau increased this month versus the same time period last year due to more sex offense cases and thefts reported.

This month's highlight for the detective bureau involved arresting two suspects through a collaborative effort with the Collier County Sherriff's Office. Several bicycles were recently stolen from Marco Island. The Marco Island Detective Bureau released a bulletin to surrounding law enforcement agencies notifying them of the missing bikes. At a traffic stop In Naples, a Collier County Deputy discovered high-end bicycles located in a vehicle. The Collier County Sheriff's Office contacted Marco Island detectives after seeing the bulletin, to investigate if the bicycles were ones stolen from the Island. The suspect voluntarily removed the bicycles from his vehicle for inspection. Marco Island detectives confirmed the bicycles were the same ones reported stolen from Marco Island. The suspects were arrested and taken to Naples Jail Center.

Cases Closed by Detective Bureau:

Death Investigation – A death reported to and handled by patrol officers was closed after the Medical Examiner ruled the death was from natural causes.

Harassment – The Detective Bureau was called in to assist patrol officers in evaluating a threat made to a local business. The person making the threats was interviewed and deemed not to be a credible threat at this time. The reporter wanted this incident documented.

Battery – A photograph of a suspect who battered a restaurant patron was disseminated through various platforms, however no leads developed. The case was suspended pending a tip.

Death Investigation – A death investigation was closed after the Medical Examiner ruled it a suicide.

Hit and Run – A report of a vehicle crashing into a gate and leaving the scene of the crash. The suspect was identified and agreed to pay for the damages. The victim declined prosecution.

Battery – A road rage incident led to one subject biting another. The victim declined prosecution.

Grand Theft – A wedding ring was stolen from a residence. Suspects were identified but sufficient probable cause for an arrest has not yet been established.

Follow-Up Reports from Patrol:

Sex Crime – A report of past child molestation was received; the investigation is ongoing.

Suspicious Incident – Mail delivered to a resident on Marco Island contained a missing credit card. This mail was part of another incident, a stolen Mail bag that was recovered in Collier County. Investigation is ongoing with the US Postal Service.

Suspicious Incident – A report of an attempt at vacation rental fraud by an out of state victim. Victim located the listing through a website. Investigation is ongoing.

Sex Crime - A report of a past child molestation was received. The investigation is ongoing

Sex Crime – A report was made by a woman who alleged she was sexually battered by her boyfriend 3 months prior.

String of Thefts – Two subjects have been arrested and charged with the theft of several bicycles at a condominium complex. Both subjects are suspected of additional thefts; charges are pending.

Sex Crime – A male exposed himself to a female in a parking lot. The investigation is ongoing.

Fraud – The reporter was defrauded over \$30,000 by means of impersonation. The investigation is ongoing.

Self-Initiated Reports:

Operation Medicine Cabinet – A report was initiated on two different dates after prescription drugs were removed from the public drop-off cabinet. Prescription drugs were packaged and placed into MIPD Property and Evidence pending proper destruction.

Fraud – A report of a vacation rental fraud. Victim booked through a website. Investigation is ongoing.

Cyber Tips – Two cyber tips were received this month regarding internet crimes against children.

January Marine Report

Marco Island Police Department Marine Officers observed a decrease in boater traffic on Marco Island waterways due to several cold fronts and high winds during the month of January. Officers took advantage of the inclement weather to conduct vessel maintenance to our fleet.

Officers Josh Ferris and Bob Marvin conducted vessel safety and sanitation inspections of anchored vessels in Smokehouse and Factory bays. All vessels were following Coast Guard regulations.

An at-risk sailboat located in Factory Bay was investigated in partnership by Marco Island Police Department's Marine Unit and Florida Fish and Wildlife (FWC). The derelict vessel, moored for the past three months in Factory Bay, degraded and began taking on water. Until the owner of the vessel was located, the Marco Island marine unit periodically checked on the vessel and pumped water from the sailboat to prevent sinking. The owner of the 38ft. sailboat was located and issued a summons along with two misdemeanor citations. A Notice of Violation was also posted on the vessel, giving the owner 21 days to comply.

One marine emergency (MERT) occurred this month. Officer Bob Marvin responded to a marine emergency on January 18th. A paddle boarder was caught in a strong current on the Marco River and unable to make it back to shore. Officer Marvin made contact with the paddle boarder and safely returned him to shore.



January New Hires

January Training

Marco Island Police Department recently acquired Inveris, an interactive computer program that trains officers how to manage and deescalate high tension situations. This tool supplements Marco Island's law enforcement training curriculum. Through role playing, this scenario-based program places officers in simulated events that are emotionally driven and unpredictable. Officers must quickly assess and respond in real time with voice commands. This training is designed to prepare our officers to effectively navigate potentially lifethreatening events through greater incident frequency and exposure to a variety of scenarios.



January Reserve / Auxiliary Program Activity Hours

Reserve and Auxiliary Police Officers are unpaid volunteers who are certified by the State of Florida to perform in the law enforcement role. These officers must meet the Department's and State of Florida's

certification requirements.

Reserve and Auxiliary personnel are required to volunteer a minimum of 16 hours per month. They perform a variety of functions for our department and community which are outlined in the chart below. Particularly they assist full-time personnel at community events or special duty functions (requests for an officer to be assigned and compensated by the outside vendor) and during significant weather events such as hurricanes or flooding. Reserve and Auxiliary Officers provide an additional uniformed police presence in neighborhoods, commercial areas, schools, parks, and beaches. Once a month Reserve and Auxiliary Officers have a staff meeting to review policy changes, attend training and address planning and logistical requirements.



January Code Enforcement:

Community Service Officers (CSOs) answered approximately 500 calls for service during January 2022. Continued compliance with removing waste receptables on curb coupled with the holiday moratorium of parking on swales generated 30% less events this year verses last. On January 15th, 2022, the City of Marco Island ended the moratorium of the overnight swale parking.

The majority of Code Enforcement efforts (78%) were self-initiated. There was a significant increase in 911 Code calls this month due to misdials on the beach.

40% of code enforcement investigations resulted in issuance of a Notice of Violation and is similar to the amount issued last year at this time (49%). The most significant Code Enforcement violations for this month include: parking citations/warnings, placement of waste on curb, and parking of boats or boat trailers in visible locations.



Code Enforcement Cases

January 2022 Code Enforcement Cases

Cases opened in January 2022 were 36% less than this time last year. This decrease is likely due to inclement weather on the Island. The top three violations for the month of January 2022 include: City Code Ordinance 50-37 "Prohibited Parking", 18-38(8) "Placement of Waste on Curb", and 30-1007c "Boat and Boat Trailer Parking". 

Code Enforcement Protected Species Update

Sea turtles: Community Service Officers have been in contact with the Sea Turtle Conservancy. They will be partnering with the Conservancy to set up a workshop for establishing best practices with Sea Turtle provisioning in early May.

Burrowing Owls: The Audubon of the Western Everglades monitored 7 sites on the Island with chicks. These hatchlings came earlier versus other seasons. The biologist for the Audubon is investigating the chicks' accelerated timeline.

In January, Marco Island CSOs received 10 calls for service regarding Burrowing Owls. 7 of the calls were regarding vehicles parked too closely to the burrows: 3 received citations and 4 warnings. No owls were injured.

Beach Report

Community Service Officers (CSO) logged slightly less beach patrol hours and events this year versus last January. The decreased activity is due to managing traffic flow and parking at the Farmer's Market. In preparation for Spring beach visitors, Community Service Officers prioritized beach sign inspections. These signs inform both residents and guests about our City's beach codes and are an integral tool for educating beach visitors about code compliance. Community Service Officers (CSO's) also played an active role for keeping our beaches safe by picking up debris that washed ashore from the severe weather system that impacted our area.








Throughout January, the Marco Island Police Department continued its informational campaign across all social media channels to deter common city ordinance violations. Messages including swale parking, fireworks, dumping, and property maintenance were pushed out to our social media community members. MIPD also reminded residents of our "Operation Medicine Cabinet" initiative that encourages redemption of unused and expired medicines. In 2021, this program safely disposed of over 600 pounds of medications, keeping our community and waterways safe. MIPD also informed residents that the City of Marco Island successfully renewed its StormReady® Community preparedness program with the National Weather Service, through 2024. StormReady® provides communities with clear-cut advice from the National Weather Service Office, state and local emergency managers, and the media.

Two "MIPD Spotlight" posts were published, detailing the impressive biographies of Officers Rosario and Prigge. Both posts received high levels of engagement and numerous complementary remarks!
