- All hands were on deck for the week of July 4th. In addition to regular shifts, our officers were patrolling the beach, with all marine vehicles and vessels were deployed. Our 300+ staff and volunteers' hours were dedicated to ensuring a safe and enjoyable holiday. This is the first year since 1998 with no fireworks noise complaints on July 4th.

Detective Bureau Monthly Report July 2019

INVESTIGATIONS:

SIGNIFICANT CASE INFORMATION/INCIDENTS:

Grand Theft 4000 Royal Marco Way – Unknown suspect(s) stole \$1,000.00 worth of tools from a storage room in the garage of apartment complex. No leads and no suspects. *Inactive*

Grand Theft Auto North Collier Blvd/Fairlawn Ct – An Officer conducted a routine traffic stop and discovered the vehicle was stolen. An investigation was conducted, and the driver was charged with stealing the vehicle out of Naples. *Cleared by arrest*

Grand Theft Auto 717 Bald Eagle Drive – A rental vehicle was never returned, and the company reported it stolen. A suspect was developed, and the investigation is ongoing. *Open*

Stolen Credit Card 1089 North Collier Blvd – A woman inadvertently left her credit/debit card in the chip reader at a cash register after completing a transaction. The next customer took the credit/debit card and left the store. Subsequently, the debit/credit was fraudulently used in Naples accruing \$880.00 in charges. A suspect has been developed and the case is being worked with the Collier County Sheriff's Office. *Open*

Loitering and Prowling 486 Tallwood St – Officers responded to a male who was walking through residents' yards and trying homes' doorknobs and car doors. An investigation was conducted, and the officers arrested the male for loitering and prowling. *Cleared by arrest*

Sex Offender Ordinance Violation 600 South Collier Blvd – Command Staff learned of a sex offender staying at the Hilton Hotel. Detectives followed up with the sex offender and the hotel of the violation. The sex offender was documented and then subsequently vacated Marco Island. *Closed*

Possession of Controlled Substance with Intent to Sell 1361 Andalusia Ter – An Officer was patrolling Mackle Park and noticed an occupied suspicious vehicle. A search to the vehicle was conducted and over 400 grams of marijuana was seized, along with scale, packing for sale, a firearm, and approximately \$3,500.00 in cash. The occupant was arrested and transported to the Naples Jail Center. *Cleared by Arrest*


Total Beach Patrol Hours = 254 Hours Total Beach Patrol Events = 131 events:


A July 4th week operational plan created for the July 4th holiday. Highlights included:

- **Road Patrol Operations** 5 officers were assigned to Day Shift (6am 6pm) and 5 officers were assigned to evening shift (6pm 6 am), totaling **120 Hours**.
- Residents Beach Fireworks Detail- 7 full-time, auxiliary officers and command staff members ensured safety and security at Residents Beach. 73 Hours+.
- Marine Patrol Operations- In addition to regular marine duties, 3 marine officers maintained a safety perimeter around the fireworks barge, using the MIPD Ranger, Donzi, and Quadski. Total staff-hours dedicated, **38.5**.
- **Community Service Operations** 6 Community Service Officers performed calls for service, oversaw the Resident's Beach, all public beach access entrances, and Eagle Preserve areas. They also provided periodic breaks to fellow officers. When not at Residents Beach or Collier Blvd. crosswalk, they assisted with beach and eagle sanctuary patrol: **66 Hours**.
- **Foundation Volunteers** 4 Police Foundation volunteers assisted with the Residents Beach entrance contributing a total of **16 hours**.
