Re: July 2022 Monthly City Council Report

The Marco Island Police Department and Community Service Officers successfully managed over 1,600 events during the July 4 weekend (July 1 – July 4). In preparation for the 4th of July celebrations, MIPD proactively ran a series of social media posts that promoted awareness behind the Island's fireworks ordinance. Both Police and Community Service Officers had a heightened presence on the beach and water to ensure the community celebrated the holiday safely. Marco Island Police Department's own Captain America joined our officers with a beach parade and helped educate beach goers in a fun way about the City's firework and beach ordinances.



Throughout the year, our officers perform scenario-based training, which includes exercises addressing targeted violence. Prior to school opening, our officers conduct on-site, incident-based operations for active shooter situations in each of the Island's three schools. Exercises are designed to prepare our officers for quick and confident responses to an incident. Officers execute tactics they learned from previous training sessions, such as team coordination with each other and emergency medical services (Marco Island Fire and Rescue), communication and movement, rapid clearing techniques and reunifications processes. Upon completion of each exercise, Command Staff and Officers meet to apply lessons learned and operational recommendations. Members of the department also collaborate with school administrators for building security considerations and safety protocols.

In addition to safety exercises, officers also attend the annual FASRO conference (Florida Association of School Resource Officer) that occurs in July. This conference covers legal updates, safety measures and best practices for law enforcement with schools. FASRO is the largest school policing organization in the country with over 1000 members. This year, additional attention was dedicated to topics concerning preparedness and response to violent behavior with special guest speakers from the Boston Police Department and the FBI.

July Police Activity

Crime report:

91 incident reports were written in the month of June. The number of criminal offenses decreased 25% versus the same time period last year; this is primarily due to a decrease in the amount of criminal traffic activity. In July 2022, the Marco Island Police Department arrested 12 individuals for offenses including domestic violence, theft, criminal mischief, and criminal traffic (individuals operating a vehicle without a license with knowledge).






Non-criminal incidents are reports that do not have a criminal offense or are information reports. Examples include fraud cases (outside of Marco Island jurisdiction), other agency assists, lost and found items and medical assists.

2022 vs 2021 Incident Trends

58 non-criminal incidents were reported in July. The majority of reports were for suspicious non- criminal incidents (29%). Examples of suspicious incidents include the following but not limited to: unidentified trespassers, unknown persons attempting to commit fraud and suspicious phone calls. Lost and found property reports were the second largest number of non-criminal reports taken (22%) in July.







Traffic patrol

305 traffic citations and warnings were issued in July.

Most citations were issued for failure to obey traffic control devices (stop signs, red lights, etc.), speeding, and driving with an expired registration (most were non-criminal due to the driver not having knowledge the registration expired).

12 driver's licenses and 3 license plates were confiscated from motorists operating a vehicle with a suspended or cancelled license. 1 motorist was transported to the Naples Jail Center for driving while under the influence.

From July 18th- 23rd, the Marco Island Police Department participated in Operation Southern Slowdown, a multi- state collaboration enacted to reduce traffic fatalities and speed- related traffic deaths.

Cases Closed by Detective Bureau:

Missing Juvenile – Detectives followed up on a missing juvenile that led the investigation to New Jersey. Utilizing cellphone data and working with law enforcement in New Jersey, the juvenile was located and deemed safe.

Grand Theft Auto – A grand theft auto occurred on the south end of the City. Circumstances were consistent with a statewide investigation that is being conducted by FDLE. The case was referred to FDLE.

Follow-Up Reports from Patrol:

Vessel Burglaries – A series of vessel burglaries occurred, and GPS navigational systems stolen. Investigation is ongoing. **Grand Theft** – Last month, an ATM debit card theft was reported. The detective bureau developed a suspect, and the investigation is ongoing.

Fraud – A victim reported a \$25,000 wiring scam. The investigation is ongoing.

Suspicious Incident – A report was made regarding some irregular documents being filed for a permit. The investigation revealed no wrongdoing, and the matter was determined to be a civil issue.

Fleeing and Eluding – A motorcyclist fled from an officer attempting to conduct a traffic stop. The case was suspended until more leads are developed.

Self-Initiated Reports:

Sex Offender Ordinance – The police department made contact with a sex offender who was temporarily staying in the community. He was photographed, documented, and issued the city's sex offender residency ordinance.

Cybertips – The detective bureau received two Cybertips from the National Center of Missing and Exploited Children. Detectives are investigating.

Threats/Harassment – A complaint was filed for harassment. The investigation revealed no crimes were committed. The case was documented should future proceedings occur.

Sex Crime – A sex crime was referred to the police department from an out of state agency. The case is open and is currently being investigated.

Election Complaint – A complaint was made for voter intimidation. The case was referred to FDLE for investigation.

July Reserve / Auxiliary Program Activity Hours

Reserve and Auxiliary Police Officers are unpaid volunteers who are certified by the State of Florida to perform in the law enforcement role. These officers must meet the Department's and State of Florida's annual retraining / certification requirements. Reserve and Auxiliary personnel are required to volunteer a minimum of 16 hours per month. They perform a variety of functions for our department and community which are outlined in the chart below. Particularly they assist full-time personnel at community events or special duty functions (requests for an officer to be assigned and compensated by the outside vendor) and during significant weather events such as hurricanes or flooding. Reserve and Auxiliary Officers provide an additional uniformed police presence in neighborhoods, commercial areas, schools, parks, and beaches. Once a month Reserve and Auxiliary Officers have a staff meeting to review policy changes, attend training and address planning and logistical requirements.

July Training and Conferences

- Offficers Schmid and Carey attended Marijuana Impaired Driving Detection training.

- All shifts and School Resource Officers participated in Active Shooter training at our local schools.
- Sergeant Haueter attended The Florida Association of School Resource Officers (FASRO) conference. The FASRO conference offers comprehensive training for school-based police and covers a variety of topics which includes but not limited to, crime prevention, safety measures, counseling, education techniques.

July Marine Report

Marine incidents increased 45% across July versus the previous month. Marine officers observed an increase in boater traffic on Marco Island waterways and officers increased patrol efforts over the 4th of July holiday. All vessels were deployed during the holiday weekend including the 32' Contender, 24' Ranger and personal watercrafts (jet skis).

From July 2 to July 4, officers attended to over 175 Marine incidents; the span of this 3-day period represented almost 30% of July's total incidents. Large numbers of vessels were on the water during the holiday, and many returned to observe the fireworks show in the evening. Marine officers maintained a safety perimeter around the fireworks barge. They also patrolled and monitored vessel traffic that night at both the North and South passes.

Few transient vessels were anchored in Smoke House and Factory Bays during the month of July. Officers conducted vessel safety and sanitation inspections for both bays' vessels; all followed Coast Guard regulations.

Marine unit officers responded to two marine emergency (MERT) calls in July. On Tuesday, July 12, Officer Garner responded to a report of a sinking kayak with two people in the water near Caxambas Pass. A good Samaritan on a boat towed the kayak and the two paddlers to Dickman's Point sandbar. When Officer Garner arrived on scene, he was assisted by the Florida Adventures charter boat and transported the two kayakers back to safety. Neither kayaker required medical attention. Follow-up investigation determined that the kayak took on water and was no longer buoyant.


Marco Island Police Department Marine Unit patrolling water safety

On Friday, July 15, Officer Garner responded to a report of a 24-

foot vessel with four people aboard, taking on water. The vessel was located 10 miles west of the Marco River in the Gulf of Mexico. The weather at the time of the response included thunderstorms with sea swells in the range of 4-6' and higher. Due to the size of the swells, the vessel in distress was unable to return east towards Marco Island. The joint effort to rescue the vessel and four persons aboard included Marco Island Fire Department Boat 50, Collier County Marine Units and Collier County Aviation Unit. Two passengers were transferred to Boat 50 and the other two passengers remained on their vessel and followed responding Marine Units back to Marco Island. Everyone arrived safely and no medical attention was required. Once back in the Marco River, the subject vessel was able to return back to their home port in Naples without further incident.

July Code Enforcement:


Community Service Officer (CSO) events increased 17% compared to the same time last year. 69% of all Code Enforcement investigations resulted in an issued Notice of Violation.





July 2022 Code Enforcement Cases

274 cases were opened in July, 23% more in comparison to the same time last year. The largest number of code violations for the month of July were for overgrown weeds, trash on swale, and right of way obstructions; a similar trend to June's issued violations. 1 valid noise violation occurred for the month of July.


July 2022, Special Magistrate Hearing Cases

26 cases with 29 violations were reviewed during the July 2022 Magistrate Hearing (some cases consisted of multiple violations).

Over half of the cases (14 cases) were for overgrown weeds and 27% were for erosion control violations.

4 cases were dismissed because the owner either complied on the final day of deadline or the property owner was not definitive (due to the property sale date) when the violation occurred. 1 case was continued for August Magistrate.

Code Enforcement: Water quality

Code Enforcement issued 18 MS4 violations in July: 13 silt fence violations, 2 illicit discharge violations and 3 storm water violations for construction.

Education is the focus for MS4 of violations. For repeat offenders however, cases are scheduled for Magistrate.

Of the 18 cases issued throughout July, 7 were compliant by the specified date. 11 cases are scheduled for the August 30th Magistrate.

Fertilizer application is not allowed during July because Southwest Florida is in the middle of the rainy season. There were no observed fertilizer application violations during this month.

Code Enforcement Protected Species Update

Burrowing Owls: The Burrowing Owl breeding season runs from February 15 through July 10. During this period, the buffer zone was 33 feet around the entrance of the Owl burrow. Now that the breeding season has ended, the buffer zone will return to 10 ft around the entrance of the burrow.

For July, there were 4 calls for service for owl burrows. Of the 4 calls, 2 were unfounded and 2 Notice of Violations were written for construction sites not meeting protection zone requirements. No owls were harmed with the valid violations.

Gopher Tortoises: 1 call was investigated this month regarding a tortoise seen in the area of 400 S. Barfield; Community Service Officers could not locate the tortoise or burrow.

Community Service Officers followed-up on a silt fence code violation and discovered several tortoise burrows were buried due to the damaged silt fence. The Officer spoke with the site crew and advised them of the protected species ordinance. They were further notified that the silt fence needed to be immediately repaired. CSOs performed an additional follow-up of this location and determined that crews took no corrective action with the protective fencing around the burrows. A Notice of Violation for the damaged silt fence and protection zone establishment was issued. The Florida Fish and Wildlife Conservation Commission (FWC) and Audubon Society were notified and responded for inspection. 4 burrows were uncovered; luckily, no tortoises were harmed.

Sea Turtles: Sea Turtle nesting season runs from June 1st through October 31st.

As of July 31, Marco Island was monitored as having 101 nests, 202 false crawls and 23 hatched nests. At the same time last year there were 96 nests, 159 false crawls and 21 hatched nests.

In the evening of July 20, a nest near South Beach hatched. The hatchlings became disoriented and headed in a direction opposite from the water. Fortunately, many of the hatchlings were saved due to interventions from our Marco Island Police Officers and staff from Collier County Parks & Recreation. The hatchlings were released in the correct direction.

Our Community Service Officers remained busy this month ensuring beach holes were filled and lighting dimmed to protect the hatchlings. 3 citations were issued this month for Sea Turtle Lighting Violations.

Education and prevention campaigns on sea turtle nesting season received a lot of attention, primarily focusing on sand sculptures and lighting.






We never pass up opportunities to spend time with our Marco students.
