Re: June 2021 Monthly City Council Report

June marked the beginning of the 2021 Atlantic Hurricane Season and as such, the City conducted a Hurricane Planning Town Hall meeting. We continued our community outreach by inviting the public to our new vessel commissioning, and events such as Coloring with a Cop and Coffee with a Cop. Our Coloring with a Cop campaign involved the kids playing games, getting fingerprinted, touring our police equipment and even a coloring contest. Coffee with a Cop returned and was hosted by Empire Bagel Factory, where the community got to know their local law enforcement. We partnered with the Marco Island Fire Rescue Department and held the Police and Fire Youth Academy. Led by officers Paul Ashby and George Guyer, students interacted with both fire and police personnel for a week long training in which they were able to learn some of the responsibilities of each profession. Reserve / Auxiliary Program Activity Hours

Reserve and Auxiliary Police Officers are unpaid volunteers who are certified by the State of Florida to perform in the law enforcement role. These officers must meet the Department's and State of Florida's annual retraining / certification requirements. Reserve and Auxiliary personnel are required to volunteer a minimum of 16 hours per month. They perform a variety of functions for our Department and community which are outlined in the chart below. Particularly they assist full-time personnel at community events or special duty functions (requests for an officer to be assigned and compensated by the outside vendor) and during significant weather events such as hurricanes or flooding. Reserve and Auxiliary Officers provide an additional uniformed police presence in neighborhoods, commercial areas, schools, parks, and beaches. Once a month Reserve and Auxiliary Officers have a staff meeting to review policy changes, attend training and address planning and logistical requirements. The below chart signifies the logged hours that have been devoted to the particular assignments by the Reserve and Auxiliary Officers.

Detective Bureau Monthly Report

INVESTIGATIVE SUMMARY:

Cases Closed by Detective Bureau

Suspicious Incident – A semi-conscious woman was found in a parking lot and there was a concern because of the suspicious circumstances. After a review of video surveillance and receiving lab results, it was determined that nothing criminal occurred.

DUI – A report was taken of a single vehicle crash where the driver was transported to Lee Memorial Hospital. There was evidence discovered that the driver had been drinking. After receipt the driver's medical records through subpoena, it was determined that he was operating his vehicle above the legal blood alcohol limit. A warrant request was sent for his arrest.

Aggravated Stalking – A report was filed that an inmate at the jail was violating court-imposed orders by contacting his ex-girlfriend. After receiving sworn testimony and evidence of the electronic communication, he was rearrested at the Naples Jail center for Aggravated Stalking.

Death Investigation – A death investigation from last year was deemed to be from natural causes as determined by the Medical Examiner.

Vandalism – A criminal mischief was reviewed, and interviews conducted. The investigation was suspended due to no further leads.

Lewd or Lascivious Battery – After an extensive investigation of a sex crime and a warrant request submitted, the State Attorney's Office refused to file charges.

Child Abuse – Investigation conducted, and findings submitted to the State Attorney's Office for review. Charges denied.







