#### **Events**

- On June 4<sup>th</sup> Police, Code, planning and environment staff, along with approximately 40 commercial landscapers and contractors, attended training on native animal protection and fertilizer usage.
- During the week of on June 4<sup>th</sup>, the 2019 Police & Fire Youth Academy trained on marine operations, including defensive tactics, internet and electronic device safety, tactical exercises and obstacle courses, first aid, smoke evaluation drills.
- A community Service Officer participated in Beach clean-up day sponsored by the Chamber of Commerce on June 8<sup>th</sup>.

- June 28<sup>th</sup>, the Department conducted Police and Community Service Officer testing and interviews

#### Detective Bureau Monthly Report June 2019

#### **INVESTIGATIONS:**

#### SIGNIFICANT CASE INFORMATION/INCIDENTS:

**Burglary Conveyance** 791 W Elkcam Cir – Suspect(s) entered the victim's unlocked vehicle and removed his credit card. It was reported that an individual used the victim's credit card at a Walmart in Naples, and the Collier County Sheriff's Office was notified. Ultimately, there was insufficient evidence to connect this individual to the Marco Island burglary, however the Sheriff's Office developed a strong case for fraudulent use of credit card. *Inactive* 

**Fraud** 730 S Collier Blvd – Unlicensed contractor promised a window replacement job and defrauded the victim \$44,000. *Investigation ongoing* 

**Burglary Conveyance** 133 S Collier Blvd – Unknown suspect(s) entered the victim's unlocked vehicle and stole her handicap placard. The placard was entered into FCIC as stolen. No witnesses and no cameras. *Inactive* 

**Sex Offender** 801 S Collier Blvd – MIPD discovered an out-of-state sex offender was in violation of the Marco Island City Ordinance. The sex offender was notified of the City Ordinance and voluntarily vacated the city. *Closed* 

**Written Threats** 400 block of N Collier Blvd – A juvenile received a threatening photograph of an individual pointing a gun at the camera. *Investigation ongoing* 

**Fleeing and Eluding/Narcotics** 1900 San Marco Rd – A suspect was speeding and began to flee when Officers attempted to conduct a traffic stop. After a brief chase, the suspect pulled over and surrendered. Through their investigation, Officers seized over 150 grams of marijuana, ecstasy pills, and drug paraphernalia. After he was arrested and transported to the jail, he was charged additionally with smuggling cocaine into a detention facility. *Cleared by arrest* 

**Sexual Battery** Collingswood Ave – A suspect arrested for domestic violence was placed into the Naples Jail Center and later reported she was sexually assaulted by her fiancé. The victim had an ICE hold on her and became uncooperative with investigators and would not establish her willingness to prosecute. *Open* 

**Fraud** 46 N Barfield Drive – Property Management Company embezzled approximately \$12,000.00 of rental income from victim. *Investigation ongoing* 

**Battery** 400 S Collier Blvd –Unknown person(s) attacked a man at the Marriott Hotel. An investigation was conducted with the Marriott Security Officers and a suspect was developed and arrested. *Cleared by arrest* 

**Aggravated Assault with a Weapon** 754 E Elkcam Cir – Customer created a disturbance at an auto collision center. While creating the disturbance, the customer unholstered what appeared to be a firearm and pointed it at the employee staff. An investigation began and a search warrant was granted for the suspect's residence. A BB gun that resembled a real firearm was confiscated. The suspect provided a full confession and was arrested. *Cleared by arrest* 

**Grand Theft** 1031 Anglers Cove – The victim reported he had house guest over. After one of the guests left, he noticed his prescription pills, jewelry, and his firearm were missing. *Investigation ongoing* 

**Traffic Arrests** – Approximately 9 traffic related arrest were made in June of 2019 that comprised of DUIs, suspended and unlicensed drivers.




#### Details –
